NARRATIVE

The following is summary of the facts, events, and circumstances surrounding the arrest of Brendan M. Reilly.

7/27/22, 12:06 PM Main Form

On the above date and time, while on Patrol in Sector 5, this Officer, Gallagher, was dispatched to rear of 869 Massachusetts Avenue, Arlington High School, to attempt to locate a trespassing student, Brendan Reilly. Mr. Reilly was given a no trespass order earlier in the day by the principal, Mr. Woodcock, because of a past assault on a student. Officer Hogan (351) was sent as backup, and shortly there after Officer Hogan reported Mr. Reilly was running from the rear of the high school. As this Officer pulled in the parking lot, Officer Hogan had caught up to Mr. Reilly by the tennis courts. As we attempted a threshold inquiry on Mr. Reilly, he was loud and uncooperative to the point a crowd had gathered. While we had him detained, the principal, Mr. Woodcock, also arrived at our location. Mr. Woodcock identified Mr. Reilly as the student who assaulted and who was given a no trespass order.

Due to the fact Mr. Reilly had disrupted school for the third time today, assaulted a student earlier, was ordered not to come to back the school, and was loud and uncooperative, he was placed under arrest. This Officer, handcuffed (double locked), searched, and placed Mr. Reilly in cruiser 355. Mr. Reilly was transported to the station in cruiser 355 with Officer Hogan following cruiser 351. There, he was booked by Sgt. Flaherty and fingerprinted.

This Officer was originally dispatched to Arlington High School at 1443 hrs, for an unruly student. It was discovered the student in question, Brendan Reilly had left prior to our arrival. The school principal, Mr. Woodcock, stated he had a student in his office who had been assaulted by Mr. Reilly. The victim of the assault was . Mr. stated he was walking down the hall of the high school when he noticed another student, Brendan Reilly, following close behind. When the victim reached the bottom of a set of stairs, he noticed Mr. Reilly was directly behind him. As turned around, Mr. Reilly punched him in the face. Mr. stated this assault was unprovoked, and he did not even know Mr. Reilly that well. He had no explanation for the assault, because no words 's mother was on sce<u>ne at the high</u> were ever exchanged. school, and stated she would bring her son to the hospital. received a laceration above his eye brow that appeared to require stitches. The family declined medical attention at the scene. This Officer explained a report would be placed on file about this incident.

This was the second assault committed by Mr. Reilly at the high school today. Sometime this morning, Mr. Reilly also hit an unidentified female in the back. This was the original reason Mr. Reilly was given a no trespass order from the principal. The principal stated he did not call the police on the original incident because Mr. Reilly was spoken to, and kicked out of school. The principal, Mr. Woodcock, also spoke with the parents of the female student, and they were going to make a decision on whether to file a

police report later.

Because Mr. Reilly was given a no trespass order by the principal for assaulting a female, re-entering the school later and assaulting again re-entering the school at 1533 hrs, attempting to elude Officer Hogan, and being loud and uncooperative during the threshold inquiry, Mr. Reilly was charged with Trespassing 266/120, Disorderly Conduct 272/53, Disturbing a School Assembly 272/40, and Assault and Battery 265/13A.

Once booking was completed by Sgt. Flaherty, this Officer advised Brendan Reilly of his Miranda Rights. Mr. Reilly was read the department's Miranda Right's sheet which he understood and signed, see attached. Once he was given his rights, Mr. Reilly was questioned. Mr. Reilly stated he did hit a female earlier. He only knew her only as Ally, and could not explain why he hit her. Mr. Reilly also stated he did not really know the male he assaulted either. He knew he was not allowed back at the school, but he was having a bad day, and decided to go back to the high school and pick a fight. His only explanation for assaulting was that he was having a bad day. Mr. Reilly had an injury to his right hand. He stated this injury was caused when he punched A photograph of Mr. Reilly's injured right hand is attached to this report. He declined medical attention at the station, and cleaned the wound himself.

After questioning Mr. Reilly on the events of today, he was also questioned as a suspect in a house break on the Concord Turnpike that took place on 01/30/2004. Officer Hogan and I were able to get verbal and written confession from Mr. Reilly on this break. See supplemental report filed by Officer Hogan, #04002005.

Mr. Reilly was placed in male cell #3 and allowed a series of phone calls.
