NARRATIVE

The following information is a summary of the facts which led to the arrest of 5 youth males and the summons of 2 female youths for minors in possession of alcohol.

On 04/30/2004 myself and SGT CONROY while assigned to PARK PATROL were conducting a park and walk with OFFICER BRYDGES at HILL'S HILL located behind the ARLINGTON RINK . While conducting the park patrol we found seven youths at the far end of the soccer field. When we approached these youths we observed 5 males and 2 females who were identified as BRENDAN REILLY, [REDACTED], [REDACTED], [REDACTED], [REDACTED], and [REDACTED]

[REDACTED] all sitting in a circle. Found next to these youths were 2 beer cans which were cold to the touch that had just been poured out with the liquids from the cans still visible. Also found were two unopened cans of beer. It should be noted that a large bottle of VODKA and a half full bottle of SPRITE were also located with these youths. The following youths had a very strong odor of an alcoholic beverage on them BRENDAN REILLY, [REDACTED], [REDACTED]

[REDACTED] Due to the fact that all of these youths were involved with this alcohol , and the fact all of these parties were under the age of 21. I informed these parties they were under arrest for violation of M.G.L CHAP 138/34c MINOR IN POSSESSION OF ALCOHOL. SGT CONROY informed OFFICER BRYDGES to drive [REDACTED]

[REDACTED] and [REDACTED] home to there parents. These two females were informed they were going to be summons to court for the above offenses. All of the above males were brought to the station. Upon arrival at the station all of the above males were booked, finger printed , photographed and given all of their rights by SGT CONROY . It should be noted that [REDACTED] and [REDACTED] both have suspended drivers licenses. During the booking process their drivers licenses were confiscated and all proper documentation was faxed to THE REGISTRY OF MOTOR VEHICLES.

I was informed by OFFICER BRYDGES that during the time she transported the two females she was informed by [REDACTED] that she was in fact drinking alcohol tonight with the above people. All of the alcohol was confiscated and placed into evidence locker #10 and the key was placed into the lock drop.
