### NARRATIVE

The following information is a summary of the facts which I observed on FRIDAY 01/30/2003 at approximately 1:45 PM. I was in the area of GLENBURN ROAD when I observed a person who was acting suspicious walking east on GLENBURN ROAD. I observed this male looking in a few yards and at the houses located on the south side of GLENBURN ROAD. This male kept looking at the houses and then back up the street over 15 times. The male then looked up the street, when I was able to get a good

look at his face and I then knew this person to be BRENDAN REILLY who lives on GLENBURN ROAD, REILLY is known to me because I was involved in an investigation with INSPECTOR SEAN KIERNAN in which REILLY gave written statements admitting to breaking into a few residences in ARLINGTON. I then observed REILLY walk east on GLENBURN and go right onto HILLCREST STREET which is a dead end street. I then went to this location and observed REILLY standing at the end of the street looking up towards a few houses on CONCORD TURNPIKE. REILLY stood for two minutes and continued to look over his shoulder and back towards the houses. REILLY was wearing a green jacket, a gray hooded sweatshirt, and baggie pants. It should be noted that this is the exact same clothing description given by the witness of the B&E which occurred at 871 CONCORD TURNPIKE. The house which had been broken into was approximately two houses up from the location REILLY was looking at. REILLY then left HILLCREST STREET and returned to GLENBURN ROAD and walked west until he took a left turn into his own vard located at 79 GLENBURN ROAD. I spoke with the home owner of

who stated that REILLY has been in her home before and knows the entire lay out of the house. REILLY was friends with the home owners son and stated that REILLY knows her hours of work. It should be noted that REILLYS home and the home that was broken into are accessible through each others back yards.

### NARRATIVE

The following information is a summary of the facts related to a B&E which occurred on 01/30/2003.

On 02/12/2003 this reporting officer reponded to ARLINGTON HIGH SCHOOL to assist OFFICER GALLAGHER for a disturbance involving a student. While on scene this reporting officer assisted OFFICER GALLAGHER with the arrest of BRENDAN REILLY (SEE OFFICER

## GALLAGHERS ARREST REPORT # 04002735).

Upon arrival at the station REILLY was booked, finger printed, photographed and given all of his rights by SGT FLAHERTY. It should be noted that REILLY is known to me from two past incidents involving house breaks. REILLY who is a suspect in a B&E on CONCORD TURNPIKE which took place on 01/30/2003 (SEE SUPPLEMENTAL REPORT 4002005) and REILLY had also given a signed confession involving four B&E'S last month. REILLY was given a departments MIRANDA RIGHTS SHEET which was read to him by OFFICER GALLAGHER. Myself and OFFICER GALLAGHER then asked REILLY about the house break which took place on CONCORD TURNPIKE. After speaking with REILLY he admitted to breaking into this house and taking money which was in a pocket book that was at this location. The money which was taken was approximately \$300.00 and was reported by the homeowner (SEE INCIDENT REPORT filed by OFFICER POWERS). REILLY was then given a piece of paper which he then wrote a summary of the incident in which he broke into the house and stole this money. REILLY made statements to which only the suspect would have known about this crime. REILLY also stated that he knew the ARLINGTON POLICE were looking for his green jacket because his father had spoken to INSPECTOR FITZPATRICK regarding witness statements which placed REILLY in the area during the house break. REILLY stated that after being questioned by his father he hid the jacket and then placed it in the trash right before it was collected.

Due to the fact there have been other house breaks in ARLINGTON which are still under investigation in which suspect footprint photo's and plaster molds were taken , REILLY'S sneakers were confiscated as evidence and placed into evidence locker #10. I informed INSPECTOR FITZPATRICK of the above incident and he stated he would follow up on this report when he returns to work. Due to REILLY'S above statements , along with his written confession I am requesting criminal complaints for violation of M.G.L CHAP 266 / 18 B&E DAYTIME FELONY and M.G.L CHAP 266/30 LARCENY OVER \$250.00.

Gallagher and Off. Hogan advised Reilly of his Miranda Rights and also read the departments Miranda Rights sheet to Reilly which he understood and signed. The Officers were able to obtain a verbal and written confession from Reilly. Off. Hogan has requested criminal complaints against Reilly for: 1. B&E Daytime/Felony Ch. 266/18. 2. Larceny Over \$250.00 Ch. 266/30.
