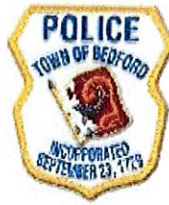

On 04-07-2010 at approximately 10:50 PM I (Off. Martin) was flagged down by a motorist in the station parking lot. I met with Carol Reilly who wanted me to do a well being check on her son Brendan. Carol related that Brendan suffers from mental disorders and has been difficult the past few days. Carol related that Brendan has said hurtful things to her and her husband and wants me to speak to him. Carol related that she would like Brendan to spend the night elsewhere if possible.

I met with Brendan who was waiting outside his mothers vehicle. Brendan appeared extremely calm and spoke slowly. I asked Brendan how he was feeling and he related he felt fine. Brendan related that he just wanted to go home and eat something before going to bed. I asked Brendan if he had any friends he could spend the night with tonight and he related he does not. I asked Brendan if he has money for a hotel room and he related he has no money. Brendan related he just wanted to go home. During my conversation with Brendan he was very calm and easy to speak to.

I again spoke with Carol and informed her that Brendan appeared calm and he just wanted to go home. Carol related that Brendan could go home with her only if he agrees to be respectful and not cause any arguments at home. I returned to speak with Brendan and asked if he is willing to go home and go to bed. Brendan related he would like to spend the night at a hotel. Brendan related he has no money and his mother would need to pay for the room. I informed Brendan that his mother does not have the money to rent him a room and asked if he would be willing to go home for the night. Brendan related he would be willing to go home.

Prior to leaving I informed Carol to contact the station if an argument takes place or she feels threatened. Carol related she would. I also informed Brendan that he should not start any arguments and I told his mother to contact the station if he acts up. Brendan related he just wanted to eat something before going to bed.

No further police action.

After reviewing previous incidents while on my days off, I observed that Mrs. Reilly of 17 Reeves had come to the station seeking a well being check on her son, Brendan. I know the family history with the Reilly's as Mr. Reilly had come to the station in February seeking assistance and advice. See incident # 2010-1284.

The information that I am aware of is that Brendan is a violent mentally altered 23 year old. He has resided out of the house for some time and is home now. In speaking with Mr. Reilly in February he appeared nervous,

aggravated, frustrated and "at witts end" with the situation with his son. Mr. Reilly had been arrested previously in 2008 for a domestic with his son which is one of many that he and his wife deal with. Mr. Reilly made statements that he felt they were ok for this period of time, but he needs to figure out what to do. In observing that Mrs. Reilly came to the station I advised Sgt. Towle of my concerns and it was decided a follow up would be done with the Reilly's. I left a message on the home number on 4/10/10 at approximately 10:00 am. I will attempt to go by the home during my shift as well.

Brendan is a known drug user and has been suspected in multiple B&E's within Arlington. Brendan is also under Psychiatric care and can be extremely violent.
