NARRATIVE

On this date, at approximately 2315 hours, while assigned to sector 3, myself and traffic Off Paradis were in the rear of the High School when we

were approached by 2 girls [REDACTED] and [REDACTED]. Both girls stated that a 25 year old man who was wearing a red hoodie sweatshirt was threatening/scaring the group of high school kids over at the basketball court. They stated that they had observed the male "snort" an unknown substance at Buzzell Field. The male then followed them from Buzzell over to the high school which concerned them. The girls were asked to wait at the gate until we investigated further.

The male, later identified as Brendan Reilly was located at the basketball courts with a small group of high school kids. When he was approached Reilly immediately jammed his hands into his sweatshirt pocket. He was told by Off Paradis to remove his hands from his pockets to which he yelled at Off Paradis to "Fuck off". He was again told to remove his hands from his pockets and again refused. When Off Paradis grabbed his arm to remove his hand from his pocket Reilly began to twist in an attempt to break Off Paradis's grip. Reilly refused to remove his hands from his pockets and struggled against our efforts to remove his hands all the time yelling at us to "fuck off". Reilly's hands were removed from his pockets and he was handcuffed and placed into the rear of 353.

Reilly's eyes were bloodshot and glassy. Reilly had the odor of an alcoholic beverage on his breath when he spoke. He stated that "I only had 8 beers so why am I in protective custody, that's bullshit".

Reilly was transported in 353 to the station, where he was processed by Lt Kiernan and placed into male cell #3.
