Serial# Stored ON WEDNESDAY 2/1/12 AT APPROXIMATELY 8:01AM I WAS DISPATCHED TO 35 REED ST TO RETRIEVE PILLS THAT HAD BEEN FOUND ON THE PORCH. THESE ITEMS MAY HAVE BEEN CONNECTED WITH A CALL THE NIGHT BEFORE (1/31/12 AT APPROXIMATELY 9:47PM) FROM THE SAME ADDRESS ABOUT A SUSPICIOUS MALE, SEE CASE NUMBER 323049. UPON ARRIVAL I SPOKE WITH THE HOMEOWNER

STATED THAT POLICE HAD BEEN TO HIS HOME THE OTHER NIGHT BECAUSE OF A SUSPICIOUS MALE WHO CAME TO HIS DOOR AND ASKED TO SEE JOE. THIS WHITE MALE WAS APPROXIMATELY 6FT TALL, WEARING A GREY SWEATSHIRT. HE APPEARED TO BE BARELY COHERENT AND WAS REPEATING EVERYTHING HE SAID. THIS INDIVIDUAL ALSO APPEARED TO LOOK IN THE WINDOWS OF THE VEHICLES PARKED IN THE DRIVEWAY. THOUGHT THIS WAS SUSPICIOUS, ALSO THEIR DOG BEGAN TO BARK AND BECAME VERY UPSET. AFTER CHECKING OUT THE VEHICLES THIS INDIVIDUAL RAN UP REED ST HEADING TOWARDS BEDFORD. DID NOT NOTICE UNTIL THE MORNING THAT THERE WERE THREE WHITE PILLS ON HIS PORCH. THE PORCH IS ON THE SIDE OF THE HOME BY THE ENTRANCE WHERE VOSS SPOKE WITH THE INDIVIDUAL FROM THE NIGHT BEFORE. I CHECKED THE AREA WITH AND WE LOCATED A PAIR OF DIRTY AND TORN GREY SWEATPANTS. THESE PANTS WERE LOCATED IN A SMALL WOODEN STORAGE SHED, WHICH IS RIGHT BY THE PORCH. THIS SMALL SHED IS BEHIND A FENCE IN THE YARD WITH A SMALL GATE. DID NOT RECOGNIZE THE PANTS AND IS CERTAIN THAT THEY DO NOT BELONG TO HIM OR ANYONE HE KNOWS. THIS SHED USUALLY HAS THE DOOR SHUT, BUT IT DOES OPEN UP ON ITS OWN SOMETIMES. COULD NOT BE CERTAIN IF IT WAS CLOSED OR NOT. DID NOT OBSERVE ANYTHING MISSING FROM THE SHED. THE LAST TIME HE WENT INTO IT WAS ON SUNDAY 1/29/12.

THE SUSPICIOUS MALE THAT CAME TO HIS DOOR IS BELIEVED TO BE BRENDAN REILLY. REILLY WAS ARRESTED BY BEDFORD PD ON THE MORNING OF 2/1/12 FOR A B&E TO A RESIDENCE. THIS INDIVIDUAL MATCHES THE DESCRIPTION GIVEN BY VOSS. THE PILLS AND SWEATPANTS ARE ALSO BELIEVED TO BE HIS.

I CONDUCTED AN INTERNET SEARCH AND IDENTIFIED THE PILLS ARE BEING GABAPENTIN. THESE PILLS ARE USED TO TREAT ANXIETY. THEY WERE NOT LOCATED IN ANY SORT OF CONTAINER AND WERE PLACED RIGHT NEXT TO ONE ANOTHER ON THE PORCH FLOOR UNDER THE RAILING. THE PILLS WERE NEXT TO SOME MATCHES.

THE PILLS WERE BROUGHT TO THE STATION ALONG WITH THE SWEATPANTS AND PLACED IN AN EVIDENCE BAG. THEY ARE BEING HELD PENDING FUTHER INVESTIGATION.

AT 1230 HRS BEDFORD POLICE DEPARTMENT CONTACTED ME AND STATED THAT THE GABAPENTIN THAT WAS FOUND AT #35 REED STREET WAS A MEDICATION THAT BRENDAN REILLY HAD BEEN PRESCRIBED.

ON MONDAY 01/07/08 WHILE CONDUCTING LIDAR VEHICLE SPEED CONTROL ON GROVE STREET, A PUBLIC WAY IN THE TOWN OF LEXINGTON, MASSACHUSETTS, I OBSERVED A BLACK NISSAN SUV TYPE VEHICLE TRAVELLING SOUTH BOUND AT A HIGH RATE OF SPEED. THIS VEHICLE WAS VISUALLY ESTIMATED TO BE TRAVELLING BETWEEN 43-48 MPH PRIOR TO LIDAR LOCK-ON OF 46 MPH AT 133 FEET. AREA IS A THICKLY SETTLED RESIDENTIAL ROAD AND IS CLEARLY POSTED 30 MPH IN BOTH DIRECTIONS. AS THIS VEHICLE PASSED MY LOCATION I IMMEDIATELY PULLED OUT BEHIND SAME AND ACTIVATED MY CRUISER'S OVER-HEAD LIGHTS, CAUSING THE OPERATOR OF THIS VEHICLE TO PULL OVER AND STOP IN THE AREA OF 38 ELDRED STREET. VEHICLE REGISTRATION WAS MA/PAN 12JT43.

UPON APPROACHING THIS OPERATOR I ASKED FOR HIS LICENSE AND VEHICLE REGISTRATION. OPERATOR TOLD ME THAT HE DID NOT HAVE HIS LICENSE ON HIM. I ASKED THIS OPERATOR IF HE ACTUALLY DID HAVE A LICENSE LISTED TO HIM, AT WHICH TIME HE TOLD ME NO, THAT HE HAD A LEARNERS PERMIT ONCE BUT THAT IT EXPIRED APPROXIMATELY ONE (1) YEAR AGO. IN OBTAINING THIS OPERATOR'S INFORMATION I WAS TOLD THAT HIS NAME WAS BRENDAN M. REILLY, FROM 17 REEVES ROAD BEDFORD, MASSACHUSETTS. A REQUEST FOR DISPATCH TO CONDUCT A LICENSE CHECK AS WELL AS AN NCIC/WANTED, AND BOARD OF PROBATION CHECK WAS MADE. LEXINGTON DISPATCH INFORMED ME THAT REILLY DID NOT HAVE A DRIVERS LICENSE AND THAT HE HAD BEEN CHARGED FOR DRUG POSSESSION (C,D), AND BREAKING AND ENTERING IN THE PAST.

OFFICER AIDEN EVELYN, SGT. JOHN MAZERALL, ARRIVED AS BACK-UP AND REILLY WAS PLACED INTO CUSTODY FOR OPERATING A MOTOR VEHICLE ON A PUBLIC WAY WITHOUT A DRIVERS LICENSE (C90-10). HE WAS ALSO CITED FOR SPEEDING, 46 MPH IN A POSTED 30 MPH ZONE (C90-17). CITATION NUMBER: M5639974 WAS ISSUED.

HE WAS HANDCUFFED (DOUBLE-LOCK), SEARCHED AND PLACED IN CRUISER 413. TRANSPORTED BY ME (TUOMI) WITH SGT. MAZERALL ESCORTING IN CRUISER 416, TO THE LEXINGTON POLICE STATION. BOOKED BY OFFICER KRISTIN FRENCH, OF THE LEXINGTON POLICE STATION. SHORTLY AFTER COMPLETION OF BOOKING PROCESS, REILLY WAS TRANSPORTED TO THE CONCORD DISTRICT COURT IN CRUISER 413, BY OFFICERS PAUL JENKINS, AND MYSELF (TUOMI).
