On 12-27-2012 at approximately 11:12 PM I (Off. Martin) in Car 3, Car 11 Off. Abajian and Car 4 were sent to 17 Reeves Rd. for a report of a verbal argument between a father and son. Upon arrival I met with the caller Brendan Reilly who was on the back deck smoking a cigarette. Brendan related that he and his father [REDACTED] had an argument over his medications.

Brendan related that his father and mother have his prescription bottles and he wanted to have them. Brendan related that he had taken his prescribed doses for this evening but would like to have possession of the bottles. I informed Brendan that I would speak to his parent's about the issue. I also informed Brendan that it was late and he should wait until tomorrow morning to discuss this with his father. Brendan related that he understood. Sgt. Cloutier arrived on scene.

Sgt. Cloutier and I had Brendan get his parent's so we could speak to them. Brendan's father [REDACTED] came downstairs and I spoke with him. [REDACTED] related that he left all of Brendan's medication on the vanity in the bathroom and he has not taken his medication for tonight. [REDACTED] related that he always gives Brendan his medication but tonight he is getting angry about it because he is not getting his way. I informed [REDACTED] that I would speak with Brendan and have him take his medication. After speaking with [REDACTED] spoke to Brendan again.

I asked Brendan if he could take his medication for tonight. Brendan related that he would. I then informed Brendan that I spoke with his father and the two of them can discuss his medication tomorrow due to the time of night. Brendan related that was fine and went upstairs to his room.

Prior to leaving [REDACTED] related that Brendan suffers from mental health issues and he and his wife have been trying to get him some help in dealing with these issues. We informed [REDACTED] that if we can assist him at all then to call us. [REDACTED] related that they would. I went upstairs to Brendan's room and asked him if he could call it a night. Brendan related that he was going to go to bed.

No further police action necessary.
