NARRATIVE

The following is a summary of the facts and circumstances related to the arrest of [REDACTED] for the following charges:

C. 276 s. 20A - Fugitive from Justice on Court Default Warrant - Docket #1310CR000949 - Somerville District Court.

On 07/07/2013 at approximately 17:57 hours while patrolling assigned Sector 2 in car 354, this Officer (Chella) along with Sector 1 (Officer Urquhart) were dispatched to the area of the Bike Path overpass at the end of Whitemore Street for a loud group of youths.

Upon arrival I saw 3 male parties, Brendan Riley (06/18/86), [REDACTED] ([REDACTED] 96), and [REDACTED] ([REDACTED] 94) sitting on the dirt hill connecting the Bike Path. At this time, from my training and experience, I observed a strong odor of Marijuana coming from the 3 males.

At this time Officer Urquhart arrived on scene. I then advised all 3 parties of the obvious odor of Marijuana and asked them if they had anything in their pockets. All 3 parties then willingly emptied their pockets completely. I then observed [REDACTED] to have a small plastic sandwich bag. Upon further investigation I observed the bag to contain a green leafy substance I immediately recognized as marijuana, (2) self made marijuana smoking pipes made out of foil, and a small match box which also contained marijuana. [REDACTED] was advised that he would be mailed a citation for the found marijuana (Please refer to DR# 13016902).

At this time I ran all parties involved for WMS. Dispatch then transmitted back the results stating that [REDACTED] had an Active Warrant out of Somerville, MA. All other parties involved were found Negative WMS.

At this time I advised [REDACTED] that he would be placed under arrest for the warrant. I then placed handcuffs on [REDACTED] (Double Locked), searched him, and placed him in Cruiser #351. Officer Urquhart then transported [REDACTED] back to the station followed by myself in cruiser 354. At the station [REDACTED] was Booked by Lt. Kelly, afforded all applicable rights, and fingerprinted by this Officer. [REDACTED] was then placed in male cell # 5.

BOP check on [REDACTED] showed Minor in Possession, Assault w/Dangerous Weapon, Malicious Destruction of Property, and Shop Lifting.
