NARRATIVE

On Monday, 7/22/13, at approximately 1649 hours, this Officer (Milner), while assigned to Sector 2, in car 369, responded to 324 Mass Ave, The Walgreens, to investigate a possible shoplifter. Sector 3, Officer Fennelly, and Sector 4, Officer Mahoney also responded to the scene. Arlington Dispatch relayed information that the suspect was a white male, approximately 6 feet tall, wearing gray shorts, a hat, and had a bandana on his head. Arlington Dispatch advised responding Officers the suspect was walking W/B on Mass Ave. and was near the Global Gas Station.

Upon arrival I observed a white male matching the description given by dispatch walking W/B on Mass Ave, directly in front of the Global Gas Station. I immediately recognized the party to be Brendan Reilly. I stopped Reilly and asked him where he was coming from. Reilly stated he just left the Walgreens. I asked Reilly if he had purchased any items, and he stated he did not. Reilly stated he did not have any money, and was going to take some batteries for his portable CD player, but then he changed his mind. Reilly explained he knew the Manager, [REDACTED], was on to him, and he decided not to go through with the act of shoplifting. I asked Reilly if he had any batteries in his Walkman now, and he stated he did. I asked him where he got those batteries from, and he stated he had them from earlier. I then challenged Reilly on this, and he again denied taking anything from the store.

At this time I spoke with [REDACTED]. [REDACTED] presented me with an empty package that would have contained 4 AA Duracell Batteries. [REDACTED] stated he had video surveillance of Reilly taking the batteries out of the case, and then leaving the store.

I then asked Reilly if I could see his CD player, and he said I could. I asked him what kind of batteries he had in the CD player, and he stated he did not know. I then opened the battery portion of the CD player, and there were two AA Duracell Batteries inside of the CD player.

I then confronted Reilly about our discovery, and explained to him there was video surveillance of him taking the batteries. I then gave Reilly his options, and he confessed to taking the batteries.

Reilly was issued a No Trespass Order from Walgreens, which he signed, and stated he understood. Officers on scene observed Reilly sign the No Trespass Order. I explained to Reilly he was going to get summons to court for the shoplifting, and he stated he understood.

Reilly was checked for WMS with negative results.

Reilly has 12 entries on his BOP (Attached).

██████████ handed me a printed receipt for \$6.90 for the batteries. The batteries and receipt was tagged and placed into evidence locker # 9.

Due to the fact Brendan Reilly intentionally took possession of two AA Duracell batteries, which he concealed on his person, I will be seeking a Criminal Complaint for Shoplifting, 266/30A.
