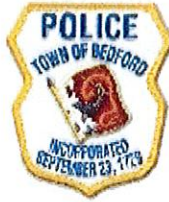

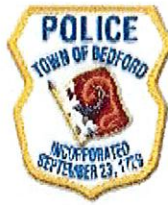

On 08-20-13 at approximately 1:30PM, I (Officer Maloney) in marked cruiser number 5, (Officer Cook) in marked cruiser number 8 were dispatched to [REDACTED], for a report of a domestic disturbance.

Upon arrival I met with the caller [REDACTED] (Dob [REDACTED]-60). [REDACTED] related he arrived home to find his son Brendan Reilly (Dob6-18-86) bashing in his bedroom door. [REDACTED] related Brendan was smashing the door because he forgot to leave him his \$20.00 allowance for the day. [REDACTED] related Brendan, who suffers from mental issues has been off his meds for the past 3 days.

[REDACTED] related Brendan started yelling at him and ran out of the house towards the woods which leads to Lexington. [REDACTED] related Brendan is only like this when he is off his meds.

Officer Cook and I checked the area and were unable to locate Brendan.

I asked [REDACTED] if there was any physical contact made between anyone during the verbal altercation and he related none at all. [REDACTED] was advised of his 209A rights.
