On Monday, November 25, 2013 at approximately 14:42 hours I was dispatched to the area of 833 Massachusetts Ave., the location of the CVS Pharmacy to investigate a white male attempting to sell drugs to high school kids. Sectors 4 & 6, Officer A. Stotik was also dispatched.

The Suspect party was described as a white male wearing a black Red Sox hat, a dark jacket and blue military jean pants walking eastbound on Massachusetts Ave away from the CVS. Officer Stotik informed me over the radio that he observed a white male fitting that description behind the CVS lot a few minutes earlier. I conducted a search of that area with negative results. Officer A. Stotik made contact with a white male party fitting the dispatched description in front of the Robbin's Library, located at 700 Massachusetts Ave.

I immediately responded to the scene. The suspect party was identified as, Brendan Reilly (06/18/86), Reilly admitted to just recently being inside CVS. I pat frisked Reilly for his and Officers safety with negative results for weapons. I asked Reilly if he made any contact with High School kids in an attempt to sell drugs, Reilly answered in the negative several times.

At this point dispatch was notified and conducted a CJIS/ WMS check on Reilly with negative results. While on scene I was also advised by dispatch that one of the High School students in front of CVS, identified as, [REDACTED] ([REDACTED]/97) was the victim of an indecent exposure and he identified Reilly as the suspect. Reilly was hand cuffed and detained in cruiser #353 until an Officer could speak to the victim.

Officer J. Dunn, Sector 2 was dispatched to CVS and obtained the following statements from the Victim and three witnesses.

- Victim, [REDACTED] ([REDACTED]/97), Arlington High School student, identified the suspect as Brendan Reilly including a matching description. [REDACTED] stated that Reilly lifted up his shirt, unbuckled his belt, dropped his pants below his knees, bent over and exposed his buttocks along with his scrotum. [REDACTED] was in direct view of the exposure from behind and believes that he was targeted. [REDACTED] was offended and shocked by the

act of vulgarity.

- Witness, [REDACTED] ([REDACTED] 97), Arlington High School student, stated a man pulled his pants down exposing his buttocks. The suspect male is known to him as "sketchy B."

- Witness, [REDACTED] ([REDACTED] 95), witnessed the suspect male pull up his jacket and drop his pants, the witness observed the suspects buttocks only.

- Witness, [REDACTED] ([REDACTED] 97), Arlington High School student, stated the suspect follows kids around and asks for pills. [REDACTED] observed the suspect drop his pants and he observed the suspects buttocks only, the suspect then fled east bound on Mass Ave.

While secured in cruiser #353 Reilly was informed that he was being placed under arrest and advised of the charges lewdness, open and gross MGL C. 272 / S. 16. Reilly was transported to the Arlington Police Station where he was booked by LT. D. Kelly fingerprinted by Officer A. Stotik and afforded all his rights as an arrested person without incident. Reilly was secured in male cell #3. Please see all attached applicable paperwork to this report.
