NARRATIVE FOR OFFICER SEAN M COLLINS

Ref: 14-103-OF

On Saturday August 2, 2014 at approximately 8:35 AM, I was dispatched to 219 Taylor Road to assist the Advocate facility with a resident who had taken 2 pills not prescribed to him. I arrived at the main office with Officer Goguen and we met with Director [REDACTED]. Mr. [REDACTED] stated resident, Brendan RILEY, is admitted to the Advocate facility and at around 3:00 AM, he had taken two "Klonopin" pills which were prescribed to another resident named [REDACTED]. Mr. [REDACTED] was not working when the incident happened but he stated another director named, [REDACTED], reported he was in the main office distributing medicine to patients when Brendan RILEY misidentified himself in an attempt to get medicine not prescribed to him. Mr. [REDACTED] further stated RILEY grabbed the 2 Klonopin pills as Mr. [REDACTED] turned his attention away from him. Officer Goguen requested Mr. [REDACTED] wake up RILEY who was sleeping in his locked room. After waking him up, I asked RILEY why he took the pills. He answered "I became paranoid, took the pills, but I flushed them down the toilet". I asked him why he flushed them down the toilet instead of returning them? RILEY did not respond to the question leading us to believe he may have ingested them. Mr. [REDACTED] stated he thought RILEY "snorted" the pills. I advised him to contact his supervisors to have them investigate further and I will review the incident with Prosecutor Gary Murphy to discuss charges being sought against RILEY.
