

of the cup were empty, but that there was a hot pot of coffee in the kitchen.
At this time Stow Fire Department arrived on scene and evaluated. Lt. Guerin of the Stow Fire Department reported that he observed a change to skin tone, approximately 2" inches in diameter above right eye, which is constant with first degree burns. did refuse medical treatment stating that he can not leave the house as he is responsible for the other tenants that are there.
I then returned to my cruiser, and I informed REILLY of his Miranda Rights, which I read to him in front of Officer Kusz. REILLY stated that he did not throw the coffee at him only next to him. I informed REILLY that he was under arrest for Assault and Battery Dangerous Weapon, which REILLY stated that I was over charging him.
I then transported REILLY to the Stow Police Station. Upon arrival REILLY requested to use the phone, which he made two phone calls and was able to make contact with his father. REILLY was then booked as per department procedure and policy.
REILLY was then transported to Concord Court.
