Stow Police Department NARRATIVE FOR PATROLMAN CHRISTOPHER A KUSZ

Ref: 16-30-AR

At approximately 515PM on Saturday March 26, 2016 I, Officer Kusz was working the 3-11 full uniform patrol shift for the Town of Stow assigned to marked cruiser #3. Det. Sgt. Sallese was also working this shift. At this time Det. Sgt. Sallese and I were monitoring the behavior of Brendan Reilly (info on file) who was walking east on Great Rd. towards the Stow Shopping plaza. Approximately 30 Minutes prior to this time Det. Sgt. Sallese and I responded to the area of 558 Great Rd. and spoke with Mr. Reilly who was walking east on Great Rd. Mr. Reilly had asked a resident at this address for a ride, after the resident denied Mr. Reilly a ride the resident explained that Mr. Reilly picked up an empty liquor bottle and continued to walk east on Great Rd. While speaking with Det. Sgt. Sallese Mr. Reilly explained that he was either walking to the Stow shopping plaza or to Maynard and that he had not made up his mind yet. It was at this time that Det. Sgt. Sallese and I cleared the area and proceeded to watch Mr. Reilly walk east on Great Rd.

Det. Sgt. Sallese parked his cruiser in the Stow shopping plaza parking lot in order to watch Mr. Reilly and I continued to patrol the parking lot. Det. Sgt. Sallese watched Mr. Reilly enter the Shaw's at the Stow Shopping plaza and requested that I park my cruiser in order for both of us to watch Mr. Reilly in the Shaw's. Mr. Reilly is well known to the Stow Police Department and on several occasions has either attempted or committed crimes in this area. Det. Sgt. Sallese and I entered the Shaw's and proceeded to watch Mr. Reilly walk around the store. Det. Sgt. Sallese could see Mr. Reilly open a freezer door and take what appeared to be popsicles. Mr. Reilly then proceeded to walk up and down aisles and proceeded to the exit of the store from the entrance doors in a hurry without paying for any items. At this time I exited the store in order to attempt to encounter Mr. Reilly. I was walking outside of the store past the bottle/can recycling center (which is approximately 15 feet away from the main Shaw's entrance) when I noticed Mr. Reilly standing facing the wall in the corner of the bottle/can recycling center furiously stuff something into his mouth. I then asked Mr. Reilly to turn around and asked him to take his hands out of his pockets. While taking his hands out of the front pocket of his hooded sweatshirt I could see several boxes of pills sticking out of the pocket. I then asked Mr. Reilly to remove what he had in his pocket. Mr. Reilly then removed a box of Benadryl. I asked where Mr. Reilly had got this to which he replied "Shaw's". I then asked if he had paid for this to which he replied "no". I then proceeded to place Mr. Reilly under arrest for shoplifting. Mr. Reilly was read his rights per Miranda. I then searched Mr. Reilly via search incident to arrest and found one other full box of Benadryl in his front pocket as well as a package of unopened batteries. I then opened the top of the trash next to Mr. Reilly which contained three empty boxes/bottles of Benadryl. I asked Mr. Reilly where the pills were and he explained that he had taken a few bottles of the pills. At this time I requested rescue 16 to my location in order to evaluate Mr. Reilly due to the amount of pills he claimed to have consumed. I also found a large amount of pills in Mr. Reilly's pockets that had not yet been consumed. It should be noted that each box of Benadryl costs approximately 5.00 dollars, the batteries are priced at approximately 5.99 dollars.

Mr. Reilly was subsequently transported to Emerson Hospital where he was evaluated and released into police custody. I transported Mr. Reilly from Emerson Hospital to the Stow Police Department with mileage recorded. Mr. Reilly was booked per departmental policy and used the phone to call his mother. Mr. Reilly was placed in cell #1. The evidence collected from the scene was processed and placed in evidence locker #1. Matt Day was contacted for bail and released Mr. Reilly on personal recognizance. It should also be noted that Mr. Reilly overdosed by taking 40—50 Benadryl on November 30, 2015 While at his residence of 219 Taylor rd.
