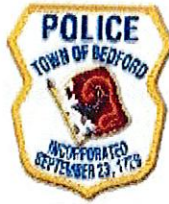

On August 6, 2020 at approximately 04:06 hours I (Officer Waite/Car9) was dispatched with Sergeant Naylor and Officer Reid to 17 Reeves Road for a report that a man with a rifle was seen in the back yard over an hour prior. The reporting party, Brendan Reilly (DOB: 06/18/1986) believed he was the target of a professional hit. He related he was standing in the kitchen when he saw a man wearing a mask carrying a rifle walk through his back yard.

We checked the yard and surrounding area and found no signs of anyone being present.

Brendan is currently seeking psychiatric care through the Eliot Center.

We spoke to Brendan's father, [REDACTED] (DOB: [REDACTED] 1960), who confirmed there was a mental health component to this incident. He felt comfortable with Brendan tonight.

Brendan related he would speak to the Eliot Center tomorrow about this incident. [REDACTED] agreed.
