NARRATIVE

On Friday, January 1, 2021, at approximately 11:48 AM, Officer John Frissore, Officer Chris Coleman and I, Officer Christopher Ducharme, responded to 98 Hancock Street, for a report of a male subject having hallucinations and a manic episode. The reporting party stated to Lexington Police Dispatch, the male subject was attempting to barricade himself.

On arrival, I spoke with the reporting party, [REDACTED] [REDACTED] is an Intensive Case Manager for the Elliot Community Human Services, who oversees the residents who reside at 98 Hancock Street. [REDACTED] stated, one of his clients, Brendan Reilly, was in a state of mania and was having hallucinations. Reilly is known, from previous Lexington Police calls for service, where officers have responded to incidents involving Reilly's mental health. On Monday, December 28, 2020, I responded to 98 Hancock Street, where I assisted Lexington Police officers in locating Reilly, where a Section 12 was subsequently issued by Advocates for an evaluation of Reilly.

[REDACTED] stated, prior to our arrival, Reilly was making statements stating, "I'm not crazy" and "If you call the police you will be sorry." [REDACTED] stated, Reilly was placing screws in his door in attempt to "barricade" himself. Officers observed Reilly's door and announced our presence. Reilly's door was unlocked, as I was able to open the door and observed Reilly laying on his bed. Reilly was making statements indicative of someone who was having hallucinations. Reilly stated, "Jesus Christ himself just came in my room and told me I have an ugly nose" and "Do I have an ugly nose officer." I observed Reilly for several minutes as he incoherently talked to himself. I reported my observations to [REDACTED] who prior to officers arrival, had been in contact with Advocates. A Section 12 committal was subsequently issued by Advocates, and hand delivered to Lexington Fire personnel.

Officers advised Reilly of the Section 12, who was apprehensive, but willingly walked down the stairs with officers without incident. On approach of Lexington Fire personnel, Reilly stopped at the front door, clenched both of his fists, bladed his stance and stated, "I'm not fucking going." I advised other officers of my observations, and moved toward Reilly to place him in the escort position. Reilly fled from officers by jumping over the railing and into a set of bushes, where he fled from officers on Hancock Street.

Officers pursued Reilly and gave verbal commands for him to stop. Reilly ignored these commands as he fled on Hancock Street. I observed Reilly flee onto Victory Garden Way, and located him standing in front of an open garage on 9 Victory Garden Way. I exited my cruiser, and shouted verbal commands for Reilly to stop. Reilly ignored my verbal commands and fled to the rear of the house. I pursued Reilly, where I located him in the rear of 15 Victory Garden Way. I observed

Reilly, who was approximately 15 feet away from me, take a bladed stance, clench both of his fists and state, "I'm not fucking going anywhere, I won't be easy." Based on my observations and experience as a police officer, I believed Reilly was going to assault me. I drew my department issued "Monadnock" baton, I shouted three (3) times the verbal command "Get on the ground." Reilly complied with my commands, and laid on his stomach and placed his hands behind his back. Officer Frissore arrived on scene and assisted in handcuffing Reilly for his safety and ours.

Officers immediately examined Reilly for injuries, where we observed numerous scratches on his arms as a result of running through the bushes at 98 Hancock Street. While examining Reilly, he looked at Officer Frissore and stated, "Tell me I am a good son, and that you love me." Officers observed Reilly was still in altered mental state. I escorted Lexington Fire who subsequently transported Reilly to Lahey Hospital. A copy of the Section 12 committal is attached to this report.
