NARRATIVE

*****Witness Statement Kristina Cunningham

On Tuesday February 17, 2022 at 1:28PM, I spoke with Kristina Cunningham regarding the incident that occurred on Saturday February 12, 2022. Cunningham made herself known at the scene that she had witnessed some of what took place at the Hancock St rotary.

The following is a synopsis of the statements made by Kristina Cunningham when I spoke with her.

I was out for a walk with my mother and father that day, we walked from my house on Dexter Rd to North Hancock to the Hancock traffic circle. As I approached the traffic circle I heard yelling. I observed an individual at the end of a driveway in baggy clothing, I then saw 2 heads above a fence in the same driveway the man was standing at the end of, these 2 men were in a verbal argument and the individual standing at the end of the driveway was watching the argument. I was unsure who was arguing, and my dad and I crossed the street and when we got to the other side I called for my mom to cross. As my mom started to cross I saw an officer come in front of the house, and he came from the left side of the house and he didn't have any weapons out.

I then saw an individual in baggy clothing kaki or light brown colored pants and a loose jacket. That individual ran behind my mom running towards the temple diagonally across the rotary. I then saw 2 cop cars one parked on the access road to Diamond and the other was parked on Hamilton Rd, both cop cars had no one in it. As I was crossing the street I could see more police cars with their lights on coming up Hancock St from the direction of Lexington Center. I then saw an officer carrying a large gun, more like a rifle not a handgun. He was running towards the temple from Hancock St on the Victory Gardens side of Hancock St. At that time I realized this was a serious matter, and my mom and I went behind two different trees and my dad kept walking down the street that lead to Diamond Middle School. Then another police car pulled up behind the other police car that was parked by the access road to Diamond.

I then heard several shots fired then saw the individual that was running towards the temple lay on his bottom and his upper body was up right and 2 officers on either side of him within 5 feet of him. I heard

the officer repeatedly saying "Drop the gun."

At that point I felt that the situation was under control because the individual was on the ground and there were 2 officers with the individual. So we left and started to walk down the street towards Diamond. As we were walking we then heard several more shots that sounded muffled. We continued on our walk and realized it was still serious, because we received a text from a friend telling us was else took place.
