Jennifer Reiners 10-08-1976 101 N. Hancock St Lexington

- 1. On Wednesday, 02-16-2022 at approximately 1250 hrs, I, Trooper Murgo, conducted an interview with Jennifer REINERS (10-08-1976) at her residence, 101 N. Hancock St, Lexington. This interview was conducted as part of the investigation into the fatal Officer involved shooting of Brendan REILLY (06-18-1986).
- 2. REINERS advised that on 02-12-2022 she was inside of her residence on the first floor watching television with her husband, Ralf REINERS (1982) when they began to hear screaming outside in the street. REINERS opened the shade to the window in her living room which faces the rotary of N. Hancock St, Hamilton Rd and Burlington St. This view is slightly obstructed by shrubbery and bushes. REINERS observed several Police Officers in the rotary.
- 3. At this time, REINERS went upstairs to her bedroom window which faces in the same direction as the downstairs living room window. This view is also slightly obstructed by some trees. REINERS did observe a male party wearing shorts and socks which she immediately identified as REILLY. REINERS is familiar with REILLY due to her residence being in such close proximity to 98 Hancock St. REINERS stated that she could not observe much due to the obstruction from the trees, however she heard Police Officers repeatedly yelling "drop the knife". REINERS stated that she heard this command repeated at least three times. REINERS did observe a Police Officer with a bigger gun that had an orange tip on it as well during what was described as a standoff in the rotary. REINERS stated that she then observed REILLY on the ground before she shut her shade and stopped viewing. REINERS advised that she would be available for any further questioning in the future.
