Narrative begins on the following page.

On February 13th 2022 at approximately 1040 hours, I conducted an interview of Eli Olidort (03/04/1986) at his residence of 9 Burlington St in Lexington. This was in furtherance of the investigation into the fatal shooting of Brendan Reilly. While waiting for Olidort to finish his prayer time, I spoke with his wife Shaina Bukiet (1992). Shaina informed me that her husband was the one who saw the end of the incident from outside the window on the first floor. Shaina informed me that her children ages, Eight, Four, and Two, also observed the incident from the window. Shaina provided me with her contact information and I advised her that an advocate from the District Attorney's Office would be reaching out to her to see if any of the District Attorney's services could benefit her children's well-being after seeing such a traumatic event. Shaina brought me to the window and showed me how it had a partial view of the incident as there was a large bush that blocked them from seeing the middle of the rotary.

I spoke with Olidort who informed me that he heard loud shouting coming from outside and went into the children's play room where he could see the police interacting with a man who had a knife in his right hand. He saw multiple officers with longer guns with what he believed to be red or yellow tape along the handles. He then heard Officers shouting for the man to put down the knife. The man was constantly moving around and looked like the Officers were moving around with him at a distance to keep him contained to the area. At one point all parties moved out of view and he heard numerous soft pops.

While looking outside of the windows Olidort observed an officer quickly come back into view moving backwards and then stumble and fall to the ground. He stated that it looked like the Officer had one of the longer guns with the colored tape on it and it appeared as the Officer was falling, he was losing control of and may have possibly dropped the gun. Olidort went on to describe how simultaneous to the Officer falling he observed another Police Officer come into view to the left side of the Officer Falling. At the same time he viewed the second Officer coming into view he saw the suspect with the knife very quickly come into view towards the Officer that was on the ground and then heard 3 to 4 louder pops. Olidort described the look on the Officers face as he was moving backwards as very startled and scared right before falling backwards.

Olidort stated that from the time he first heard the yelling to the time he finally heard the gunshots, several minutes elapsed during which time the Officers were asking the suspect to drop the knife. Olidort described the Officers as looking like they were really trying to prevent the situation from escalating but once the Officer fell everything happened so quickly.

Olidort stated that after he heard the gunshots he observed the man with the knife fall to the ground. Olidort could clearly see that the man still had the knife in his hand and observed one of the Officers rush over to the man on the ground, step on his wrist, and carefully grab the knife by the blade and move it away from the suspect. Olidort stated that the Officers immediately began providing aid to the man on the ground but that the individual looked pretty limp and unresponsive.

Olidort provided me with his contact information and advised that we could contact him if we had any further questions I could contact him.
