## **Rotary at Hancock Street and Burlington Street Examination**

Arrival Date/Time: February 12, 2022 / 1555 hours

Observations and testing:

- Residential area
- Intersection of Hancock Street, North Hancock Street, Burlington Street, Hamilton Road, and an unmarked roadway
- Roadways and sidewalks were wet with melting snow
- A tree and a blue package (MSP #22) were on the island of the rotary
- #98 and #100 Hancock Street were on the southside of the rotary
- #9 Burlington Street was on the northeast side of the rotary
- #106 North Hancock Street was on the northwest side of the rotary
- Pieces of apparent bean bags (MSP #1, 6,7, and 18-21), apparent shotgun shells (MSP #2-5 and 8-11), four discharged casings (MSP #13-16), a ring with a clover (MSP #23), Emergency Medical Technician debris, , a knife inside a plastic bag (MSP #17), and red-brown stains (MSP #12) extended between the front lawn of #9 Burlington Street and west sidewalk of Burlington Street

A screening test for the presence of blood was positive on the red-brown stains MSP #12.
