SUBJECT: STIGLIANO SHOTGUN SEAIZED 02-10-11

1. On 07-02-13 this officer was assigned to asset in the investigation in the Police involved shooting death of Andrew Stigliano in Ashland.

2.

On 07-10-13, this officer spoke with **Execution** concerning an antique shotgun which Stigliano had offered to sell went to the Ashland Police during the execution of a search warrant on 02-10-11. **Execution** stated that he went to the Ashland Police sometime after March 2013 inquiring about purchasing the weapon, and was turned away and stated the police never contacted him as he requested

3. On 07-09-13, Tpr. Jeffrey Saunders interviewed Attorney Joseph Hennessy concerning his involvement with Stigliano, immediately prior to the fatal shooting of Stigliano. In this interview, Hennessey relates information he has from a prior incident with Stigliano, in which his client (Ashland Police Officer Edward Pomponio) told him that he had never received a shotgun or seized money into evidence from a prior case with Stigliano.

4. Because of the information provided by **and Hennessey** Assistant District Attorney Adrienne Lynch requested this officer research the information provided.

5. This officer contacted Chief Craig Davis of the Ashland Police and requested the he research the information. This officer then contacted the District Attorney's Office in Fiamingham also. This officer determined that the prior case was related to a search warrant executed on 02-10-11, under the direction of Sgt. Gregg Wildman of the Ashland Police Department at 13 Metropolitan Ave, Ashland.

Search warrant 1149SW0049 was issued to Sgt Wildman. On the return, Item #1 is listed to be a "Shotgun", Item #11 is listed and crossed out and initialed to be \$7600.00, and item #20 is listed to be \$7,676.00 cash.

Ashland Police reports detail the arrest of Stigliano and others and recovery of aforementioned items.

Excellence In Service Through Quality Colicing

A State Police Crime Lab submission #11-02285-2 dated 02-24-11, lists item #2 as a Savage 24E Over/Under Shotgun related to Ashland Arrest 11-27-AR (incident in which warrant was served and Stigliano arrested) and lists Pomponio as delivering officer, and the signature is a circled "X"

State Police Evidence Return Receipt dated 09-26-12, indicates the 5 items submitted on 02-24-11 and one test fire, were returned to Gregg Wildman of the Ashland Police Department.

6. Chief Davis personally checked the Ashland Police Evidence and located the aforementioned shotgun still in the custody of the Ashland Police Department. The shotgun is a different, make, and model from the shotgun recovered on 07-02-13 at the fatal shooting of Andrew Stigliano
