1. On Friday March 24th, 2012 at approximately 1300 hours during the course of the investigation into the Malden police shooting at 500 Broadway me and Malden Police Detectives Mitch Montana and Jason Froio conducted a canvass of 500 Broadway, Malden of potential witnesses of the incident. 
█ stated he took the MBTA Route 411 bus home from Mass General Hospital where he works and exited at 500 Broadway at 1700 hours. █ ran across the street towards the front entrance of 500 Broadway where the island is and saw someone flagging police officers down in the median. █ could not describe remember what he looked like. █ observed this person pointing to a red Honda Civic in parking lot. █ further stated he observed what he described as an off-duty police officer wearing a bullet resistant vest and holding a radio pointing at the red car. █ also observed two people leaning out an apartment window towards the street saying "three guys with a gun just ran that way." █ continued toward the archway or entrance to the building where the lobby is located and heard gunshots. █ continued up to his apartment as he was concerned for his family. █ did not see more of the incident.

3. I spoke with:

█ DOB █ 1966

█ stated he was coming home from errands and walking inside the lobby when observed a woman he recognized as a neighbor of his scurrying inside the lobby with a young boy. █ did not know her name. █ stated he heard her say "the cops are chasing somebody." █ stated he helped her get inside the doors which close automatically. █ stated he then saw two males run into the archway area outside the doors and into the pool area. █ stated both of the males were wearing blue jeans and sneakers with one wearing a dark colored sweatshirt and a Red Sox baseball hat. He couldn't further describe the other male. Afterwards he went into the building to his apartment and didn't see or hear anything else.
