From: Officer Kasey Oestreicher Subject: 13 Metropolitan Avenue Date: July 3, 2013 I, Officer Kasey Oestreicher, report the following: On, Tuesday, July 2, 2013, I was working my assigned 7am-3pm shift in marked cruiser A10 covering the north sector. At approximately 10:51am I heard Officer Piers ask dispatch to confirm warrants for Andrew Stigliano. Andrew Stigliano is known to the Ashland Police Department and a recent warrant list had been in roll call. According to the list Andrew Stigliano had two warrants. Officer Piers asked for another car at 13 Metropolitan Avenue. Lt. Briggs and Officer Foster were responding to the area. Officer Piers had radio transmissions that was also on scene. informed officers and dispatch that is also known to the Ashland Police Department. A search warrant was executed at 13 Metropolitan approximately two years ago. At which time a gun, drugs, and pit bulls were taken out of the residence. Because there was a female was on scene I went to the area, but did not respond to the residence. I parked in the Rite Aid parking lot. I heard dispatch onfirm that Andrew Stigliano had two warrants. I also heard Officer Piers confirm that the address on the warrant was 13 Metropolitan. Dispatch confirmed the address as 13 Metropolitan Avenue. A few minutes later, as I was leaving the area, Lt. Briggs asked for my assistance. I arrived on scene and pulled into the short cut at the back of Papa Gino's facing westbound. At this time Lt. Briggs had leaning against marked cruiser A9. Upon my arrival I exited my cruiser and Lt. Briggs and I met between marked cruiser A9 and A10. At this time Lt. Briggs informed was under arrest for disorderly. I began searching . During the search began saying how she did not do anything wrong and that she knows her rights. During this was yelling that she was strangled by an officer and that she just told them to get off her property because she knows her rights. During this time also mentioned that the entire outside was placed in the rear of marked cruiser A10. I put her of the residence is under surveillance. personal items on the front passenger seat of marked cruiser A10. At this time I took position at the rear of marked cruiser A10. During this time I heard radio traffic regarding obtaining a canine. Officer Alberini is responding and will arrive within a few minutes. I also heard Dispatcher Patriarca inform officers on scene that she had Andrew Stigliano's attorney on the telephone and he was advising officers to use caution. A short time later Dispatcher Patriarca informed officers on scene that Andrew Stigliano had texted his attorney regarding harming officers. I observed Officer Alberini arrive on scene. Officer Alberini went to the middle of the residence between the garage and the residence. Officer Alberini then came back and retrieved Dax from the rear of his cruiser. At this time I was keeping my position at the right rear of marked cruiser A10. from the salon had approached me regarding her phone. I advised her to return to the salon. yelled that she would let us in the residence. I began screaming, "Please don't kill my dogs." nened the front passenger door and asked if she was giving us permission to use a key to gain entry and she said, No." I turned down my cruiser radio and then closed the door to the cruiser and returned to my position. During this time I was advising all pedestrians to walk around the area by walking either down Metropolitan towards Union Street or to use the paved area to the rear of Papa Gino's. I was also looking around to make sure Andrew

Stigliano did not exit the backyard area and that other individuals did not enter the scene. I heard Lt. Briggs

inform officers that the canine was working the house. I then heard two shots and then a third shot. I stayed at my location because I know that Andrew Stigliano has run from the police in the past and did not want him to attempt to flee the area. Sgt. Fawkes radioed that the suspect was down. There was also radio information regarding the Ashland Fire Department responding to the scene. I observed Officer Foster, Officer Alberini with Dax, and Sgt. Fawkes outside the residence. Sgt. Fawkes told me to take my cruiser and block Metropolitan Avenue. I informed him that I was unable to do so because I had in the rear of my cruiser. Sgt. . At this time I radioed my mileage to dispatch and Fawkes then told me to leave the scene with left the scene through the parking lot of CVS Pharmacy. I arrived at the Ashland Police Department and again gave dispatch my mileage. Once at the station I asked Officer Downey to watch while I put my gun in the lock box. Officer Downey and I then escorted to the booking area. I booked presence of Officer Downey. During the booking process asked me to contact Scott (former Chief Scott Rohmer). I said, "No." I advised her that she would be allowed to make a telephone call. At approximately 11:36am was verbally advised of her rights in the presence of Officer Downey. was asked if she had any medical conditions. advised this officer that she had if she needed medical attention regarding this issue or if she needed kidney disease. I asked medication? said that she did not need medial attention. was allowed to make a phone call and attempted two telephone calls before making contact with Ler mother. During this telephone conversation she was speaking loudly and stated, "Cops strangled me. Put n said that Andrew Stigliano ran into the backyard and hid in a hole and hands around my neck." they shot him in the hole while he was unarmed. Then said, "Because they shot Andy." I did not observed any marks on neck area. not observed any marks on neck area. In never asked for medical attention there were no other conversations. If was placed in cell #3. I printed the rights and property forms. I then entered cell #3 and asked to read and sign the papers. I informed that one form was stating the items she had in property and the second was a rights form. I had to inform was placed in cell #3.
