SUBJECT: SUPPLEMENTAL REPORT – POLICE OFFICER INTERVIEWS POLICE USE OF DEADLY FORCE – MALDEN DEATH

1. On Tuesday, March 27, 2012 I along with Captain Tom Swanson of the Malden Police Department interviewed several Police Officers who were involved in an on duty use of deadly force incident that occurred on Friday, March 23, 2012 in the City of Malden. The incident originated from a Bank Robbery in Saugus, Ma and continued into the City of Malden to the area of 500 Broadway. The incident involved officers from the Malden Police Department and the Saugus Police Department. Officers from both departments discharged their firearms in the course of performing their law enforcement duties and one suspect died as a result of the exchange of gunfire.
