







I took video evidence of the scene on Broadway and within the parking lot at the Cliffside Commons Condo Complex at the above location.



2. At approximately 1800 hrs I arrived at 500 Broadway and met with Lt Damore. He directed me to 140-142 near Kennedy Street in the Granada Highlands. Items of evidence secured there were photographed by this Officer.
3. On March 24, 2012 at approximately 1000 hrs I met with Tpr Lombard of MSP Ballistics at 500 Broadway. I took photographs of two projectiles.
4. On March 25, 2012 at approximately 1330 hrs I was requested by Tpr Baker of Middlesex SPDU to respond to 325 Main Street Saugus. There I photographed a brown Lincoln bearing MA reg 199HT5.

On 3/23/12, at approximately 1745 hrs, I was requested to respond to a fatal shooting at 500 Broadway St, Malden by Sgt Mahan.

Upon my arrival, I met Tpr Chambers, the case officer and Lt. D'Amore from CSSS Sudbury. Lt. D'Amore requested that I document the scene at the Cliffside Commons, 500 Broadway St. I photographed points of interest for the Middlesex County Detective Unit.

On 3/24/12, at approximately 1000 hrs, I responded to Malden PD and assisted in documenting four motor vehicles (Plymouth Voyager bearing Mass. reg. [REDACTED], Ford Fusion bearing Mass. reg. [REDACTED], Honda Accord bearing Mass. reg. [REDACTED], and a Hyundai Elantra bearing Mass. reg. [REDACTED]) that were being processed as well as assisting Sgt Cahill and Tprs Dougherty and Risteen from Ballistics in documenting/recovering ballistic evidence.

On 3/24/12, at approximately 1615 hrs, Tpr Baker from the Middlesex County Detective Unit requested my assistance in documenting evidence that was located at the Cliffside Commons, 500 Broadway St, Malden. Upon my arrival, I was directed to the Broadway St side of the Cliffside Commons and observed and photographed cash that was wrapped in a "band" and a pair of black sunglasses under a Nissan Rogue that was parked nine spots to the right of the main entrance to the building. The cash (\$250, 25 \$10 denominations) was immediately given to Tpr Banks and the sunglasses were transported to CSSS Boston (item 10-1). Also photographed was a rag that was under a Nissan, eight parking spaces to the right of the main entrance which was given to Lt D'Amore at Malden PD at approximately 1900 hrs to be given to the MSP chemists.
