On July 2, 2013, Trooper Jeffery Saunders of the Massachusetts State Police Middlesex County Detective Unit requested technical assistance in connection with the above subject. Forensic Scientist Emily Despres and I, Forensic Scientist Jana L. Thomas, responded, reporting to 13 Metropolitan Avenue at approximately 3:50 p.m. where we met with the following personnel among others:

At approximately 4:15p.m., Sergeant Peter Sennott transferred clothing to us. He identified the clothing as belonging to Officer Christopher Alberini of the Ashland Police Department.

Thirteen Metropolitan Avenue was a white single family dwelling. The residence consisted of a single level that was in disarray. We were directed to a ladder in the hallway leading to the attic of the residence. The attic was small, confined and extremely hot. A wooden plank running the length of the attic was observed at the top of the ladder. Several attic floor joists with insulation between them and pipes were noted in the attic. Trash, toys and bags were observed. The body of a male individual was noted in the northeast corner of the attic lying on the wooden plank. The body was in the supine position and dressed in green pants, a blue shirt and a pair of

boots. Emergency medical technician debris was noted around the body. Red-brown stains were noted on the insulation and frame of the house. A screening test for the presence of blood was positive on the red-brown stained insulation.

The firearm of Officer Christopher Alberini was in the possession of Sergeant David Cahill. The firearm was labeled "Glock 22 Austria" and had a serial number of "GET381". Red-brown stains were noted on the slide, barrel and trigger guard. A screening test for the presence of blood was positive on the red-brown stains on the slide, barrel and trigger guard of the firearm.

We departed 13 Metropolitan Avenue at approximately 5:05 p.m. and were directed to the Ashland Police Department. We arrived at the Ashland Police Department at approximately 5:15 p.m. where we met with the following personnel among others:

Upon arrival, we were shown the duty belt and vest of Officer Christopher Alberini. Red-brown stains were noted on the duty belt and vest. A screening test for the presence of blood was positive on the aforementioned red-brown stains.
