SUBJECT: APRIL 22, 2016 AUTOPSY OF MARIO MEJIA MARTINEZ

1. On the morning of April 22, 2016 this officer attended the autopsy of Mario Martinez Mejia (DOB 01/29/1968) at the Office of the Chief Medical Examiner (OCME). The autopsy was performed by Dr. Henry Nields.
2. Upon speaking to Dr. Nields I learned that Mejia Martinez had a total of six gunshot wounds. There were five gunshot wounds to the torso and one to the head. There were six entrance gunshot wounds and three exit gunshot wounds, including one entrance and one exit wound to the head. There were three spent projectiles recovered from the body. The projectiles recovered from the body were later secured by Lieutenant David Cahill, FIS/ Ballistics for forensic analysis.
3. Dr. Nields stated that the cause of death is gunshot wounds to the head and torso with the manner as homicide.
