1. On Wednesday, January 4. 2023, CPAC was notified of an officer involved shooting at 59 Chestnut St. in the City of Cambridge. Middlesex CPAC responded and learned that at 1:15 p.m. the Cambridge Police Department received a 911 call for a disturbance, reporting a male was cutting himself with a machete in the rear of 254 Sidney St. Members of the Cambridge Police responded and observed a male cutting himself with a machete. The male took off running from Police and a foot pursuit ensued.

2. Members of the Cambridge Police encountered the male in the rear of 59 Chestnut St. A preliminary investigation suggests that commands to "drop the knife" were verbally given to the male, and a less lethal impact munition round was utilized with negative results.

3. The male kept advancing towards the officer armed with the kukri knife. The officer discharged his department issued firearm and struck the male multiple times.

4. First aid was administered at the scene, and the male was transported to Massachusetts General Hospital to be treated for his injuries. The male subcommand to his injuries and was pronounced deceased at the hospital.

5. Multiple Massachusetts State Police assets are assisting in the investigation: Sgt. Ryan Hodgdon, Trooper Gabriela Reardon, and Trooper Stephanie Devlin of the Crime Scene Services Section, Massachusetts State Police chemist Brian Cunninham, Det. Lt. Richard Wolanski and Trooper Phil Kucha from the Collision Analisys and Reconstruction Section, Trooper Jason Beausoleil from the Firearms Identification Section, Troopers assigned to the Special Emergency response Team, and Troopers assigned to the Middlesex District Attorney's Office.

6. The investigation continues along with the Cambridge Police Department.

On Thursday, January 5th, 2023, Lieutenant Gagnon requested an examination of a phone that belonged to Sayed FAISAL (DOB 5/30/2002). FAISAL was shot and killed during an officer involved shooting incident in the city of Cambridge on January 4th, 2023. The phone had been transported to the Middlesex District Attorney's Office by Trooper Murgo and secured in the phone lab. The phone was a gray iPhone 14 with a black edge. The phone was secured in a black Spigen Magnetic Case. Attached to the case was a magnet card holder that contained a Massachusetts ID and Apple Credit Card. Both items belonged to FAISAL. The phone was powered on and in airplane mode.

At approximately 1000 hours on January 5th, 2023, I utilized GreyKey to attempt an extraction of the phone. GreyKey responded that the device is not supported. It listed the software version as 20A380. I also contacted Cellebrite and learned that iPhone 14's are not supported at this time. The phone was secured in the phone lab and connected to a power source, awaiting a software update that will support an extraction of the device.

1. On Thursday January 5, 2023 at approximately 1100 hrs. Cambridge Detective Micelli and I spoke with Kathryn Vallier, Director of Operations at the Charles Hotel, 1 Bennett St. Cambridge in regards to former employee, Sayed Arif Faisal. She stated the following:

2. Faisal started working at Henrietta's Table, a restaurant in the Hotel, on October 13, 2022 as a Host. He was frequently 15-30 minutes late to work. She explained that he wanted to be a server, but they did not need servers at the time. His last day of work was December 11th stopped coming in to work on December 13th, 2022 the following shift he stated that he had a family emergency. He stopped showing up to work and came back on December 22, 2022 at approximately 0800 hrs to drop off his name tag.

1. On Wednesday, January 4, 2023, I went to Massachusetts General Hospital as part of the Middlesex-SPDU response to the officer involved shooting of Sayed Faisal in Cambridge. In the hospital I met with Cambridge investigators Deputy Superintendent Peter Velluci, Sergeant Nicholas Mochi, Detective Don Mahoney, Detective Brian O'Connor, and Officer Muhammed Khalid. We were led to an area outside of the operating room where we awaited an update on the status of Faisal. A short time later, we were notified that Faisal had been pronounced deceased by Dr. John Parks. Dr. Parks told us that he observed at least three wounds on Faisal's body that he believed were from gunshots.

2. While still at the hospital, investigators were made aware that Faisal's mother, Mosammat Begum (DOB 22; phone # 23, phone # 24, phone

3. Initially present for the interview was Detective Don Mahoney, Faisal's parents, Officer Muhammed Khalid, a hospital social worker, and me. It was then determined that Sayed and Mosammat would speak with us through a Bengali interpreter provided through an interpreter service on a hospital iPad. Mosammat signaled that she would like the social worker to stay with her during the interview, and Officer Khalid left the room. During the interview we learned that Faisal lived with Mosammat and Sayed at 625 Putnam Ave, #107, in Cambridge. They were unaware if their son had a girlfriend, and they could not think of any close friends or family he might speak with. They knew that Faisal had worked at the Charles Hotel in Cambridge, but he left that job last week. Faisal told his parents that he was looking for a new job. Investigators were told that Faisal was a student at UMass-Boston where he was in his sixth semester and studying mechanical engineering. Sayed and Mosammat never heard of or saw Faisal talk about hurting himself or others. They never saw Faisal with weapons, or heard him talk about any. Faisal's parents believed that he had one cellphone, and there was a desktop computer in his room. Sayed and Mosammat did not think their son used any illegal drugs, and he was not prescribed any medication.

4. Faisal was at first described as being good during the previous weeks, but he was not sleeping a lot. He had also begun praying and reading the Koran excessively. Faisal usually prayed, but he had started doing it much more than before. Mosammat believed that Faisal was anxious, tense, and scared of something, possibly death. Two Fridays prior to our meeting, Faisal woke up his parents to tell them to start praying because the world was coming to an end. Faisal kept saying that the last day on Earth was coming, something was about to happen, and everyone was going to die. Mosammat described this as unlike Faisal, and she asked him to see a doctor. Faisal told his mother that nothing was wrong with him so there was no reason to see a doctor. Sayed and Mosammat were also aware that Faisal was attempting to join the US Army, but he was secretive about it. Faisal told his parents that joining the Army would help pay for his college, but he had missed some kind of deadline preventing him from joining immediately.

5. On the morning of January 4th, Faisal had breakfast with his parents. Nothing seemed out of the ordinary, and Faisal returned to his room after eating. Mosammat left their apartment around 0900 hours to complete some errands, and Sayed left around noon to go to work. It was normal for Faisal to stay in his room because he did not have work. When Mosammat returned home she was told what happened, and she drove to the hospital.

6. After speaking with Mosammat and Sayed, Detective Mahoney and I asked them to sign a consent form to search their home, 625 Putnam Ave, #107, in Cambridge. Detective Mahoney held the form upright, and I held the hospital's iPad so that the Bengali Interpreter could see the form. The interpreter read the form for Mosammat and Sayed, and they consented to the search. Both signed the form. After signing, Mosammat and Sayed asked Detective Mahoney and me questions regarding the incident. The questions were similar and ranged along the lines of why did this happen, and why wasn't Faisal shot in the legs. Mosammat also asked if the doctor would be able to tell if there was anything physically, or mentally, wrong with Faisal. Detective Mahoney and I told the couple that an investigation was being conducted, and Faisal was going to be brought to The Office of the Chief Medical Examiner. I provided Mosammat with my business card before leaving the room.

1. On Wednesday, 01/04/2023 at approximately 1800 hrs, I, Trooper Murgo along with Detective Barkhouse conducted an interview at the above address of Xavier MARTIN (2009) in the presence of his mother, Shanice JONES ((1986) as part of the investigation into the death of Sayed FAISAL (05/30/2002). stated the following : At approximately 1315 hrs, MARTIN was playing video games in his bedroom with his brother and his friend, Jayden WALKER ((2006). The bedroom is located at the above address on the third floor in the back of the apartment with a window that faces the left side of the apartment building as well as the back; with a vantage point of 625 Putnam Ave., Cambridge. MARTIN and WALKER heard a loud crashing sound which also sounded like glass breaking. MARTIN and WALKER looked out of the bedroom window and observed FAISAL climbing out of the first floor window of 625 Putnam Ave. FAISAL appeared to be crawling out of the window feet first before falling to the ground. At this time, MARTIN and WALKER observed a large "machete" looking knife in FAISAL's hand and what appeared to be a bible in his other hand. FAISAL had on a shirt that appeared to be blood stained. FAISAL then walked onto the path that is located on the left side of 254 Sidney St and sat down on the path. FAISAL then took off his shirt and began cutting his wrist with the large knife while speaking to himself: however MARTIN and WALKER could not hear what FAISAL was saying.

2. MARTIN relayed all of the above information to his brother who was lying in bed. MARTIN's brother called 911 dispatch and began relaying the information that MARTIN was giving him as to what FAISAL was doing. MARTIN observed FAISAL get up and walk over to the window that he climbed out of and grab a piece of glass before returning back to the path he was sitting on. FAISAL then sat down and began cutting his wrist with a piece of glass. MARTIN stated that he believed the Police arrived on the street which was out of view from his window, which was when FAISAL ran behind 254 Sidney St on the path and out of view. MARTIN stated that this interaction from when FAISAL climbed out of the window until the Police arrived was approximately 7 minutes. MARTIN and JONES advised they would be available for any further questioning.

1. On January 5, 2023, at 11:50 a.m. Det. David Barkhouse of the Cambridge Police Department and I attended the autopsy of (Sayed Arif Faisal 05-30-2002). The autopsy was conducted at the Office of the Chief Medical Examiner in Boston by Dr. Michele Matthews.

2. Dr. Matthews informed me no stippling was observed on the body. Lacerations on the neck and both wrists were observed. Six gunshot wounds observed; right chest, left neck, left upper arm, left torso, right leg and right wrist. Two projectiles were recovered from the body, one from the liver and one from the right femur.

3. Dr. Matthews informed me the cause of death will be multiple gunshot wounds, and the manner will be homicide.

1. On Wednesday, January 4, 2023, Cambridge Police Detective Brendan O'hearn and I interviewed (Samuel Stubbs 1997) at the Cambridge Police Department. The interview was conducted in interview room #1. Stubbs stated the following statements to be factual.

2. On Wednesday, January 4, 2023, Stubbs was at his parent's residence (Chestnut St.) watching television in the living room when he heard a commotion outside. Stubbs could hear voices but could not tell what was being said. Stubbs turned off the television, ran over to the dining room window and heard an assertive voice from the outside yelled "drop the knife". Stubbs quickly started recording from his cell phone device and capture part of the incident from the dining room window. Stubbs heard multiple gunshots and observed police officers running through the driveway of 59 Chestnut St. heading towards the backyard. Stubbs while still recording ran towards the kitchen window that faces the backyard and observed a male on the ground and police officers in the back yard. Stubbs stopped recording at this time. Stubbs then observed police officers and an ambulance responding to assist at the scene.

3. Stubbs provided a copy of the video he recorded. The Cambridge Police Department is in possession of the video.

1. On Friday January 6, 2023 at approximately 1115 hrs. Detective Micelli and I went to CVS at 624 Mass Ave in Cambridge to speak with Faisal's Former supervisor, named Prahlad, and obtain his dates of employment. On arrival, we spoke with Camille El-Issawy, who explained that she is a supervisor and worked with Faisal. She advised us that Faisal came into the CVS either the day before or a couple of days before the shooting. He spoke with her, Prahlad and a security guard who she only knew as Ray. She stated that at that time, when he was in CVS he seemed depressed. He didn't want to go to school or work. She formed the opinion that he was suicidal. She told us that Prahlad was due in today at 2 o'clock and provided us an email of a supervisor that would be able to assist us in obtaining Faisal's dates of employment.

2. We returned to the CVS at approximately 1400 hrs. and spoke with Prahlad Harijan. He explained that he is currently the Ops Manager and was a Supervisor when Faisal worked there. He said he was a good worker and did not have any bad interactions with him. He stated he would occasionally be late, but would call up when he was running late. He stated he remembered him coming in to CVS recently but believed it was on Saturday December 31, 2022.

3. I again spoke with El-Issawy, who was able to contact Ray via Instagram on her phone. I spoke with him, and he identified himself as Raymond Barreau. He stated he worked for Westech, which is a security company that is contracted by CVS. He stated that on Tuesday January 3, 2023 Faisal came into CVS at approximately 1800 hrs. He spoke with him there and went to Tasty Burger with him. There conversation consisted of Faisal telling Barreau that he wanted to focus more on goals and he has been distracted in the last year. He was also talking about a girl but Barreau did not know the name of the girl or who the girl was.

4. Detective Micelli and I then observed video of Faisal entering CVS at approximately 1700 hrs. at approximately 1715 hrs. he leaves with Barreau.

1. On Friday, January 6, 2023, Cambridge Detective Tony Schwartz and I spoke with Paramedic Elise Gedansky at the Pro EMS office in Cambridge. Elise was one of the responding members from Pro EMS that attended to Sayed Faisal at the scene of the shooting and during his transport to Massachusetts General Hospital. Elise's crew was notified of the incident regarding Faisal as a psychiatric call for a person with a weapon. They didn't know any particulars, but the ambulance proceeded to Sidney St at Chestnut St to standby because the police were in a foot pursuit. The ambulance ended up stopping behind a Cambridge Police Cruiser that was blocking the street. Elise's team received some kind of an update that shots were fired and they needed to relocate. At that time they were unaware of who was shot, but they donned their protective vests and Kevlar helmets before proceeding to the scene on Chestnut St. The ambulance stopped in front of a blue house.

3. Once at the scene, Elise began gathering medical equipment from the ambulance. She described the environment as high stress for those officers already on scene, and she assumed the subject was shot. Cambridge Police Officers were yelling, and they began taking equipment from the ambulance they believed was necessary. One thing she recalled being taken by an officer was a blanket. Elise went to the backyard scene, and she observed Faisal, handcuffed, face up on the ground wearing underwear. His head was facing the right corner of the yard, and his legs were facing the house. Elise did not see any weapons in the backyard. Faisal was covered in blood which made it difficult to completely see his wounds. There were tourniquets on both his arms, placed at the shoulders, and one on his right leg. Elise also saw what she thought was a gunshot wound to Faisal's right thigh, and she believed that leg was broken. Elise asked the officers who shot, and what caliber round. She was told it was a 9mm round, and it was believed that Faisal was shot three times. A medical seal was already applied to Faisal's chest, and another one was on his lower left flank. Someone on scene mentioned that Faisal jumped out of a window, but Elise could not confirm that. Officers were asking for additional medical seals, but in the initial confusion of officers taking equipment from the ambulance, Elise did not know where her trauma kit was.

4. Elise described Faisal as combative while he was being treated in the backyard. She also distinctly recalled Faisal smiling at her when she tried to speak with him. Elise described his facial expression as eerie. Faisal could move both his arms, head, and left leg. When they tried to move Faisal, he would flail those limbs. Faisal had to be held down by officers, but she would not classify it as restraining him. A Cambridge Police Officer continued holding pressure on Faisal's chest, and he was brought to the ambulance. Paramedic Megan May got in the ambulance to assist during the transport to Massachusetts General Hospital.

5. In the back of the ambulance was Elise, Paramedic Megan May, Cambridge Firefighter Darryn DeGrace, and an unidentified Cambridge Police Officer. The ambulance was being driven by Giana Conserva. Squad 2 (ambulance) was following the ambulance with Faisal to Massachusetts General Hospital. Faisal remained uncooperative while in the ambulance. He was clearly screaming, and trying to take off the rebreather providing him with oxygen. The ambulance was traveling over the Longfellow Bridge when Faisal stopped moving. They could not determine his blood pressure due to the tourniquets on his body. Faisal was given fluids through an intraosseous infusion into his left leg, and he was intubated. The paramedics also performed needle decompression on Faisal's left side, and the Cambridge Police Officer maintained pressure on Faisal's chest. Elise was not aware of any self-harm performed by Faisal until the officer said it on the ambulance. Elise saw cuts on Faisal's right wrist that were deep enough to see tissue. There

was no bleeding due to the applied tourniquet. She was also told about superficial cuts to the back of Faisal's neck. By the time the ambulance arrived at the hospital, Elise was told by someone that Faisal was shot five times. When the ambulance arrived at the hospital, everyone from the ambulance went with Faisal inside. The occupants of Squad 2 went inside as well. Faisal was brought to Acute Room 7, and Elise gave her report to hospital staff before leaving.

Rodney was one of the personnel from Pro EMS that responded to the scene of the fatal shooting of Sayed Faisal. On January 4, 2023, Rodney was assigned to Paramedic 9 (ambulance) with Paramedic Megan May. They were driving through Cambridge when they were told to relocate due to the call for shots fired. Paramedic Elise Gedansky was reporting a shooting at 59 Chestnut St in Cambridge, and she was requesting additional chest seals.

2. Paramedic 9 arrived at Chestnut St, and Rodney went to the back of the ambulance to grab his trauma purse. While Rodney was in the back of the ambulance, he was approached by Cambridge Police Officer McMahon and another Cambridge Police Officer he believed was a supervisor of some kind. Rodney was told that Officer McMahon needed to be transported to a hospital. Paramedic Megan May left Paramedic 9 to bring chest seals to Elise Gedansky. It was determined that Paramedic Thomas Wobby would drive Paramedic 9 and transport Officer McMahon, with the Cambridge Police supervisor and Rodney, to Mt. Auburn Hospital.

3. During the transport, Rodney said it was clear Officer McMahon was upset. Officer McMahon denied having any physical injuries, but he appeared stressed. Rodney was not fully aware of what had just transpired, and he asked Officer McMahon what just happened. Officer McMahon told Rodney, "I just shot someone." Rodney checked Officer McMahon's vital signs, but Rodney said there was no real conversation. It appeared to Rodney that the Cambridge Police Supervisor was just telling Officer McMahon where they were going. The ambulance arrived at Mt. Auburn Hospital, and the occupants entered the hospital. Officer McMahon was seated on a bed in the hallway and he was registered with the staff. Rodney then cleared from the hospital.

1. On Friday, January 6, 2023, Cambridge Detective Tony Schwartz and I spoke with Paramedic Megan May at the Pro EMS office in Cambridge. Megan was one of the personnel from Pro EMS that responded to the scene of the fatal shooting of Sayed Faisal. On January 4, 2023, Megan was assigned to Paramedic 9 (ambulance) with Paramedic Rodney Smith. They were driving through Cambridge when they were dispatched to respond for a shooting. The pair stopped to put on their tactical gear when they heard the incident was an officer involved shooting.

2. Paramedic 9 arrived at Chestnut St. in Cambridge, and parked behind Paramedic 1 (ambulance). Megan brought chest seals to Paramedic 1, and she saw Faisal already in the back of Paramedic 1. It was determined that Megan would ride in the back of Paramedic 1 during the transport of Faisal to Massachusetts General Hospital. Also in the back of the ambulance was a Cambridge Firefighter (Darryn DeGrace), an unknown Cambridge Police Officer, and Paramedic Elise Gedansky. EMT Giana Conserva drove Paramedic 1.

3. Megan observed multiple injuries to Faisal. She saw what she described as bilateral cuts to Faisal's wrists, and two to three inch cuts to his neck. Megan also saw what she thought were gunshot wounds to Faisal's right upper chest and possibly his lower left abdomen. Those wounds were already sealed. Tourniquets were also applied to the upper parts of both arms and the upper right leg of Faisal. The Cambridge Police Officer was applying pressure to one of Faisal's wounds. Faisal was not wearing a shirt or shoes, but he might have been wearing underwear with his legs exposed. Faisal maintained a pulse and respiratory readings while they drove. Megan described Faisal as appearing pretty out of it until he was given an intraosseous infusion. Faisal yelled, "Oh my god, my leg." He screamed a few more times, and he appeared to be moving his arms in an attempt to fight treatment. The paramedics also performed a chest decompression to Faisal. The ambulance arrived at Massachusetts General Hospital, and Faisal was brought inside still having a pulse. Megan cleared from the hospital after transferring Faisal.
