NARRATIVE

On February 16, 2023, while assigned to the Criminal Investigations Section of the Cambridge Police Department and at the direction of Assistant District Attorney Carrie Spiros I responded to the Middlesex District Attorneys Office located in Woburn, Massachusetts to speak with Mr. Muhammed Majibullah (father of Sayed Faisal) and Ms. Joynab Ara (Grandmother of Sayed Faisal). Present during this meeting was Mr. Muhammed Majibullah, Ms. Joynab Ara, Ms. Barbara Dougan (Legal Director for The Council on American-Islamic Relations Massachusetts), Middlesex A.D.A Carrie Spiros, Massachusetts State Police Lieutenant Eric Gagnon (CPAC), Massachusetts State Trooper Christopher Murgu (CPAC), the brother of Muhammed Majibullah (unknown name), Bengali interpreter (unknown name). The purpose of the interview was an attempt to get a better understanding of Sayed Faisal as a person, as well as, his behavior and activities prior to his encounter with the police on the day of January 4, 2023. Mr. Majibullah stated that on January 4, 2023 he, Sayed (who he refers to as Prince), and the grandmother all ate breakfast together at approximately 10:00AM-11:00AM. Sayed appeared happy and offered to help his grandmother fix the television after breakfast. Mr. Majibullah stated he left for work at approximately 12:30, leaving Sayed and the grandmother in the apartment together.

Mr. Majibullah stated that Sayed was unemployed at the time, but had previously worked at C.V.S. and at a hotel in Harvard Square. He stated Sayed never showed signs of anger, was always mild mannered, was not known to use drugs, alcohol nor cigarettes. He further stated that Sayed had no known mental health issues. He stated Sayed had shown interest in joining the U.S. Army, so they could assist with paying for college. He stated Sayed had recently taken a trip to Nepal, with a friend who had recently joined the Army. This friend had family in Nepal.

Mr. Majibullah stated he was unaware of any lock boxes/ safes that Sayed may have kept in his room and was unaware of any knives that he may have had.

Mr. Majibullah stated Sayed had a close relationship with his cousin and was friendly with a Bengali kid (unknown name) and an Indian kid (unknown name).

Mr. Majibullah stated that although he had spoken to his wife about a possible divorce, he had not spoken to Sayed about it, further stating that his mother may have, but he did not.
