NARRATIVE

On 01/10/2023, Trooper Torres contacted Det. Barkhouse and I, and informed us that the District Attorney's Office wanted us to locate and interview an individual by the name of "Amtiaz Uddin." I was informed that there was a segment from a news article which stated:

"Amtiaz Uddin was moved to tears as he spoke of his friendship with Faisal."

number and got no answer, so I left a message.

"He was my best friend." Uddin told the Globe. "He was always being nice to everyone. He was always beside me for any situation."

I conducted a query of the name Amtiaz Uddin on the Cambridge Police Department's Master Name Index and on CJIS. Both law enforcement search tools revealed one result, which depicted an Amtiaz Uddin (DOB: . At approximately 12:30 PM, Det. Pasquarello and I went to this address and knocked on the door. An unidentified woman opened the door and we introduced ourselves to her. I asked her if Amtiaz Uddin was there and she replied that he did not live here. I asked her if she could provide me with his phone number. She indicated that she would go get her phone and closed the door. From outside the unit, I could hear this woman make a phone call and begin speaking to someone in Bengali. A short time later, the door opened and she advised me to speak to the person on the other side of the phone call. This person identified themselves as Amtiaz's cousin, Washim (). Upon request, Washim provided me with Amtiaz's phone number as At approximately 1:17 PM, I called Amtiaz from my department-issued cellphone. He answered the call and confirmed his full name. I introduced myself to him and asked him if he had made a statement regarding the death of Arif Faisal. Amtiaz stated that he did not make any statements about Arif Faisal. I then asked him if he would be willing to speak to me about this incident and what he knew about Arif Faisal. He stated that for any statements on his behalf, I should contact his "alternative", a person named Fatema Ahmed at 1-I then called this

At approximately 2:13 PM, I received a phone call from the phone number, I have a caller identified himself as Carlton Williams. He stated that he represented Amtiaz Uddin. He asked me why I wanted to speak with Amtiaz, and I replied that in regards to an incident that occurred recently, Cambridge Police had been conducting interviews with friends and family members of Arif Faisal. Williams wanted to know what I wanted to know about Arif Faisal and I replied that I was going to ask some basic questions to Amtiaz about how he knew Arif Faisal and

what he knew about him. At some point in this conversation, Williams asked me if I was insinuating that Arif Faisal was a "violent" person. I replied that I did not make any statements of that note and apologized if I wasn't clear with my explanation for why I called Amtiaz. Williams advised me that if I had any questions for Amtiaz, that they can be directed to him. I then asked Williams to confirm the spelling of his full name, which he did. I then asked Williams for his Bar Association ID number, to which Williams asked me why I asked him for that and that in twenty years, not one police officer has ever asked him for his Bar ID number. He added that I could've easily obtained that number online in "two seconds" with his name. I apologized to Williams again for taking offense to me asking for his Bar ID number and began to tell him that it was to confirm who he was before I made statements regarding this investigation. The conversation with Williams abruptly ended shortly after.
