

ADDITION BY DET. JEFF BLODGETT

ON SUNDAY JULY 23, 2017 I DET BLODGETT WAS CALLED IN TO ASSIST WITH AN OFFICER INVOLVED SHOOTING THAT TOOK PLACE AT 3 CLOVERHILL RD CHELMSFORD, MA. I WAS ASKED TO ASSIST MASSACHUSETTS STATE POLICE TROOPER (CPAC) MIKE WILLIAMS WITH DOING AN INTERVIEW TRP WILLIAMS AND I (BLODGETT) INTERVIEWED WITNESS AND RENTER OF 3 CLOVERHILL RD CHELMSFORD, MA [REDACTED] 52. I LEARNED THAT MR [REDACTED] HAD CALLED 911 TO ALERT CHELMSFORD POLICE [REDACTED] THIS MORNING AT 3 CLOVERHILL RD. MR. [REDACTED] WAS INTERVIEWED IN THE MEDIA AREA OF THE POLICE AREA. WE WERE LOOKING TO GET HIS ACCOUNT OF WHAT HAD TAKEN PLACE TODAY AND ALSO GET CONSENT TO SEARCH HIS RESIDENCE. PRIOR TO THE START OF THE INTERVIEW TRP. WILLIAMS READ MR [REDACTED] A CHELMSFORD POLICE DEPARTMENT CONSENT TO SEARCH FORM. MR. [REDACTED] TOLD US HE UNDERSTOOD AND WAS WILLING TO GIVE CONSENT TO SEARCH HIS RESIDENCE AND HE SIGNED THE FORM (SEE SIGNED CPD CONSENT FORM TAKEN BY TRP. WILLIAMS).



MR [REDACTED] SAID THAT EARLY THIS MORNING (JULY 23, 2017) [REDACTED]



[REDACTED] SAID AT THAT POINT HE CALLED 911 FOR THE CHELMSFORD POLICE TO COME. [REDACTED]

MR. [REDACTED] SAID WHEN THE FIRST OFFICER ARRIVED HE KNOCKED ON THE BEDROOM DOOR TO [REDACTED] AND OMAR'S ROOM. HE SAID THE OFFICER ANNOUNCED HIS PRESENCE AND TOLD OMAR TO OPEN THE DOOR. OMAR AT FIRST DID NOT OPEN THE DOOR. MR. [REDACTED] SAID THAT OMAR THEN OPENED THE DOOR AND THEN SLAMMED IT ON THE OFFICERS FACE. MR. [REDACTED] SAID THAT THE OFFICER ATTEMPTED TO KICK THE BEDROOM DOOR TO GAIN ENTRY. OMAR THEN CAME OUT OF THE ROOM TOWARD THE OFFICER AND PUNCHED THE OFFICER IN THE FACE. MR. [REDACTED] SAID HE SAW THE OFFICER FLY IN THE AIR AND HIT A WALL. THE OFFICER THEN TOOK OUT HIS TAZER AND WENT BACK TOWARD THE BEDROOM IN THE AREA WHERE OMAR WAS. MR. [REDACTED] SAID THE INCIDENT WAS TAKING PLACE BY [REDACTED]'S BEDROOM AND BATHROOM AREA AND IN THE FOYER AREA. WE ASKED HOW MANY OFFICERS WERE AT THE HOUSE AT THIS POINT AND HE SAID ABOUT 3-4. MR. [REDACTED] SAID HE THEN HEARD GLASS BREAKING IN THE BATHROOM AND HE HEARD CRASHING. MR. [REDACTED] SAID THAT HE HEARD POLICE TELLING OMAR TO STOP OR HE WOULD BE TAZED. THE OFFICER'S TOLD OMAR TO PUT HIS HANDS BEHIND HIS BACK. HE THEN HEARD THE TAZER GO OFF AND HE HEARD OMAR AND [REDACTED] YELLING. MR. [REDACTED] SAID THAT OMAR CONTINUED TO BE VIOLENT TOWARD POLICE AND HE CONTINUED TO HEAR CRASHING. MR. [REDACTED] SAID THAT OMAR WAS SCREAMING AT THE TOP OF HIS LUNGS AT POLICE. WE ASKED IF HE HEARD WHAT OMAR WAS SAYING AND HE TOLD US HE COULD NOT. MR. [REDACTED] SAID HE THEN HEARD A GUN SHOT GO OFF. WE ASKED HOW MANY TIMES AND HE TOLD US HE BELIEVED JUST ONE. MR. [REDACTED] SAID THAT THE AMBULANCE THEN SHOWED UP A SHORT TIME LATER AND TOOK OMAR TO THE HOSPITAL. MR. [REDACTED] SAID THAT HE SAW GLASS IN THE HALLWAY BY THE BATHROOM. HE TOLD US THAT OMAR COULD HAVE HAD A PIECE OF GLASS IN HIS HAND BUT HE DID NOT SEE HIM WITH IT. WE ASKED IF HE HAD ANYTHING FURTHER TO OFFER AND HE TOLD US THAT THIS WAS IT. WE THEN CONCLUDED THE INTERVIEW.
