On April 21, 2016, Sergeant Peter Sennott of the Massachusetts State Police Middlesex County Detective Unit requested technical assistance in connection with the above subject. I, Forensic Scientist Timothy E. Woods, responded, reporting to the intersection of Broadway, Chelsea Street and Norwood Street at approximately 1940 hours where I met with the following personnel, among others:

Detective Lieutenant Thomas Sullivan (Massachusetts State Police Middlesex County Detective Unit)
Trooper Robert Quigley (Massachusetts State Police Crime Scene Services Section)

The intersection of Broadway, Chelsea Street and Norwood Street was a four-way intersection located in an urban area. Broadway ran southwest to northeast through the intersection, while Chelsea Street and Norwood Street approached the intersection from the southeast and northwest respectively. Businesses were noted on each corner of the intersection, with Cancun Bar and Restaurant at the north corner, Everett Square Convenience at the east corner, Global Dental at the south corner and a small park and Tres Lounge at the west corner. Upon arrival, I was directed to the northwest sector of the intersection to an area on Broadway adjacent to the intersection with Norwood Street. Red-brown stains with Emergency Medical Technician (EMT) debris (A) were noted on the ground. Directly to the north of this, additional red-brown stains (B) were noted on the ground.

A screening test for the presence of blood was positive on the following:

- Red-brown stains with EMT debris on ground – A
- Red-brown stains on ground – B



On April 21, 2016, Lieutenant David Cahill and Troopers David Hughes and Michael Bonasoro of the Firearms Identification Section responded to the intersection of Broadway at Chelsea Street in the City of Everett for a Fatal Police Officer Involved Shooting. The following evidence was recovered and returned to this section for examination:

- 3-1 Firearm 45 AUTO caliber Glock model 21 semi-automatic pistol serial number TPC469
- 3-2 Ammunition One (1) 45 Auto caliber live cartridge from chamber of item 3-1, head stamp "FEDERAL 45 AUTO +P" caliber
- 3-3 Magazine(s) One (1) magazine from item 3-1 with seven 45 auto caliber live cartridges, head stamp "FEDERAL 45 AUTO +P"
- 3-4 Discharged Cartridge Casing(s) One (1) 45 auto caliber discharged cartridge casing, head stamp "FEDERAL 45 AUTO +P" CSS placard #2
- 3-5 Discharged Cartridge Casing(s) One (1) 45 auto caliber discharged cartridge casing, head stamp "FEDERAL 45 AUTO +P" CSS placard #3
- 3-6 Discharged Cartridge Casing(s) One (1) 45 auto caliber discharged cartridge casing, head stamp "FEDERAL 45 AUTO +P" CSS placard #4
- 3-7 Discharged Cartridge Casing(s) One (1) 45 auto caliber discharged cartridge casing, head stamp "FEDERAL 45 AUTO +P" CSS placard #5

On 04/22/2016 Lieutenant David Cahill responded to the Office of the Chief Medical Examiner. The following evidence was recovered and returned to this section for examination:

- 5-1 Spent Projectile(s) One (1) copper jacketed lead spent projectile received from the OCME from right lower back
- 5-2 Spent Projectile(s) One (1) copper jacketed lead spent projectile received from the OCME from right back
- 5-3 Spent Projectile(s) One (1) copper jacketed lead spent projectile received from the OCME from abdomen

As recovered item 3-1 is a .45 Auto caliber Glock model 21 semi-automatic pistol, serial number TPC469. The weapon has a barrel length of 4 ½ inches and has a general rifling system of eight lands and eight grooves with a right hand twist. The trigger pull was measured between seven and eight pounds. Item 3-1 was test fired using two live cartridges from item 3-3, no malfunctions were noted.

As the result of physical and microscopic examination of the recovered evidence against the test specimens it is my opinion that:

A/The six (6) .45 Auto caliber discharged cartridge casings mentioned in items 3-4, 3-5, 3-6, 3-7, 3-8 and 3-9 above, were all fired by item 3-1 .45 AUTO caliber Glock model 21 semi-automatic pistol serial number TPC469.

B/The four (4) .45 caliber copper jacketed lead spent projectiles mentioned in items 3-10, 5-1, 5-2 and 5-3 above, were all fired from item 3-1 .45 AUTO caliber Glock model 21 semi-automatic pistol serial number TPC469.

No further examination will be conducted unless requested.

On 04/21/16 at approximately 1700 hours, I was dispatched to the City of Everett for a police related shooting. At approximately 1738 hours, I arrived at the intersection of Broadway and Chelsea Street and met with the case officer, Trooper Mike Cashman of the MSP Middlesex SPDU.

Trooper Cashman requested that I document the scene and record any evidence as required. I documented the scene with appropriate digital photography. Trooper Rob Quigley documented the scene with digital video. I also made a diagram of the scene. These items were forwarded to the appropriate personnel.
