The following report is submitted by: SGT. SCOTT STALLBAUM

ABOUT 1635HRS I WAS NOTIFIED BY DET LAVEY OF AN OFFICER INVOLVED SHOOTING IN EVERETT SQ.

I IMMEDIATELY RESPONDED TO EVERETT SQ AND WAS INFORMED THAT AN HISPANIC MALE ATTEMPTED TO STAB AN OFFICER WITH A KNIFE AND HAD BEEN SHOT BY THE OFFICER. I LEARNED THAT THE HISPANIC MALE HAD BEEN TRANSPORTED TO MGH AND THAT THE OFFICER WAS TAKEN TO THE WHIDDEN HOSPITAL. I INSURED THAT THE SCENE WAS SECURE AND INSTRUCTED OFFICERS AND INVESTIGATOR TO LOCATE AND INTERVIEW POTENTIAL WITNESSES. I THEN CONTACTED THE STATE POLICE DETECTIVES ASSIGNED TO THE MIDDLESEX DISTRICT ATTORNEY'S OFFICE TO RESPONDED AS THE HISPANIC MALE WAS NOT EXPECTED TO SURVIVE.

I LEARNED THE THAT AT APPROXIMATELY 1702 HRS THE HISPANIC MALE, LATER IDENTIFIED AS MARIO MEJIA-MARTINEZ WAS PRONOUNCED DEAD.

THE STATE POLICE DETECTIVES, CRIME SCENE SERVICES, AS WELL AS, ADA ADRIENNE LYNCH ALL RESPONDED TO THE SCENE FOR THE INVESTIGATION.
