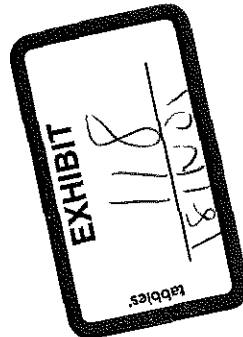

On Friday, September 1, 2017 at approximately 6:40 pm, while assigned to marked cruiser 929, I, Ptl. Lannan, along with Ptl. Spinosa (924) and Sgt. Limoncelli (923) respond to 41 Highland Avenue (Winchester Hospital Emergency Room) for a disturbance involving a male patient.

Upon my arrival, I observed several nursing staff and hospital security employees escorting a tall, skinny male into a hospital room. I later identified the male as Alan Greenough. Nurse Practitioner, Dermont Lahey, advised me that Greenough arrived moments ago via a Reading Ambulance. NP Lahey stated the reason Greenough was transported was because he had a seizure after an alcohol binge. NP Lahey stated Greenough was allowed to use the bathroom and when he tried to run from hospital staff, they stopped him from leaving for his own safety and the safety of others. North Reading Patrolman, Michael LaBlanc, was at the hospital (not involved with Greenough) at the time and helped the hospital staff.

I then attempted to speak with Greenough. During my entire conversation, Greenough was a belligerent drunk; constantly swearing, extremely loud and yelling, asking, "Why the fuck am I here," and, "Who the fuck am I," etc. After approximately 10 minutes and 3-4 warnings later by hospital staff members, Greenough calmed and stated he would cooperate. The nursing staff, security staff, and I escorted Greenough to the X-ray room to get a CAT scan. Security staff stated that my presence was no longer necessary and thanked me for my time.

As I was clearing, members of the nursing staff ran out and said my presence was needed again and Greenough is not cooperating. I radioed Sgt. Limoncelli and advised him I am returning to the emergency room. Once inside, NP Lahey stated Greenough's CAT scan was normal and he was discharged (I have attached it to this report). I advised Greenough that I would be placing him into protective custody for his own safety. Greenough tried to run away from us all again, so myself and hospital security prevented him from leaving for his safety and the safety of others. I handcuffed (DL), searched, and escorted Greenough to my cruiser. Once outside, Greenough started to become very uncooperative again, refusing to get into the back of the cruiser, but we eventually placed him in the cruiser. I transported Greenough to the Winchester Police Department with Sgt. Limoncelli following.

Once at the station, Greenough became extremely belligerent and aggressive, telling myself, Sgt. Limoncelli, and Sgt. Filtzer (OIC) to go fuck ourselves and, "I'm gonna sue you." Greenough was too belligerent to be booked, not allowing me to remove his handcuffs, trying to run away from us, and kicking at us with his feet. We placed Greenough in a temporary holding cell in order to calm himself. Greenough continued, for approximately 10 minutes, to yell and scream profanity, and Sgt. Filtzer observed him kicking and headbutting the walls and the door and flailing around. Finally, Sgt. Filtzer was able to calm Greenough down enough to be booked. Greenough had a large, swelling bump on his left forehead from banging his head on the wall that was not there prior to being placed in the temporary holding cell. We asked Greenough if he wanted to have the bump on his head looked at by EMT's and he refused. Sgt. Filtzer booked Greenough after a long process of Greenough continually cursing at us, saying wait until he calls his lawyer, he has police officer friends, and told Sgt. Limoncelli that he can't wait to see him on the outside when he's not in his police uniform. Greenough attempted to call someone and arrange a pick-up but no one would respond to the station initially. Sgt. Filtzer and I placed Greenough in holding cell #2.

While I wrote this report, approximately 25-30 minutes, Greenough continually kicked the cell door, saying he will do it all night unless someone listens to him. In addition, Sgt. Limoncelli observed Greenough shoving toilet paper rolls down the toilet of his cell.

Greenough was released at approx 2135 hrs to his friend, James Burke of Andover, MA (DOB [REDACTED]-64). While being released, Greenough continued to swear and yell profanities at all officers he saw. After he was released Greenough began calling our department over and over, yelling threats and profanities over the phone.
