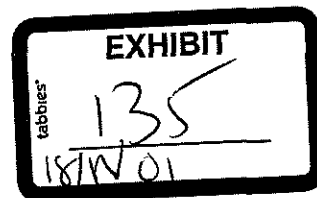

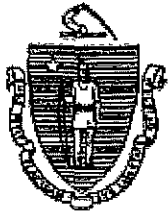

SUBJECT: Phone interview of Alexander Holguin

1. On June 17th, 2019, at approximately 1930 hours, Detective Lieutenant Paul Bulman and I went to [REDACTED] in the city of Methuen. Through the course of our investigation, we learned that the address may be the home of Alexander Holguin, whom we knew to be an associate of Alan Greenough through a cell phone "dump" of Alan Greenough's phone. In January of 2018, Holguin was listed in Greenough's phone as "Alex" and had an associated phone number of [REDACTED]. At the aforementioned address, we were met by a woman identifying herself as Holguin's niece and subsequently spoke with Holguin's sister, who put me in touch with Holguin on the phone. Holguin explained that he was currently living in New York and provided us with his new cell phone number, [REDACTED]. After leaving the home, we conducted a phone interview with Holguin and learned the following,

a) Holguin previously lived near the East Coast Gas station. In the Spring of 2017, he met Alan Greenough at the East Coast Gas station. He said that he had received gas and had forgotten his wallet. Greenough, who was working at the gas station at the time, assisted him. After that, they stayed in touch and hung out once or twice a month until Greenough's death. Holguin said

that he moved to Lawrence, but would still come to visit Greenough. He noted that he also knew Greenough's brother and roommate. Holguin did not know their names. Holguin also said that he had a mutual friend in Kurt Roth.

b) When asked, Holguin said that Greenough drank alcohol and he knew that he would use illegal drugs. Specifically, he knew Greenough to use heroin, crack and Klonopin. However, he did say that he had never seen Greenough drunk or high. Greenough told him once that he took methadone to assist his drug addiction. He said that Greenough would sometime ask him for drugs. If Holguin did not provide him with drugs, Greenough would get angry and text him aggressively. (In text messages from 1/28/18, it appeared that Holguin had drugs and was attempting to sell to Greenough or have Greenough broker a deal to another buyer). Holguin said that he had come upon "crack" and was trying to off load it. He did not say whether he had sold Greenough crack and denied having sold drugs ever. Holguin said that Greenough's brother once told him that he could continue to visit Greenough, but told him specifically not to bring his brother drugs. When asked, he said that Greenough's brother thought that he was bringing Greenough drugs because he was coming from Lawrence and for no other reason.

c) Holguin described Greenough as a generally quiet guy, but knew that he would sometimes get out of control. He said that in the Summer of 2017, Greenough told him that he and his roommate had been drinking and things "got out of control", but he could not elaborate on specifics.

d) When asked, Holguin said that he hadn't seen Greenough for about a month before he was killed. He said that he learned that Greenough was killed from the news. He said that he had not spoken with anyone else about the incident, but had gone to the East Coast Gas and given condolences to Greenough's brother.

2. Holguin said that he is working in New York and will likely be in Massachusetts in July of 2019 and would make himself available to us for further questions.
