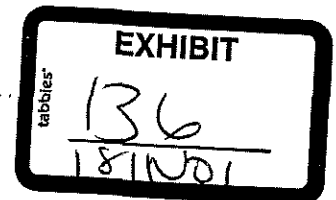

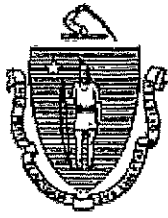

SUBJECT: Phone interview of Kurt Roth

1. On June 18th, 2019, at approximately 1130 hours, Assistant District Attorney Adrienne Lynch, Detective Lieutenant Paul Bulman and I spoke with Kurt Roth on the phone. Through the course of our investigation, we learned that Roth was a friend of Alan Greenough and that they had spoken several times via text and phone calls in the days and hours preceding Greenough's death. Roth provided us with the following;

a) Greenough and Devin McDonald went to high school with Roth. Roth said that he was closer with Greenough and they had been friends since the 1990's. Roth knew Alan to be a landscaper by trade, but noted that he believed him to be working at a Mobil gas station after he lost his driver's license. In the beginning of 2018, Roth said that he was living with a friend in Hampton, New Hampshire, after he was separated from his wife. Roth said that he has battled with addiction and has been clean of drugs since February 27th, 2018. He noted that, prior to that time, he had begun his attempt to rid himself of drugs.

b) In December of 2017, there are texts from Roth to Greenough asking for "Val", "blue round". Roth said that he was asking for Valium to aid him in his sobriety. On or about January 23, 2018, Roth contacted Greenough looking for "Beens". Roth said that "Beens" was in reference to benzodiazepines. The conversation continued for several days by text and phone call. On January 30th, 2018, Greenough tells Roth that he has "25 kpins". Roth said that "kpins" are Klonopins. That conversation goes on until Febraury 1st, 2018, when Greenough texts Roth "those

pins are in". After more conversation, Roth tells Greenough that is coming on February 2nd, 2018, at approximately 1545 hours. At this time there are several phone calls (some probably missed calls) between Greenough and Roth. Roth said that he got a couple of Klonopins from Greenough and, at that time, he seemed to be ok. He said that Greenough did seem drunk or high. He knew Greenough to drink alcohol during hard times. Roth also noted that he knew Greenough to use benzodiazepines and Soma. He said that Greenough was with "Amy" and he knew that he had gone to his friend's wake that day. Roth said that he did not stay long and spoke with Alan again on the morning of February 3rd, 2018. Roth said that he was not feeling well and Greenough had called to check on him. Roth also recalled that Greenough told him that "Alex" had come to visit him after he had left on February 2nd, 2018. Roth did not know Alex' last name, but described him as "foreign looking, from Lawrence". We believe him to be described Alex Holguin. He said that he knew Greenough's brother, Anthony Perrotti, was angry because he believed Alex was delivering him drugs.

c) When asked about Greenough's drinking, Roth said that Greenough was "not the happiest drunk". He added that Greenough "didn't really listen" and "can be really mouthy" when he is drunk. When asked, Roth also said that Greenough did not have a good relationship with the police. He recalled Greenough telling him about a specific time that he had a confrontation with the police, but he did not remember any specifics about the story.
