1462 Main Street, Reading Examination

One thousand four hundred sixty two Main Street was an apartment attached to the right side of East Coast Gas Auto Repair. Gas pumps were noted in front of the business. A parking lot with many cars was noted to the left of the business. Some of the cars in the parking lot included a black Kia Sedona that was facing the street, a dark gray Mazda Tribute that was facing the street, a gray VW Passat that was facing the back of the parking lot, and a dark orange Hummer that was behind the Mazda and the VW that was also facing the back of the parking lot. There were no license plates on these vehicles. Emergency Medical Technician debris and two discharged cartridge casings were noted in the area of these four vehicles. Red-brown stains were noted on the passenger side quarter panel of the Hummer, on the passenger side quarter panel of the Mazda, and on the interior front passenger side door of the Hummer. A screening test for the presence of blood was positive on these stains. White apparent fibers with red-brown stains were noted on the interior front passenger side door of the Hummer. A screening test for the presence of blood was negative on these red-brown stains. Red-brown stains were also noted on the step under the rear passenger side door of the Hummer.
