## AFFIDAVIT OF ERIK E. WANG, M.D.

I, Erik E. Wang, M.D., on oath, depose and say the following, based on my own personal knowledge, information and belief:

- I am a medical doctor licensed to practice medicine in the Commonwealth of Massachusetts. I am a graduate of Vanderbilt University School of Medicine. I am board certified in the field of Emergency Medicine. I am a member of the Department of Emergency Medicine at the Lahey Hospital and Medical Center at 41 Mall Road, Burlington, MA.
- 2. On February 3, 2018, I was the attending physician on duty in the Department of Emergency Medicine at Lahey Hospital and Medical Center and assumed care and treatment of Alan Greenough, date of birth: 74, when he was transported to the Lahey Hospital and Medical Center by paramedics. Mr. Greenough had gunshot wounds of the chest and was pronounced at the hospital that day.

During the course of Mr. Greenough's treatment at the hospital that day, he was not administered fentanyl or any drugs or medications, which is reflected in his medical record number 5481718. Although the records reflect that an anesthesiologist, Dr. Kaufman, was present at bedside, no anesthesia was administered to the patient.


