
## Sean Killilea,



Below is a summary of the interview statement made by Fire Fighter Sean Killilea at approximately 2:50pm on 01/23/2022.

Killilea advised that he was assigned to drive the ambulance (A1) that day. The call came in over the dispatch intercom to respond to a male party barricaded in his apartment with a knife. He believed the address given was building 1, apartment number 22. They were advised that police requested they stage in the area of the apartment building and respond if needed. He added that this is common practice for calls of this nature. They would usually wait until police made the scene safe, and transport the patient if needed due to a section 12 or for an evaluation. The fire engine took a left onto Terrace Hall Ave to head to the apartment complex via Middlesex Turnpike Extension, and they (the ambulance) took a right out of the station to enter the complex via the Terrace Hall Avenue end.


Upon entering the area, he staged just past the playground on Barron Park Lane. Killilea stated that as he staged he could see some commotion and people running around, but he did not hear anything. Seconds later, the Lieutenant (Lt. Todd Ficociello) called them to the scene stating "A1 get down here, shots fired." They immediately pulled up to the scene and saw a male party faced down, handcuffed behind his back. He was immediately rolled over, and he observed the patient was bleeding from the head/neck area. They were told by the officer (Officer Reyes) that the patient had been shot in the eye. At this time, he immediately retrieved the trauma kit and applied wound dressings to the eye. As he was doing this, Fire Fighter Taylor Falconer cut

off the patient's shirt and applied AED pads so they would be ready in the event the patient "coded." He remembered Falconer had to apply two sets of the pads, as the patient's chest hair prevented the first set of pads from sticking properly. He observed that the patient still appeared to be breathing, but was unresponsive. The AED advised that motion was detected, and suggested administering CPR. CPR was started for less than a minute as they prepped the patient for transport. He was then placed on the stretcher and moved to the back of the ambulance.

Killilea drove the ambulance to the Lahey Clinic ER, with Falconer and Fire Fighter Kurt Dupres riding in the back with the patient. While en route Killilea called Lahey to notify them of the patient transport and the extent of his injuries (which is standard for any patient transport). He stated by the time they arrived at the hospital, the hospital staff had a trauma room designated for the patient, with staff already there ready for him. They took him directly to the trauma room and passed him off to the doctors and nurses. At this time Killilea updated one of the Doctors in the room as to what they had and completed their transfer of care.

While still at the hospital, A2 (the ALS ambulance out of Station 1) was dispatched back to the scene to transport the two involved officers to Lahey Clinic. A2 was also at the hospital after transporting another patient from a different call. Upon speaking to the Fire Fighters assigned to A2 it was determined that the transport of the officers would not require ALS assistance. Therefore, Killilea and Falconer returned to the scene to transport the officers to the Lahey ER as well.

## Tyler Falconer



Below is a summary of the interview statement made by Fire Fighter Sean Killilea at approximately 3:10pm on 01/23/2022.

According to Falconer, he was assigned to the ambulance along with Fire Fighter Killilea (who was driving the ambulance). They were dispatched to Lord Barron apartment building 1 for a male party with a knife. They were requested to stand by in the area, while police made the scene safe. They responded via the Terrace Hall Ave end and staged approximately 75 yards away from building 1. Just as they had pulled up to their staging area Falconer saw Engine 2 arrive from the Middlesex Turnpike Extension end (with building 1 to their left). As the Engine was pulling up to the building, Falconer also saw what looked like commotion, and people falling. He stated he believed he saw what he thought was the female officer falling, and then "the guy" falling right after. He could not hear anything due to the ambulance running. Seconds later the Lieutenant got on the radio and stated "Shots fired. A2 stand down."

Shortly after he and Killilea observed Officer Reyes waving them down, at which point they responded, pulling right up to the scene. As they pulled up he observed Officer Reyes handcuffing the suspect behind his back, and "Aurise" walking away. He stated it appeared Aurise was in shock. As they approached the patient they were advised that he had been shot in the eyeball, and he saw what he believed to be an exit wound at the back of his head with brain matter on the ground. At this time Killilea retrieved the Trauma bag as Falconer prepped oxygen and the AED. Falconer then cut the patient's shirt off and applied the pads for the AED. He had to rip off the first set of pads due to the patient's chest hair not allowing them to stick properly. He shaved the areas of the patient where the pads would be attached before applying the second set of pads. The AED analyzed the patient and advised that motion was detected, and to begin CPR. CRP was started as they placed the patient on the backboard and stretcher to prep him for transport. Before they placed him on the backboard, Lt. Hanafin un-cuffed the patient from behind and back and re-cuffed him in the front. Falconer also prepped the bag valve mask to have on stand-by for breaths if needed.

Falconer advised that after getting the patient in the ambulance for transport to the Lahey ER, Killilea drove as he and Fire Fighter Dupres rode in the back with the patient. While en route to the hospital the two of them continued with hemorrhage treatment to the wound site to try to control the bleeding the best they could. Upon arrival to the ER, they brought the patient to the trauma room to hand him off to the hospital staff. Falconer stated he believed there were approximately 20 staff memebers (between doctors and nurses) waiting for their arrival. Before exiting the trauma room, they give their report to the doctor. They then began restocking the ambulance when they got the call to return to Lord Baron to transport the involved officers to the Lahey ER as well. Falconer noted that during the transport, neither patient appeared to be critically injured, however, Aurise was very upset.
