On November 12, 2012, Sergeant Robert Manning of the Massachusetts State Police Middlesex County Detective Unit requested technical assistance in connection with the above subject Chemist Timothy Woods and I, Chemist Kelley L. King, responded, reporting to 52 Meadowbrook Road in Marlborough at approximately 11.30 p.m. where we met with the following personnel among others:

Fifty-two Meadow Brook Road consisted of a white, single family residence. Upon our arrival, we were directed to the second floor of the residence where two bedrooms were located. A discharged cartridge casing was observed on the landing at the top of the stairs ascending from the first floor. Another discharged cartridge casing was observed on the floor in the doorway of a bedroom located to the left of these stairs.

This bedroom contained an unmade bed, two dressers (one with a television on top of it), and a desk with a chair. A closet and a storage area were also noted within this bedroom. This bedroom had a cluttered and dirty appearance, with trash, clothing and other miscellaneous items noted on one side of the room and on the furniture. The body of an adult male, identified to us as Bryce Coutinho, was observed laying on the floor in the supine position, with one arm on his chest, the other by his side, and the right leg crossed under the left leg. His head was in the direction of the head of the bed, facing away from the door. The body was adorned in

a pair of jeans, black boots and a blue T-shirt. Red-brown stains were noted on the T-shirt and jeans. A red-brown stain, consistent with a saturation stain, was observed on the floor, at the foot of the bed and adjacent to the feet of Mr. Coutinho. A screening test for the presence of blood was positive on this stain. Red-brown stains were also noted on the mattress at the foot of the bed, next to the body. A kitchen knife, with a silver colored blade and a black handle, was noted on the floor, next to the red-brown saturation stain.

DEFINITIONS

The following terms relating to bloodstain pattern analysis were used throughout this report (SWGSTAIN Terminology 2009):

Bloodstain: A deposit of blood on a surface.


Saturation Stain: A bloodstain resulting from the accumulation of liquid blood in an absorbent material.
