1. On Sunday, January 23, 2022, members of the Middlesex-SPDU spoke with Mohammed Khan at his apartment in the Lord Baron Apartment complex. Mohammed lives with his wife and eight month old son in the apartment directly above Paul Courtemanche. Investigators were told that the two men recently had a negative interaction with one another. Present for the interview were myself, Trooper Mark Delaney, and Trooper Francis Torres.

2. On the morning of January 23rd, at around 0930 hours, Courtemanche knocked on Mohammed's apartment door. Courtemanche complained to Mohammed that he was making too much noise, and it was loud in Courtemanche's apartment. Mohammed acknowledged that his son had been tapping his heel on the ground, but he did not think it was excessively loud. Mohammed believed that Courtemanche was under the influence of something because he was not talking properly. Courtemanche had come to Mohammed's apartment carrying a white blanket, and he left Mohammed after their brief interaction. This was the only time that Courtemanche had complained to Mohammed that his family was making too much noise. Mohammed did not hear or see anything regarding the shooting.
