1. On Thursday June 25, 2020 at approximately 1230 hours this officer along with Captain Paul Bulman, Lieutenant William Donoghue, Lieutenant Bruce O'Rourke, Trooper Michael Sullivan and Trooper Scott Quigley responded to 13 Tarbell Street in Pepperell for a report of an officer involved shooting at that address. Upon arrival I met with Pepperell Police Chief David Scott who was standing on the porch of the residence. I observed 13 Tarbell to be a single family home with a porch leading to an entrance.

2. Chief Scott informed me that one two of his police officers had responded to that residence to take a subject identified as Christopher J. Shuttle (DOB [REDACTED]/1989) into custody as there was a warrant for apprehension issued for him out of Ayer District Court relating to a Section 12 three day commitment for mental illness (Docket #2048MH0092). I learned that during the officers attempt to apprehend Shuttle, that Shuttle attacked one of the officers with a knife and another officer fired at least one round from his service weapon. I learned the two involved Pepperell Police officers' identities to be Sergeant Nick Parker and Officer Justin Zink. I was informed by Chief Scott that both officers were currently being treated at Nashoba Hospital with non-life threatening injuries and that Shuttle had been transported to Lowell General Hospital with a gunshot wound to the torso and then Med Flighted to Brigham and Women's Hospital in Boston. I learned that both Parker and Zink carried the same type of duty weapon which is a Glock Model 21 .45 caliber handgun. Upon speaking with Chief Scott I learned that the residence was secured pending a

search warrant. I then made arrangements with Chief Scott to meet him at the Pepperell Police station where I planned to write an affidavit in support of a search warrant for 13 Tarbell Street.

3. Once at the Pepperell Police station I authored a search warrant affidavit for 13 Tarbell Street. Once completed Ayer District Court Clerk Magistrate Damien Riddle arrived at the police station and signed the search warrant. The search warrant was then executed (See report #2020-110-377/3).

4. Several interviews were conducted in relation to this investigation and will be documented in additional reports. The investigation is active and ongoing and more reports will follow this case initiation report as warranted.

1. On Thursday June 25, 2020 at approximately 1310 hours, Detective John Coburn and I conducted an interview of [REDACTED] Shuttle in furtherance of the investigation into the Police Officer involved shooting of Christopher Shuttle. This interview was conducted on the back porch of Mrs. Shuttle's home at 13 Tarbell St.
2. I started the interview by apologizing to Mrs. Shuttle for having to go through this and informing her of the recent update that I had received regarding Christopher's medical status. Mrs. Shuttle thanked me for the update and stated, "There is nothing to apologize for." Mrs. Shuttle informed me that she holds no ill will towards the Pepperell Police because they have done everything they possibly could to help her, and to try and get her son Christopher the mental health help he needs.
3. I asked Mrs. Shuttle to provide a little background on her son Christopher and what may have led to this incident. Mrs. Shuttle advised that her son has been battling mental health issues for an extremely long time. Mrs. Shuttle advised us that Christopher was

diagnosed as having Bipolar Disorder and Schizophrenia. He has been in and out of mental health hospitals monthly for the past several years and she could not find a hospital in order to keep him for an extended stay. Mrs. Shuttle advised that he was recently released from a mental health facility approximately 3 weeks ago. Since his release Mrs. Shuttle noted that his Schizophrenia appeared to be getting worse over the past several days. Mrs. Shuttle advised that she would come downstairs on some days and Chris would be having conversations with imaginary people and not even realize she was in the room. She recalled recently that Chris believed he was a Spartan Warrior ready to carry out biblical missions.

4. I asked Mrs. Shuttle if anything had changed in Christopher's schedule or medication recently and she advised that the medicine he was taking for the Schizophrenia was making him feel ill and his Doctor prescribed him a new medication called [REDACTED]. Mrs. Shuttle advised that Christopher took the medication for the first time last night.
5. I asked Mrs. Shuttle if there was anyone else that helped out with Christopher's daily care and well-being. She informed me that she pays a nurse to come to her house every Tuesday in order to give Chris his medicine while she is at work. Mrs. Shuttle informed me that he was ordered by the court to contact his Probation Officer Jeff Phelps, on a daily basis via a telephone call. Mrs. Shuttle then advised me that Jeff Phelps had reached out to her last night via a phone call. Mrs. Shuttle stated that Jeff was concerned about Christopher's mental status the past couple days and Mrs. Shuttle agreed with his assessment. Mrs. Shuttle informed me that she told Jeff Phelps she believed he was fully manic and showing signs of the behaviors that have led to issues in the past.
6. I asked Mrs. Shuttle if she could take me through the events today starting from when she first woke up. Mrs. Shuttle advised that she woke up at approximately 6:45 A.M. and came downstairs. Chris was already awake and when she asked him if he actually slept last night, Chris stated that he did, and that he got up at 5:00 A.M. Mrs. Shuttle advised when he's having these schizophrenic episodes he will go nights without sleep. Mrs. Shuttle provided Chris his medication which she stated that he did take. Mrs. Shuttle did advise either the Nurse or her are responsible for providing the meds so that Chris will not overmedicate. Mrs. Shuttle states Chris has had [REDACTED] in the past. Mrs. Shuttle then made her coffee and went upstairs to log onto her computers and start work. When Mrs. Shuttle finished a work meeting on her computer she got up and looked out the window and saw the front of a Pepperell Police Cruiser. Mrs. Shuttle advised that Chris has a history of calling the Police and requesting to speak to the FBI or the President and assumed that was the case with this instance as well.
7. Mrs. Shuttle walked downstairs where she encountered Chris at the bottom of the stairwell. She told Chris to open the door for the Police and according to her, Chris stated, "No do not let them in, or there will be a fight." Mrs. Shuttle informed us that she moved Chris out of the way and made her way to the door. She advised that she opened the door, saw the two Officers standing there and as they entered Chris attempted to slam the door shut on them. Mrs. Shuttle advised that the Officers were calmly talking to Chris and were stating "Chris we need to talk to you." I asked Mrs. Shuttle if she could describe the two Officer's demeanor. Mrs. Shuttle advised that they were very calm, and just trying to talk to Chris so they could get in the door. Mrs.

Shuttle advised that the Officers were not aggressive in any way even after they entered the house.

8. I asked Mrs. Shuttle what she did next and she advised that Chris had let go of the door and quickly walked/ran into the living room. She let the two Officers in, gathered her two dogs and started walking out towards the back porch. The last thing Mrs. Shuttle saw before exiting the house was the Officers just entering the dining room and Chris coming towards them from the living room. Mrs. Shuttle did not notice if Chris had any weapons and did not see any Officers with their guns drawn. Before Mrs. Shuttle even made it to the back door she immediately heard things banging around and loud thuds and assumed that Chris was trying to fight the Police again. Mrs. Shuttle stated that she never even heard a gunshot or anything that was said by either Chris or the Police after she left the house. She heard the other Sirens coming and saw the ambulance pull up from her side yard. She assumed they were just taking Chris to the Mental Health Hospital and never realized the seriousness of the incident until another Officer came out back and spoke with her.
9. I asked Mrs. Shuttle if she saw Christopher grab any type of knife or sharp object from the kitchen before he went to the living room and she said absolutely not, that he ran right from the door into the living room. I asked Mrs. Shuttle if it was possible that a knife was left in that side of the house for any reason and she stated, "Yes, I use a knife to open up packages that are delivered to the house, and I may have left it on the dining room table area." It should be noted that during the service of the Search Warrant Mrs. Shuttle was very concerned over what damage was done to her house and kept asking to see the area. After initial photographs and video were taken of the scene, I let Mrs. Shuttle look at the room from the kitchen area. A knife was visible on the floor and I asked her if she recognized that knife. Mrs. Shuttle immediately stated "Yes" told me the name brand of the knife, then advised that it was one of her kitchen knives. Mrs. Shuttle states that knife would definitely be the one she was opening packages with and likely left it on the table from the day before.
10. Mrs. Shuttle was very calm and collected throughout the entire interview. She again thanked the Pepperrell Police for all the times that they have attempted to get Chris into a Mental Health Facility. Mrs. Shuttle advised that she is scared of Chris and does not sleep well at night because she never knows what he will do during one of his episodes. Mrs. Shuttle was begging for Christopher to be placed into a long term facility that can help him with his issues. Mrs. Shuttle states that she no longer wants Christopher at the house, however if he were to be released she would take him back solely for the reason if he was on the street, she fears he would kill someone.
11. Mrs. Shuttle did sign a consent to search form for her home however a search warrant for the home was obtained. I have attached the consent to search form that Mrs. Shuttle signed to this report.

SUBJECT: INTERVIEW OF CHRISTOPHER SHUTTLE

1. On Thursday June 25, 2020 at approximately 1315 hrs I responded to Brigham and Women's Hospital in Boston where Christopher Shuttle had been transported via Med Flight from Lowell General. I spoke with nurses Kaitlyn Harrington, Kate Maccune and Surgeon Dr. Adam Field. They advised that Shuttle has a gunshot wound on the right side of his back. They stated that it appears the projectile entered the right side is currently lodged in the left side of his back. They explained to me that it appears he has a broken rib, bruised lung and is expected to survive. At this time he did not undergo surgery and was transported to the ICU for observation. Pepperell Sgt. Maskalenko and I attempted to speak with him and after reading his Miranda Rights he refused to speak with us. He signed a Miranda Form indicating his refusal. He was irate while trying to advise him of his rights. This was also audio recorded, see recording.
