Lieutenant in Fire Engine 2

- 1. On Sunday, January 23, 2022, at 3:00 p.m. I, Trooper Francis Torres, along with Burlington Police Detective James Hanafin, conducted an interview with Lieutenant (Todd Ficociello 1970) at Burlington fire house 2. Ficociello stated the following statements to be factual:
- 2. On Sunday, January 23, 2022, he was dispatched to 1 Baron Park Lane in Burlington for the report of a male with a knife. While in route, Lt. Ficociello learned the call was regarding a suicidal male. Lt. Ficociello was on board fire engine 2 and arrived on scene, stopping in front of 1 Baron Park Lane.
- 3. Lt. Ficociello observed a male running, wearing a white blanket, with one arm up. The male was running away from the fire truck towards a female Police Officer. Lt. Ficociello observed the female officer backing up and yelling. Lt. Ficociello could not hear what was said due to the loud noise inside the fire truck. As the officer kept backing up, the male rapidly approached her with one arm up. Lt. Ficociello heard two gunshots. At this time, Lt. Ficociello believed the officer was shot, as she was in such close proximity to the subject that she fell to the ground and he almost fell on top of her. The officer waited to the last possible second to shoot. Ambulance 2 drove to the scene to assist and provided life saving measures to the male on the ground, and transported him to Lahey Hospital. Back-up Burlington Police officers arrived and secured the scene.
