1. [REDACTED] On Monday, November 12, 2012 I contacted by phone [REDACTED] and [REDACTED] Coutinho of [REDACTED], Marlborough, Ma and confirmed they were the parents of

Bryce A. Coutinho

I along with Sergeant Steve Lupien of the Marlborough Police Department responded to the above residence at [REDACTED], Marlborough. It was approximately 11:00 to 11:30pm in the evening. The Coutinho's met us outside of their residence in the driveway. They did not want to speak inside of the house. I made an official notification to them that their son Bryce had died in a shooting incident that occurred on this same date at approximately 8:00pm at a residence at 52 Meadowbrook Road, Marlborough, Ma. I also informed them that the shooting incident occurred as a result of a Marlborough Police Officer using lethal force and shooting their son.

2. The Coutinho's were upset but very polite. They asked if anyone else was hurt during the incident and were told no. I informed them that the State Police Middlesex Detective Unit along with the Middlesex District Attorney's Office with the assistance of the Marlborough Police Department was investigating the incident at 52 Meadowbrook Road. I provided them with some preliminary information that I was aware of concerning the incident that led to the shooting death of their son. I provided them with information concerning the medical exam and I gave them contact information to start the process of personal arrangements.



3. I did ask the Coutinho's if they would talk to me about any information they had regarding speaking with their son Bryce today and if they could provide me with any information about their son's history. [REDACTED] Coutinho told me that they did speak to Bryce to day at about 6:30pm. She said Bryce called them by phone and told them he had no place to go. She said that he seemed distraught and upset. She stated that she thinks he called them from the Jaworck School but was not positive. I tried to ask them some follow up questions but [REDACTED] did not want to provide any more details or information to me. She did tell me that she was aware of some recent arrest or warrant issued Bryce had. She also informed me that they adopted Bryce at age 3 and that he had issues. Again I tried to gather some more information but they did not want to provide any additional information to me. [REDACTED] did tell me that they tried very hard to get him some help. I left my contact information with them and the meeting ended.
