## Ofc. Sullivan Recorded Interview

1 DELUCIA: Alright so it's uh Monday February 14th, 2022, it is 15:33 2hours um, and it's Sean, Sullivan? 3 SULLIVAN: Yep, correct. DELUCIA: I'm gonna read you your Miranda rights Sean okay? 4 SULLIVAN: Okay. 5 6 DELUCIA: Uh before asking you any questions it is my duty to advise 7 you of your rights. You have the right to remain silent, if you choose to speak 8 anything you say may be against- may be used against you in a court of law. You 9 have the right to consult with a lawyer before answering any questions and you 10 may have a lawyer with you during questioning. If you cannot afford a lawyer or 11 want one, a lawyer will be provided at no cost before any questioning. If you 12 decide to answer questions you may stop at any time. Do you understand each of these rights I have read to you? 13 14 SULLIVAN: Yes. 15 DELUCIA: Okay so there's a yes, no, and initials. So. 16 SULLIVAN: Check it off? 17 DELUCIA: Yep. And then having these rights in mind, do you wish to speak with me now? 18 SULLIVAN: Yes. 19 DELUCIA: Okay and then initials. And then it's just gonna have the Se-20 21oh, excuse me, sign and then we'll have the Sarge be the witness for it. Thanks. 22 HAGENAH: Yep.

- DELUCIA: Uh, so again it's Monday February 14th, 2022, 15:34 hours,
- 2 my name is Anthony Delucia, I'm a Sergeant with the Massachusetts State
- 3 Police I work out of the Middlesex DA's office. So Sarge if you could introduce
- 4 yourself please?
- 5 HAGENAH: Sergeant Alex Hagenah.
- 6 SULLIVAN: Sean Sulli-
- 7 DELUCIA: Yep go ahead.
- 8 SULLIVAN: Sean Sullivan, Lexington Police, Patrol.
- 9 MCDONALD: Alan McDonald, counsel to the Lexington Police
- 10 Association.
- DELUCIA: Alright great. So, um, Sean, uh how long have you been a
- 12 police officer?
- 13 SULLIVAN: A little over 3 years.
- DELUCIA: All with Lexington PD?
- 15 SULLIVAN: Yes.
- DELUCIA: Had you worked prior, anywhere prior to that in law
- 17 enforcement?
- 18 SULLIVAN: I have not no.
- DELUCIA: Did you have a prior career or different job?
- 20 SULLIVAN: Yeah I worked at a special needs program in Burlington.
- DELUCIA: Okay, and, and what age would that have been? The people
- 22 you were working with.
- 23 SULLIVAN: Uhh... so it was 14 to 22.

- DELUCIA: Okay um what type of facility was that? Was it a lockdown
- 2 facility, or?
- 3 SULLIVAN: Uh, no, it was at uh Burlington High.
- 4 DELUCIA: Oh okay it was affiliated with the high school?
- 5 SULLIVAN: So it was a lab program-
- 6 DELUCIA: Okay.
- 7 SULLIVAN: But I worked at Burlington High School.
- 8 DELUCIA: Okay.
- 9 SULLIVAN: So it's Lexington, Arlington, Bedford, Burlington, Belmont.
- DELUCIA: Okay. And what, so what would your title have been when
- 11 you did that?
- 12 SULLIVAN: A teacher assistant.
- DELUCIA: You were a teacher's assistant, okay.
- 14 SULLIVAN: Correct.
- DELUCIA: And did you go to school for that? Or did you just fall into
- 16 that?
- 17 SULLIVAN: Uh, I kinda just fell into it.
- DELUCIA: Okay. And how long did you do that for?
- 19 SULLIVAN: Oof.. uh, either 5 or 6 years.
- DELUCIA: Okay. How, how was that job?
- SULLIVAN: Uh, I loved the kids but just wasn't uh, it wasn't enough
- 22 money in it.

- DELUCIA: Yeah, it's hard work for sure. Um, so in terms of your training
- 2 and experience with Lexington, do you have annual training that you have to
- 3 perform?
- 4 SULLIVAN: Yep. I attend in service every year.
- 5 DELUCIA: Okay. Is that, is that in person, is it online, is it a hybrid
- 6 thing, or?
- 7 SULLIVAN: This year it was all in person.
- 8 DELUCIA: All in person this year.
- 9 SULLIVAN: Yes.
- DELUCIA: Okay um, do you have any specialized training in terms of
- 11 um, if you guys use like less lethal and stuff like that, do you have you been
- trained in anything like that before?
- 13 SULLIVAN: Yeah, we've been trained in that in the, at the range. I
- haven't had like a, I'm not like a range officer or anything.
- DELUCIA: Are you certified to use that equipment?
- 16 SULLIVAN: I am yes.
- DELUCIA: You are. Okay. Alright. Is everybody in your department
- 18 certified to use that?
- 19 SULLIVAN: I believe everyone is yep.
- DELUCIA: Okay. I didn't know if it was a thing you volunteer for or um
- as a Lexington police officer they have you do it.
- 22 SULLIVAN: Uh,
- DELUCIA: Do you know the answer to that?
- SULLIVAN: I don't know, but I believe everyone has to-

- 1 DELUCIA: Okay.
- 2 SULLIVAN: –qualify with their whatever. Yeah.
- 3 DELUCIA: Okay. Um, what was your assignment on Saturday?
- 4 SULLIVAN: I was assigned to the 411 sector.
- 5 DELUCIA: Okay. And could you just describe for that, describe the place?
- 6 SULLIVAN: Uh, like a typical day so-
- 7 DELUCIA: What that sector is, excuse me. Like what part of town was
- 8 that.
- 9 SULLIVAN: Oh, um...
- DELUCIA: Is that how it's broken up?
- SULLIVAN: Yeah uh, ask me a question I don't know exactly how you
- want me to describe the...
- MCDONALD: Was it like the geographic area, or is it...
- SULLIVAN: Yeah I just don't know like, what street, Lowell street...
- DELUCIA: Yeah no we don't have to get into particulars, um.
- 16 SULLIVAN: Okay.
- 17 DELUCIA: You're in uniform patrol that day?
- 18 SULLIVAN: Correct. Yes.
- 19 DELUCIA: You're in a marked car?
- 20 SULLIVAN: Yes.
- DELUCIA: Okay. And you're covering a section of the town.
- 22 SULLIVAN: Correct.
- DELUCIA: Okay. Very good. I'm not, yeah. I'm not trying to be tricky.
- SULLIVAN: Yeah I just don't know exactly.

- DELUCIA: No I get you. I get you. Might have not been a fair question.
- 2 SULLIVAN: East Lexington, I guess?
- 3 DELUCIA: I get you. I know, it's really irrelevant its more-
- 4 SULLIVAN: Okay.
- 5 DELUCIA: What your assignment was that day.
- 6 SULLIVAN: Alright.
- 7 DELUCIA: Um, did you attend a roll call that day?
- 8 SULLIVAN: I did yes.
- 9 DELUCIA: Okay. And who, who leads roll call.
- 10 SULLIVAN: Uh, that day it was Sergeant Demambro.
- DELUCIA: Okay. Was there anything at roll call that was put out that
- was unusual or anything or was it just kind of a...
- 13 SULLIVAN: No it was just the usual like who has what sector.
- 14 DELUCIA: Okay.
- 15 SULLIVAN: Just do your thing.
- 16 DELUCIA: Okay.
- 17 SULLIVAN: (unintelligible) calls you.
- DELUCIA: Okay. And uh what were your hours worked on that day on
- 19 Saturday. When did you come in?
- 20 SULLIVAN: What were they supposed to be?
- DELUCIA: Yeah. Well when did you arrive for work?
- 22 SULLIVAN: Uh,
- DELUCIA: Start of your shift.
- 24 SULLIVAN: Started at 7:45.

- DELUCIA: Okay. Uh had you worked the prior night?
- 2 SULLIVAN: Uh no I was off.
- 3 DELUCIA: Okay. So you came in for 7:45 AM, is the beginning of your
- 4 shift?
- 5 SULLIVAN: Yep.
- 6 DELUCIA: You attend roll call?
- 7 SULLIVAN: I did yes.
- 8 DELUCIA: Okay. Um, when were you alerted to something going on at 98
- 9 Hancock?
- 10 SULLIVAN: Um, so I was actually on Heartwell Ave., across town, um,
- closer to where it happened. I heard the call come in, it was for, they were
- dispatching two cars I believe. Uh, Steve arrived, John arrived.
- DELUCIA: Do you remember what the call was?
- SULLIVAN: Uh, it was for a jogger running by claiming they heard
- someone, from, coming from the window saying someone was gonna kill them.
- 16 DELUCIA: Okay.
- 17 SULLIVAN: "I need help." Along those lines.
- DELUCIA: Okay. Are you familiar with that address?
- 19 SULLIVAN: I am, yes.
- DELUCIA: And have you been there before?
- 21 SULLIVAN: I have, yes.
- DELUCIA: Uh what have you been there for in the past?
- 23 SULLIVAN: Uh a lot of mental health-
- 24 DELUCIA: Okay.

- 1 SULLIVAN: -disturbances.
- 2 DELUCIA: Do you know, d- okay. Do you know who lives there?
- 3 SULLIVAN: Um, I know, is it Brendan or Brandon?
- 4 DELUCIA: Brandon.
- 5 SULLIVAN: Brandon, I remember there was a female with black hair I
- 6 don't know her name.
- 7 DELUCIA: Okay.
- 8 SULLIVAN: And I don't know the other person.
- 9 DELUCIA: So have you dealt with Brandon before?
- 10 SULLIVAN: I have. Yes.
- DELUCIA: And what was that interaction or experience like in the past?
- 12 SULLIVAN: Um, I mean obviously nothing like what occurred then, but
- it was usually pretty intense.
- 14 DELUCIA: Okay.
- 15 SULLIVAN: Um, appeared to have some mental illness.
- 16 DELUCIA: Okay.
- 17 SULLIVAN: Stuff like that.
- DELUCIA: Okay. Um, do you remember the last time was that you would
- 19 have had interactions with him?
- 20 SULLIVAN: Oh man, um...
- 21 MCDONALD: Approximate's fine.
- 22 SULLIVAN: Maybe like last November.
- 23 DELUCIA: Okay. So months-
- 24 SULLIVAN: Maybe then.

- 1 DELUCIA: Let's say months.
- 2 SULLIVAN: Months, yes.
- 3 DELUCIA: Okay. Alright. Um, so on that day, you heard that go out over
- 4 the radio, was that-
- 5 SULLIVAN: I did yeah.
- 6 DELUCIA: -the dispatcher put something out over the radio?
- 7 SULLIVAN: Correct, yep.
- 8 DELUCIA: Um, do you start sliding that way? Or...
- 9 SULLIVAN: I did yes.
- 10 DELUCIA: Okay.
- SULLIVAN: Um, not, and then once I heard, I don't know exactly how it
- 12 happened, I remember Steve saying knife, so then I really picked it up.
- DELUCIA: You heard that over the radio.
- 14 SULLIVAN: Yes.
- DELUCIA: Okay.
- 16 SULLIVAN: Yep.
- 17 DELUCIA: Alright so-
- SULLIVAN: And I think he asked, he told Joe to grab the less lethal.
- 19 DELUCIA: Over the radio.
- 20 SULLIVAN: I believe so yes.
- DELUCIA: Okay. But again that's your memory, that's what you think
- 22 you heard on the radio.
- 23 SULLIVAN: Correct.

- 1 DELUCIA: Okay. Um, as you're driving there, do you hear more radio, is
- 2 there more information going out or is-
- 3 SULLIVAN: Um, I'm just trying to think...
- 4 DELUCIA: Yeah, no again take your time. If you don't remember, you
- 5 don't remember, but do your best to uh, see what you do remember.
- 6 SULLIVAN: Yes so I remember, I remember Steve and John kinda like
- 7 going back and forth. I couldn't understand him perfectly, but I remember him
- 8 saying knife. So that's when I really picked it up.
- 9 DELUCIA: Yup.
- 10 SULLIVAN: And that—do you want me to keep going?
- 11 DELUCIA: Yeah for sure yeah.
- 12 SULLIVAN: So I was driving up North Hancock, um, driving down
- towards the house. I remember Joe Carruthers driving by the house, parking on
- the side.
- DELUCIA: So, so I have a photo here.
- 16 SULLIVAN: Oh perfect.
- DELUCIA: If that's gonna be helpful.
- 18 SULLIVAN: Perfect.
- DELUCIA: So, um just so you can have your point of view, this is 98.
- 20 SULLIVAN: 98.
- DELUCIA: Okay. This is 100.
- 22 SULLIVAN: So I'm coming this way.
- DELUCIA: So this is, what road is this?
- 24 SULLIVAN: Umm...

- 1 DELUCIA: Hamilton?
- 2 SULLIVAN: Actually no, so I'm coming, where's North Hancock?
- 3 DELUCIA: So this is, this is Hancock, I believe this is-
- 4 SULLIVAN: I'm coming from like here.
- 5 DELUCIA: Okay.
- 6 SULLIVAN: I'm coming here.
- 7 DELUCIA: Okay.
- 8 SULLIVAN: So I'm coming down, Joe's coming right here. Stops, I
- 9 remember him opening-
- DELUCIA: Okay. No go ahead, go ahead nope.
- SULLIVAN: I remember him opening up the trunk, to I assume grab the
- 12 less lethal.
- 13 DELUCIA: Okay.
- 14 SULLIVAN: So now I'm like right here.
- DELUCIA: Mmhmm.
- 16 SULLIVAN: Then I see Brendan?
- 17 DELUCIA: Yup.
- SULLIVAN: Brendan literally running through here.
- 19 DELUCIA: Yup.
- 20 SULLIVAN: I see John, I see Steve. So I'm here.
- DELUCIA: Where, where do you park your car?
- 22 SULLIVAN: So I stop right here.
- DELUCIA: Yup.
- 24 SULLIVAN: These guys are running out,

- 1 DELUCIA: Yup.
- 2 SULLIVAN: I back up to right here.
- 3 DELUCIA: Okay. So why don't you, if you would, just make a circle there
- 4 as to where you parked your car and got out of your car.
- 5 SULLIVAN: Right here.
- 6 DELUCIA: Okay. And then just put your initials like underneath there or
- 7 something like that.
- 8 SULLIVAN: Okay. So now they're like right—
- 9 DELUCIA: So this is when you first arrive.
- 10 SULLIVAN: So when I first arrive, I stopped here.
- 11 DELUCIA: Yep.
- 12 SULLIVAN: Didn't park it, I see them running.
- 13 DELUCIA: Yep.
- 14 SULLIVAN: So I back up here.
- DELUCIA: Understood. Yup.
- 16 SULLIVAN: I get out here.
- 17 DELUCIA: Yup.
- SULLIVAN: Come out, I believe, I don't know exactly if, I believe Steve
- 19 Papia shot a less lethal here.
- DELUCIA: Okay. So, I just want to mark this up.
- 21 SULLIVAN: Yep.
- DELUCIA: Just one thing at a time.
- 23 SULLIVAN: Yep.

- DELUCIA: So not too much on here. I'm just gonna make this #1 which is
- where you parked your car when you arrived.
- 3 SULLIVAN: Yep, perfect.
- 4 DELUCIA: And if you could just initial up there. Right in between the
- 5 time and #1. And again, strictly, this is where you parked your vehicle.
- 6 SULLIVAN: That's where I-
- 7 DELUCIA: And got out.
- 8 SULLIVAN: Yep, correct.
- 9 DELUCIA: Okay.
- 10 SULLIVAN: So now,
- DELUCIA: So we'll go to another one here, just so we don't have too many
- markings on one thing. So, let me have a, would that be, is that a better
- 13 representation?
- 14 SULLIVAN: Uh yeah that works
- DELUCIA: Cause that's 98 again, okay?
- 16 SULLIVAN: Yup.
- DELUCIA: This way, this is North Hancock Street right? That's the-,
- that's where you came in?
- 19 SULLIVAN: That's yes, that's where I came in. Stopped.
- DELUCIA: You came in, backed up,
- 21 SULLIVAN: Stop.
- DELUCIA: Right, again we're not gonna mark it on this one. You stopped
- 23 roughly here.
- SULLIVAN: Mmhm.

- 1 DELUCIA: And you see them coming, saw Branden running that way.
- 2 Correct?
- 3 SULLIVAN: That way. I remember seeing John here, Steve somewhere
- 4 over here.
- 5 DELUCIA: So did you, so, so what did you see when, you said you saw
- 6 Branden running.
- 7 SULLIVAN: Uh, I remember him running like full speed with the knife.
- 8 I'm like what the fuck?
- 9 DELUCIA: Yup.
- 10 SULLIVAN: This guy has a knife.
- 11 DELUCIA: Yup.
- 12 SULLIVAN: I'm like oh shit.
- DELUCIA: Did you see what hand it was in or anything?
- 14 SULLIVAN: Uh, I want to say right.
- 15 DELUCIA: Okay.
- 16 SULLIVAN: I- get you, no.
- 17 SULLIVAN: I want to say right.
- DELUCIA: No I get you. Again we're going with your best memory.
- 19 SULLIVAN: Yeah for sure.
- DELUCIA: Um, how was he holding it?
- 21 SULLIVAN: It was like this.
- DELUCIA: So you're, so right now, so we describe it, you have your right
- 23 hand up-
- 24 SULLIVAN: Correct.

- DELUCIA: Like, kinda tow- near your head, like in a-
- 2 SULLIVAN: Giving like a fist pump, yeah, yeah.
- 3 DELUCIA: Like with your- with a blade headed outbound, obviously.
- 4 SULLIVAN: Correct, yeah.
- 5 DELUCIA: Okay.
- 6 SULLIVAN: Correct.
- 7 DELUCIA: Um, and he's running.
- 8 SULLIVAN: He's running towards Burlington Street.
- 9 DELUCIA: Okay. It-
- 10 SULLIVAN: Um, I don't know if he just fell, I remember, I don't know, I
- don't know if John fell, he fell, they both fell, or Steve hit him with the less
- 12 lethal. But I remember him like tumbling over at some point then standing back
- 13 up.
- DELUCIA: So where did you first see him tumble? If you just make a-
- 15 SULLIVAN: Oooh.
- DELUCIA: And again this is rough.
- 17 SULLIVAN: Yeah.
- DELUCIA: It's not drawn to scale there. Okay so.
- 19 SULLIVAN: Let's say...
- DELUCIA: Is it on the street, or in this median area? Where...
- 21 SULLIVAN: It's like right on the edge.
- DELUCIA: Okay.
- 23 SULLIVAN: But like I said, I don't know specifically.

- DELUCIA: That's okay. Just to the best of your abilities. 'Cause you
- 2 kinda know where your car was right?
- 3 SULLIVAN: Yeah so I think I saw him, I saw this happening from like
- 4 here.
- 5 DELUCIA: Okay.
- 6 SULLIVAN: So I'd say like right here.
- 7 DELUCIA: So if you could just make it an area where we can, just like...
- 8 yup, okay.
- 9 SULLIVAN: And that's when I went back here.
- 10 DELUCIA: Okay.
- 11 SULLIVAN: Okay.
- DELUCIA: And is this him on the ground here?
- 13 SULLIVAN: Uh... yes. Yes 'cause that would make sense.
- DELUCIA: Okay. Could you just put his initials, BR?
- 15 SULLIVAN: Mmhmm.
- DELUCIA: Okay so this is where he's on the ground.
- 17 SULLIVAN: Correct.
- DELUCIA: Uh, where are you?
- 19 SULLIVAN: So now I'm out of the cruiser.
- DELUCIA: Yup.
- 21 SULLIVAN: And I remember, I believe it was Steve was shooting the less
- 22 lethal.
- 23 DELUCIA: Yup.

- 1 SULLIVAN: And I actually remember getting out and like, I don't know if
- 2 it ricocheted, it was like close to me, I'm like oh fuck!
- 3 DELUCIA: Yup.
- 4 SULLIVAN: So I'm like alright get back in. It actually worked out so then
- 5 I pull up like right... like right here.
- 6 DELUCIA: So you move your vehicle.
- 7 SULLIVAN: To right here yup.
- 8 DELUCIA: Did you drive forward or in reverse do you remember?
- 9 SULLIVAN: Forward.
- 10 DELUCIA: Okay.
- SULLIVAN: 'Cause I'm like "oh shit" now we gotta block this way.
- 12 DELUCIA: Burlington Street.
- 13 SULLIVAN: Yes.
- 14 DELUCIA: Okay.
- 15 SULLIVAN: 'Cause there's, there's people coming.
- 16 DELUCIA: Right.
- 17 SULLIVAN: So I pulled up here.
- DELUCIA: So why don't you make a notation as to where your cruiser is
- 19 there?
- 20 SULLIVAN: Uh....
- DELUCIA: So again this is rough so...
- SULLIVAN: Okay, alright. So I'm going like right here.
- DELUCIA: Okay and then just again, write your initials there. And put
- 24 car in there possibly? Just the word car.

- 1 SULLIVAN: Yeah.
- 2 DELUCIA: And do you get out of your car at that point? After you come
- 3 up here?
- 4 SULLIVAN: Yup. So I immediately come around here and now I'm like
- 5 here.
- 6 DELUCIA: Okay.
- 7 SULLIVAN: And now Branden's here.
- 8 DELUCIA: So you have him down here, and you see him get up at some
- 9 point?
- 10 SULLIVAN: Um... no.
- 11 DELUCIA: Okay.
- 12 SULLIVAN: I mean not until I like turn around.
- DELUCIA: Okay.
- 14 SULLIVAN: I don't.
- DELUCIA: So when you, when you drive up here,
- 16 SULLIVAN: Yup.
- DELUCIA: He's down. When you come up here and re-, re-situate your
- 18 cruiser and come back, is he in a different location?
- 19 SULLIVAN: Can I see that again?
- DELUCIA: Yeah. No problem. No problem.
- 21 SULLIVAN: Uh, no he's definitely further down. He's definitely-
- DELUCIA: Than when you first saw him?
- 23 SULLIVAN: Yes.
- 24 DELUCIA: Okay.

- 1 SULLIVAN: 100%
- DELUCIA: Okay.
- 3 SULLIVAN: Cause he, he's closer to me. 'Cause I wasn't, there's no way I
- 4 was that far away from him.
- 5 DELUCIA: Okay.
- 6 SULLIVAN: So he was like closer to here at this point.
- 7 DELUCIA: And again, make a notation as to where um, where he was-
- 8 SULLIVAN: I'd say...
- 9 DELUCIA: —on that second instance...
- 10 SULLIVAN: I would say, like right here.
- DELUCIA: Okay, and again if you could put his initials there that'd be
- 12 helpful.
- 13 SULLIVAN: BR.
- DELUCIA: BR yep. Okay. Where do you go when you get out of your car?
- SULLIVAN: So now I come over here and I'm like on this side of the
- 16 cruiser. Like, I'm like over here.
- DELUCIA: You wanna make like again a little note with your initials
- 18 there?
- 19 SULLIVAN: Yep. Yep.
- DELUCIA: Okay. Is he standing up or is he on the ground in this
- 21 instance?
- SULLIVAN: Uh, he's definitely on the ground now.
- DELUCIA: Okay. Alright so, so you're here-
- SULLIVAN: Mhmm.

- DELUCIA: Um, where are your fellow officers? In this- so forget about
- 2 this point, we're beyond that.
- 3 SULLIVAN: Yeah, do you want me-
- 4 DELUCIA: Yep. If you could write them in,
- 5 SULLIVAN: Okay.
- 6 DELUCIA: Like in a circle with their initials.
- 7 SULLIVAN: So this is Steve Papia, Joe Carruthers, um... John Frissore.
- 8 McAleer was like somewhere over here.
- 9 DELUCIA: Okay.
- 10 SULLIVAN: I don't know exactly. Um...
- DELUCIA: Could you see him? Or you found out afterward, or—like you
- 12 know he's there.
- 13 SULLIVAN: No, I knew he was there.
- 14 DELUCIA: Okay.
- 15 SULLIVAN: He was like behind him somewhere.
- 16 DELUCIA: Okay. Okay.
- 17 SULLIVAN: There we are.
- DELUCIA: Okay. Um... so then it, what's going on here? What are you
- 19 seeing, what are you hearing?
- 20 SULLIVAN: Drop the knife, drop the knife, please drop it, along those
- 21 lines.
- DELUCIA: Is there anyone talking more than anyone else? Or is
- 23 everyone just communicating?

- 1 SULLIVAN: Um, so it's, I heard mostly Steve and John. But then Joe, Joe
- 2 was unbelievable. He was very calm. Like he, he was trying to talk to him
- 3 calmly.
- 4 DELUCIA: Okay.
- 5 SULLIVAN: And these two were more like, "drop the fucking knife," like-
- 6 DELUCIA: Yup.
- 7 SULLIVAN: —come on man, like enough is enough.
- 8 DELUCIA: Yup. Let me just, we gotta date and time this one too. Let's
- 9 make this one, this one's just going to be #2.
- 10 SULLIVAN: Yep.
- DELUCIA: And same thing if you could just write your initials.
- 12 SULLIVAN: Yeah.
- DELUCIA: Right in there. Okay. So, um, let me see that pen. While this
- 14 is going on—
- 15 SULLIVAN: Mmhm.
- DELUCIA: —what's going on with you. What are your thoughts, what are
- 17 you seeing, what are you...
- SULLIVAN: Um, so I think when I initially came out I had my baton
- because I- I really thought he was going to drop the fucking knife.
- DELUCIA: Mmhmm.
- 21 SULLIVAN: So I assumed we were going to have to run at him, do
- 22 whatever we had to do.
- DELUCIA: Mmhmm.

- 1 SULLIVAN: After a while I was like alright this isn't going that way. I
- 2 got the vibe it wasn't going that way so I did, I took out my firearm.
- 3 DELUCIA: Mmhmm.
- 4 SULLIVAN: Low ready.
- 5 DELUCIA: Okay.
- 6 SULLIVAN: Uh,
- 7 DELUCIA: So you, you put your baton away?
- 8 SULLIVAN: Yeah, put my baton away and had my firearm out.
- 9 DELUCIA: Are you right handed?
- 10 SULLIVAN: Yeah.
- 11 DELUCIA: Okay.
- 12 SULLIVAN: Correct.
- DELUCIA: Okay, so you're—
- SULLIVAN: 'Cause I have this, I have this whole side, I mean that's on
- me. I mean...
- DELUCIA: Yeah, no like you had said right here, you're blocking
- 17 Burlington Street-
- 18 SULLIVAN: Yup. Mmhmm.
- DELUCIA: –from traffic. I mean, I mean I'm assuming you're trying to
- 20 contain this whole thing.
- 21 SULLIVAN: Yeah and that I don't want to be in the line of fire.
- DELUCIA: Of course.
- 23 SULLIVAN: So it's like, I'm on that side.

- DELUCIA: What do you see these guys with? Do you see anyone with
- 2 weapons, out of your, your fellow officers?
- 3 SULLIVAN: Umm, I know Steve definitely had the less lethal.
- 4 DELUCIA: Okay.
- 5 SULLIVAN: Um, and I know, obviously Joe had it because he took it out
- 6 here, and I remember him giving it to John.
- 7 DELUCIA: Okay.
- 8 SULLIVAN: Um, I don't remember Joe pulling out his firearm but-
- 9 DELUCIA: Okay.
- 10 SULLIVAN: -I mean...
- DELUCIA: Okay. Um, so... what ultimately happens here? What do you
- 12 end up seeing?
- SULLIVAN: Ah, so after a while um, they're going "drop it, drop it."
- DELUCIA: Is he saying anything?
- 15 SULLIVAN: I couldn't even understand what the hell he was saying.
- 16 DELUCIA: Was, was there any noise coming from him at all?
- 17 SULLIVAN: Yeah, something, but I can't tell you what.
- 18 DELUCIA: Okay.
- 19 SULLIVAN: Um, pretty much like along the lines of "no, I'm not, no."
- DELUCIA: Okay.
- 21 SULLIVAN: I remember him banging the knife too, like against the
- 22 ground.
- DELUCIA: Okay.
- 24 SULLIVAN: Um...

- DELUCIA: So you're doing that with like the butt end of it with—
- 2 SULLIVAN: Yeah. Just like, just, I don't know he wouldn't drop it. Um,
- 3 and they're obviously continuing. At this point like Joe was kind of like
- 4 quarterbacking it.
- 5 DELUCIA: Mmhmm.
- 6 SULLIVAN: He's like um, he's like "back up guys, back up guys, give him
- 7 space, keep your distance." Uh and he's trying to talk to him calmly.
- 8 DELUCIA: Mmhmm.
- 9 SULLIVAN: Um, and then obviously at some point I believe Steve went
- 10 to reload, um...
- DELUCIA: Did you hear any of the less lethal discharged?
- 12 SULLIVAN: Uhhh...
- DELUCIA: I know you said you saw one because it like skipped by you
- when you first got there right?
- SULLIVAN: Yeah and then another one skipped by me over here.
- 16 DELUCIA: Okay.
- 17 SULLIVAN: Too. So I'm like "oh shit."
- 18 DELUCIA: Yeah.
- 19 SULLIVAN: Um,
- DELUCIA: So you know they're deploying less lethal.
- 21 SULLIVAN: For sure.
- 22 DELUCIA: Okay.
- 23 SULLIVAN: Yes. Definitely.
- DELUCIA: Do you know if they're hitting him?

- 1 SULLIVAN: Um, I can't say for sure.
- DELUCIA: Yeah if you don't know, you don't know.
- 3 SULLIVAN: Yeah. I don't know.
- 4 DELUCIA: So, okay.
- 5 SULLIVAN: I believe so, but.
- 6 DELUCIA: You don't know.
- 7 SULLIVAN: I don't know.
- 8 DELUCIA: Okay. Um so then ultimately what ends up happening, what
- 9 do you end up seeing happen?
- 10 SULLIVAN: Uhh, so I still remember Steve Papia taking like a step back,
- and it was like, it was like this thick of ice with like a little snow on it.
- 12 DELUCIA: Yeah.
- 13 SULLIVAN: I still remember him stepping back and seeing his face like,
- 14 like-
- DELUCIA: Mmhmm.
- SULLIVAN: -terrified. Like, that's still I can see it, like "oh shit," like "oh
- 17 fuck."
- DELUCIA: Like he was gonna fall?
- 19 SULLIVAN: Yes.
- DELUCIA: Okay.
- SULLIVAN: Um, and then, obviously, shots were fired.
- DELUCIA: What happened then, when he goes, does he fall?
- 23 SULLIVAN: Um, I believe so yes. I- I- all I remember is seeing his face
- 24 like.

- 1 DELUCIA: Like, fall- you're demonstrating falling backwards.
- 2 SULLIVAN: Yes. Stepping back and like, yeah.
- 3 DELUCIA: Di- did you see, when that was happening, or after that was
- 4 happening did you see Branden do anything?
- 5 SULLIVAN: I definitely saw him take a step forward at that point. He's
- 6 up, and then seeing him.
- 7 DELUCIA: So, you saw Branden get up?
- 8 SULLIVAN: Yes I think he's up at that, I remember seeing Steve go back,
- 9 it happened so fast.
- DELUCIA: Yep and no I'm again,
- 11 SULLIVAN: Yeah.
- DELUCIA: I'm not trying to get hyper-technical with you.
- 13 SULLIVAN: Haha yeah.
- DELUCIA: It's just a matter of what you saw.
- 15 SULLIVAN: Sure.
- 16 DELUCIA: You have an obviously very good memory of Steve.
- 17 SULLIVAN: I specifically remembered his face being like, like scared.
- 18 Like terrified.
- 19 DELUCIA: Yep.
- 20 SULLIVAN: Yeah. Like "fuck. Fuck I just slipped."
- 21 DELUCIA: Yep.
- 22 SULLIVAN: And yeah I remember him being up, and walking like
- 23 towards that way. And then,

- DELUCIA: So, and I want to make sure I understand the "hes" and
- 2 "hims" right?
- 3 SULLIVAN: Yep.
- 4 DELUCIA: You see Steve falling backward.
- 5 SULLIVAN: Yup.
- 6 DELUCIA: And when you say "him up" you're talking about Branden?
- 7 SULLIVAN: Branden, yup.
- 8 DELUCIA: Standing up?
- 9 SULLIVAN: Standing up. Walking towards Steve's direction.
- DELUCIA: And, okay. And is Steve on the ground?
- 11 SULLIVAN: I don't know,
- DELUCIA: Or you don't know, okay.
- 13 SULLIVAN: I don't know exactly.
- 14 DELUCIA: Okay, okay. Um...
- 15 SULLIVAN: I believe so.
- DELUCIA: And, how quickly, so then what happens then? When you,
- when you see that.
- 18 SULLIVAN: Um...
- DELUCIA: What's the next thing that happens?
- 20 SULLIVAN: I remember there was a shot fired.
- 21 DELUCIA: Yup.
- SULLIVAN: And I remember um, immediately going to my cruiser,
- opening up the back door, the uh, to get the med bag. That wasn't there. Opened
- 24 up the truck, got the med bag.

- 1 DELUCIA: Okay.
- 2 SULLIVAN: So now I have the med bag. Throw it onto the ground, I still
- 3 remember this like perfectly, Joe Carruthers goes "Sean put gloves on," I was
- 4 like "alright." Put gloves on, and I don't know if there was another shot or he
- 5 finally just fell down, you know what I mean? Branden fell down.
- 6 DELUCIA: Okay.
- 7 SULLIVAN: Um, I remember he fell down with the knife in his hand, I
- 8 remember John Frissore either kicking it out or taking it out.
- 9 DELUCIA: Okay.
- 10 SULLIVAN: Uh, and then I just started doing compressions on Branden.
- DELUCIA: How many shots did you hear? Do you know?
- 12 SULLIVAN: To be honest with you? None.
- 13 DELUCIA: Okay.
- 14 SULLIVAN: Like more things, I don't know.
- 15 DELUCIA: Okay.
- SULLIVAN: But how would I have known to get the med bag? You know
- what I mean?
- DELUCIA: Yeah no, again this is just what your memory is right?
- 19 SULLIVAN: Yeah.
- DELUCIA: Uh cause whenever there's a traumatic incident there's...
- 21 SULLIVAN: Yeah.
- DELUCIA: There's auditory exclusions, I mean we've been through it all
- 23 right, through training.
- SULLIVAN: It's actually weird.

- 1 DELUCIA: I mean there's all kinds, you get tunnel vision, you get, all
- 2 kinds of things happen.
- 3 SULLIVAN: Yes, bizarre.
- 4 DELUCIA: Um, so, did you know, did you know he was shot?
- 5 SULLIVAN: Oh definitely.
- 6 DELUCIA: Did you know who, who shot, who fired their weapon.
- 7 SULLIVAN: I had an idea for sure.
- 8 DELUCIA: And who do you think that was?
- 9 SULLIVAN: Uh, Joe.
- DELUCIA: Okay. And why, again can you take me through why you
- 11 knew that, or why you thought that.
- 12 SULLIVAN: Because Steve tumbling over, John had the less lethal, and I
- 13 knew, at that point I knew Joe had his firearm out.
- DELUCIA: Okay. Are you familiar with you know, less lethal, there's
- 15 lethal cover? Are you familiar with-
- SULLIVAN: I know you're supposed to, that's how it's supposed to be.
- 17 DELUCIA: Like, like through training, or?
- 18 SULLIVAN: Through training yes.
- DELUCIA: Okay you're aware of that is that?
- 20 SULLIVAN: Correct. Yeah.
- 21 DELUCIA: Okay. Alright.
- SULLIVAN: So that's why he, why Joe gave Ste- err- Joe gave John a
- 23 less lethal so that he had le- the-
- DELUCIA: The lethal cover right?

- 1 SULLIVAN: Yeah, correct. Yeah.
- 2 DELUCIA: Okay. Um, and then you said you ended up doing
- 3 compressions?
- 4 SULLIVAN: Correct, yeah.
- 5 DELUCIA: How would you describe uh, what Branden looked like that
- 6 day?
- 7 SULLIVAN: Oh like-
- 8 DELUCIA: Like the size of him, there's demeanor, like whatever str-
- 9 whatever you remember right now.
- 10 SULLIVAN: Uh big, really pale, like I don't even, I can't even describe his
- skin, not healthy.
- 12 DELUCIA: Okay.
- 13 SULLIVAN: Um,
- DELUCIA: Remember what he was wearing?
- 15 SULLIVAN: Uh shorts I believe?
- 16 DELUCIA: Okay.
- 17 SULLIVAN: I want to say a long sleeve or a sweatshirt.
- 18 DELUCIA: Okay.
- 19 SULLIVAN: I know he always wears a hat, I don't know if he was
- wearing a hat, um, yeah that's it.
- DELUCIA: Did, did he look any differently than you had seen him in the
- 22 past? Based upon past interactions.
- 23 SULLIVAN: Yes, he looked a lot less healthier.

- 1 DELUCIA: Okay. In, in terms of his complexion? Is that what you're
- 2 talking about?
- 3 SULLIVAN: Just, I mean, just, I mean. Don't know how to say it. Not just
- 4 like, you know when someone's healthy or not. Uh, I mean...
- 5 DELUCIA: When you say healthy do you mean physically, do you mean
- 6 mental health? What-?
- 7 SULLIVAN: Yeah, just his uh, appearance and his skin complexion, and
- 8 just I dunno, just.
- 9 DELUCIA: Okay. Did you ever see his face?
- 10 SULLIVAN: Yeah.
- DELUCIA: Okay. What did it like, could you describe any characteristics?
- 12 SULLIVAN: He just looked sick, um, trying to think about how I would
- describe it... droopy, just like, just not all there.
- DELUCIA: Okay. So when you had had interactions with him in the past,
- were you able to successfully communicate with him?
- SULLIVAN: For the most part. And I've seen him walking like, I always
- 17 see him walking.
- DELUCIA: Mmhmm.
- 19 SULLIVAN: And like, he was fine.
- DELUCIA: Okay.
- 21 SULLIVAN: But yeah, when I've interacted with him it's usually been
- 22 like okay, like you can tell he has some mental illness some, disabilities.
- DELUCIA: Okay. What and, so, so that, that being your past experience
- with him.

- 1 SULLIVAN: Mmhmm.
- 2 DELUCIA: How is this experience different in terms of the way, or the
- 3 way he was communicating or not communicating?
- 4 SULLIVAN: It just, it wasn't there. Like I honestly believe that there was
- 5 no stopping him that day.
- 6 DELUCIA: Okay.
- 7 SULLIVAN: He was a dangerous, dangerous person.
- 8 DELUCIA: Okay.
- 9 SULLIVAN: And I don't, there's just no way you could reason with him.
- He's, these three guys they couldn't have tried harder. I mean, gave him every
- 11 opportunity in the world.
- DELUCIA: Okay.
- 13 SULLIVAN: You know what I mean?
- 14 DELUCIA: Yeah, no I do.
- 15 SULLIVAN: Its, he wasn't stopping.
- 16 DELUCIA: And like, now how about you, where was your head at during
- this entire affair? I know you said that you were (unintelligible).
- SULLIVAN: So like over here I'm like, honestly I'm like fuck, he comes
- this way guess who has him. Me.
- DELUCIA: Yeah.
- 21 SULLIVAN: So. But I was definitely not, I didn't have any interaction
- 22 with him whatsoever.
- 23 DELUCIA: Okay.
- 24 SULLIVAN: But I, I could see it all.

- DELUCIA: Okay. Okay. And um, do you recognize that house?
- 2 SULLIVAN: Yeah, 98 Hancock.
- 3 DELUCIA: Okay, that's that's what it looked like when you had gone in
- 4 the past?
- 5 SULLIVAN: Yep.
- 6 DELUCIA: Okay. Um...
- 7 MCDONALD: Okay.
- 8 DELUCIA: I, I don't think I have any more questions, um...
- 9 MCDONALD: Okay.
- DELUCIA: You're good?
- 11 MCDONALD: Yup.
- DELUCIA: Okay um, it is, do you have anything you want to ask me or
- 13 anything like that? Otherwise we are going to shut this down.
- 14 SULLIVAN: No, I'm all set.
- DELUCIA: Okay. It's uh, 16:00 hours uh, Monday February 14, 2022 and
- 16 uh we are going to stop this interview. Okay. Thank you all.
- 17 VOICE: Thank you.
