Donahue: All right. This is being recorded now. Ayoub: Okay. Donahue: Okay. Oop, I'm throwing stuff at you. The date is January 6th, 2023. Uh, the time is now approximately 5:11 p.m. My name is, uh, Detective Lieutenant William Donahue, um, with the Massachusetts State Police, assigned to the Middlesex district attorney's office. Uh, we are currently conducting an interview of Cambridge Police Officer Nicholas Ayoub, uh, relative to the facts and circumstances ... stances surrounding a fatal, officer-involved shooting which occurred on Wednesday, January 4th, 2023 in the city of Cambridge. For the purposes of the tape, if we could go around the room and identify ourselves. Brown: Uh, Lieutenant David Brown, B-R-O-W-N, assigned to criminal investigations. Attorney Kenneth Anderson, A-N-D-E-R-S-O-N, for Officer Anderson: Ayoub. Nicholas Ayoub, Cambridge Police, patrol officer. Ayoub: Donahue: And how do you spell your last name, Nicholas? A-Y-O-U-B. Ayoub: Donahue: Okay. Thank you. Um, and prior to this interview, you've had an opportunity to consult with your attorney? Ayoub: Correct. Donahue: And you're here voluntarily? Ayoub: Yes. Donahue: Yes. Attorney Anderson? Anderson: Yeah. He's, he's here voluntarily. He hasn't been coerced to be here, ordered to be here. He's fully cooperating in the

Ayoub: Police officer with Cambridge ... city of Cambridge. Donahue: How long you been, uh, employed as a police officer? Ayoub: Uh, since May 2018. Donahue: 2018, and, uh, do you, uh, academy training? Ayoub: Yes. Donahue: Where did you attend that? Ayoub: Lowell Police Academy. Donahue: A-, how long was that training? Six months. Ayoub: Donahue: And can you describe that training? Ayoub: Um, it was a lot of classroom sessions, a lot of PT, um, firearms training, a lot of vehicle training. Donahue: Okay. And since your, um, during your tenure as a Cambridge police officer, do you attend additional training and service training? Ayoub: Yes. Every year we do that. Uh, we DID ICAT. We've ... this year, we ... most recently, we did, uh, mental health training about a month or two ago. So could you, uh, further des-, w-, w-, further describe ICAT Donahue: training and then further describe your most recent mental health training. health compulsion ... training component here?

Ayoub: Just, uh, like, try to deescalate, talk with somebody, establish a

rapport, um, and, and try to get them to comply and get them

help.

Donahue: Those trainings are m-, provided by Cambridge Police?

Ayoub: Yes.

Donahue: And, um, are there practical exercises? Is it classroom?

Ayoub: Uh, we did both.

Donahue: You did both? And it's, um, using dialog ...

Ayoub: Mostly, yes.

Donahue: ... versus use of force?

Ayoub: Correct.

Donahue: And then your firearms training, uh, is there a use of force

training as well?

Ayoub: Yes.

ni-, you know, 9-1-1 calls ... what's the range of calls you've

had here as a Cambridge police officer?

Ayoub: Uh, it could be anything from a 9-1-1 hang-up to, uh, shots

fired, anything in between, sexual assaults, shopliftings.

Donahue: Okay. Um, directing your attention to this past Wednesday,

January 4th, 2023, were you working?

Ayoub: I was.

Donahue: And what was your assignment that day?

Ayoub: Car 3.

Donahue: Car 3. And what is car 3? Does that have a particular area that

you would cover? Or it's ...

Ayoub: The, uh, coast area or Cambridge Port area, in between Central

Square to the river.

Donahue: Is that a single-man car or a ...

Ayoub: Two-person car.

Donahue: Two-person car? Who were you driving with that day?

Ayoub: Officer Liam McMahon.

Donahue: Okay. Um, and at some point, um, did you and Officer

McMahon, um, respond to a call?

Ayoub: We did.

Donahue: Uh, do you remember the time and the nature of that call?

Ayoub: It was about 1:00, and it was for a person ... it was a psych

suicide. A person with a ... armed with a machete and was

self-harming himself.

via radio?

Ayoub: Yes, that's what it ... Donahue: And ... Ayoub: ... says on the INAUDIBLE. Donahue: ... and that's what ... is that, um, is there a computer notification on that? Correct. Ayoub: Donahue: And does that com-, does that notification actually say "psych"? It does. Ayoub: Okay. "Psych suicidal"? Donahue: Ayoub: I believe that's what it says. Donahue: Okay. So, um, via radio transmission, what else did you learn about that call? Ayoub: Uh, the individual ... the reporting person said he was armed with what he believed was a machete. Uh, he had jumped through a window, broken a window, and he was actively cutting himself with both the knife a-, and with broken glass. And do you remember where you were when you received that Donahue: call? Ayoub: HARPER Square. Donahue: Okay. And with that information, what'd you guys do? Ayoub: Uh, we immediately responded to the call, which was, I believe, 625 Putnam Ave, in that area. Donahue: And, uh, emergency lights, siren activated? Yes. Ayoub: Donahue: Okay. And on your way, do you recall or did you learn or, uh,

recall learning any additional information? Were there other officers there? Were there further radio transmissions?

believe car 1 got there first, maybe a minute or two before us.

Donahue: Do you remember who was in car 1?

Ayoub: Uh, Officer COLBERT and Officer BUCKS Pugliares.

Donahue: Okay. Um, they got there first. When did you arrive and where

did you arrive?

Ayoub: I'd say it probably took us about five minutes to get there,

maybe four minutes. Um, we arrived a-, as there was foot pursuit. Um, I got out of the cruiser at Chestnut and Sydney Street, and Officer McMahon parked the cruiser and, and

followed me on Chestnut Street.

Donahue: Um, w-, when you first got out, did you see anyone, or were

you just following radio transmissions to get ... to assist?

Ayoub: There was a UPS driver right at that intersection. I told him to

leave the area, and I was listening to the radio as they were chasing the person and calling out where they were going.

Donahue: And why ... why'd you tell him to leave?

Ayoub: Uh, because from what I knew, there was a person armed with

a weapon, and there was an active foot pursuit.

Donahue: Uh, anyone else ... any other civilians?

Ayoub: WELL, that's all I saw.

Donahue: Okay. Um, what'd you do next?

Ayoub: Uh, Officer McMahon and I went to ... went down Chestnut

Street. They were saying the person was running towards Waverly by the tracks. We got to the end of Chestnut at Waverly. At that time, I believe Officer Colbert said they were

on the train tracks. We looped around the fence onto the train

tracks, and that's when I saw f-, for the first time, the

individual.

Ayoub: I saw a shirtless, uh, light-skinned male, uh, gray sweatpants,

and he was holding a large, large knife.

Donahue: And how would you, um, further describe that large knife?

Particularly describe it.

Ayoub: Uh, it was probably a ... looked, looked f-, to be about a foot

long. Uh, it was silver. Um, that's all I ... that's what I saw at

that time.

Donahue: It was, uh, the call came in as a machete.

Ayoub: Mm hmm.

Donahue: Would, would it be consistent with that?

Ayoub: I would say so.

Donahue: Okay. And, um, any other observations about that individual?

Ayoub: Uh, he was bleeding, um, and he was not responding to

anything we were saying to him.

Donahue: And what were you saying to him?

Ayoub: Uh, "Buddy, can you talk to me? Can you please drop the

knife?" Um, "We just wanna help you." He did not respond at

all.

Donahue: In that, um, being faced with somebody with a machete and that

tactic ... is that part of the ICAT training and the other training you've received? Is that a s-, is that a intentional technique

you're using?

Ayoub: Uh, we were trying to keep our distance from him. Uh, at that

point, Officer McMahon and I were on one side of him. The other officers were on the other side. He was in the middle, and we were trying to keep distance and try to establish some

sort of communication with them.

Ayoub: Um.

Donahue: And the distance is for your own safety?

he wasn't saying anything.

Donahue: And, um, how was he holding that knife?

Ayoub: Um, at that point, I believe he was ... still had it to his, to his

throat, uh, but he was, he was moving around a lot.

Donahue: In what fashion?

Ayoub: Uh, just very jerky. He was walking, running, um, and then

shortly after we were on the train tracks, he cut out a, a hole in

the fence. He went through a cut-out hole in the fence.

Donahue: Okay. And what'd you guys do? What did the officers that

were responding do?

Ayoub: We followed through the same hole, um ...

Donahue: Where did that ...

Ayoub: ... back onto Chestnut Street.

Donahue: Okay. Back onto Chestnut Street? And what happened next?

Ayoub: We were still engaging with him, trying to, trying to get him to

talk to us, trying to get him to drop the knife. Um, the UPS driver that I'd first seen was still there. He was in the back of the truck at that point. Um, and he was ... the person was heading towards him. I told him to shut the door and leave the area, uh, w-, at which point he, he saw all of us, and he

immediately did. Um, the person with the knife was, at one point, cutting his, cutting his wrists. He was cutting his throat.

Um.

Donahue: When you say, "cutting his wrists, cutting his throat," was that

... i-, is he doing that stat-, while he's stationary? Is he doing it

on, on the move? Is he doing that continually?

Ayoub: I believe ...

Donahue: How was that happening?

stopped, and he would turn around, kinda mock us, um, and then he would continue on his way. Um, but he, he was, like, sawing at his, at his throat. Um, at ONE point, he did stop and drop down to the curb and began, like, sharpening the knife on

the curb.

Donahue: Do you remember ... was that on Chestnut Street?

Ayoub: Chestnut Street.

Donahue: Do you know what, you know, what area of Chestnut?

Ayoub: It was in between Chest-, uh, it was on Chestnut between

Waverly and Sydney.

Donahue: Okay. H-, your ... who was the point person in, in this foot

chase, if you recall?

Ayoub: I believe ...

Donahue: If there's an order ...

Ayoub: Yeah.

Donahue: ... that you know at this time INAUDIBLE.

Ayoub: Officer, Officer Pugliares, O-, myself, and Officer McMahon

were on the left side of the street. He was on the right side of the street for most of it. Um, I would say we were closest to

him.

Donahue: And what's that distance?

Ayoub: Maybe 30 feet.

Donahue: And that w-, was that, uh, kind of a maintained distance

throughout this?

Ayoub: Correct. We tried to, you know, keep him close enough but not

too close, um, whereas we could still interact with him.

very crowded.

Donahue: So it's a crowded neighborhood, but more specifically, what are

your concerns with the man with the knife in this state?

Ayoub: That he could harm somebody if somebody were to come

across him.

Donahue: And with a weapon like that, what would the result be?

Ayoub: Severe injury.

Donahue: Okay. So you're following him down Chestnut Street. What

happens next?

Ayoub: Um, we're continuing to order him to drop the knife. Uh, he

continues to mock us, I guess, and, and was laughing, smiling, wasn't saying anything. Um, he also did have a ... uh, it appeared to be, like, a Bible, and somebody said it was a Quran. Um, and he continued ... he just continued down

Chestnut.

Donahue: Um, do you remember seeing that?

Ayoub: I do.

Donahue: The Bible or Quran or whatever ...

Ayoub: I do.

Donahue: ... it was? Okay. Uh, so you continued down Chestnut Street.

Where do you go? What happens next?

Ayoub: He entered the driveway of 65, I believe, or 63 Chestnut Street,

uh, which I remember calling off on the radio, that address.

Right as I called that off, he switched over into the

next-door-neighbor's house, which was 59 Chestnut. We followed him through that driveway on the left side of the

house.

Ayoub: Yup.

Ayoub: Correct.

Donahue: And who else was with you?

Ayoub: Officer McMahon and I believe Officer Pugliares.

Donahue: Okay. So you entered through 65, we believe, um, but you end

up in 59?

Ayoub: Correct.

Donahue: And when you pursue him in 59, what happens when that ...

when you get into that backyard?

Ayoub: Uh, so there's a little ... there's a little fence there. He jumped

over the fence. Officer Mc-, McMahon and I both hopped over the fence, and I, I remember him being towards the back of the yard. It was large yard for Cambridge, um, and there was a ... kinda like a boarded-off garden in the middle of it. And he ... I remember putting over the radio that he was trying to get out the back of the yard, um, which he couldn't. The fences were too high, um, at which point he s-, went around the, the

opposite side of the house ... so the right side if you're looking

at it ...

Donahue: And we're talking about 59 now?

Ayoub: 59.

Donahue: Okay. So f-, backyard o-, opposite how you guys came in.

Ayoub: Right. Well, we, we came in through 59, over that fence into

the backyard of 59.

Donahue: Well, I guess, um, if you're facing 59, do you recall a driveway

to the right? You ... did you come in through the left side?

Ayoub: I came in through the left side if you're looking at the house. Donahue: Okay. Ayoub: I believe there's driveways on ... Donahue: CORRECT. Ayoub: ... both sides. Donahue: Correct. So you were in the backyard. He's trying to potentially get out the back. What happens next from there? Ayoub: Um, at that point, I said he was trying to go out the backyard. He realized, I think, he couldn't get out that area 'cause the fences were probably 12 feet high, at which point he started going ... trying to get back out towards the Chestnut Street, um, using the opposite way that he came in, which was ... Donahue: Did you guys have guns drawn at that time? Yes. Ayoub: Donahue: And, um, were you trying to maintain distance in that backyard as well? Ayoub: As much as we could. Uh, I stayed ... right when I hopped that fence, I stayed right by that fence as I was observing him kinda move about the backyard until he went around the corner of the house to that driveway, and Officer McMahon then was in front of me. It-, remember saying, "Liam, like, stay back. Stay back. He's around that corner." Um, at which time, I heard the other officers starting to order commands from the driveway. Donahue: And specifically, what were they saying? Uh, continuing to yell "drop the knife," um, and then I Ayoub: remember people saying j-, "we're just trying to help you. We're just trying to help you. Just talk to us. Drop the knife." And then I remember hearing, uh, "the less lethal." Donahue: You say hear-, hearing the less lethal round or hearing someone

Donahue: ... announce "less lethal" INAUDIBLE?

Ayoub: I heard Officer Colbert, who had ... I'd seen him with the

40-millimeter launcher. I o-, I heard him yell, "Less lethal, less lethal," which I knew to mean he was gonna fire the less lethal

round.

Donahue: And then did you hear that fi-, actually fire?

Ayoub: I did.

Donahue: And what happened then?

Ayoub: Um, so he was around the corner. I, I heard all this. I didn't see

it, um, but after hearing the, the round fired, I heard him laugh

... the person laugh.

Donahue: Did he go down?

Ayoub: Didn't appear so because he came back into my frame in the

backyard.

Donahue: Okay. Um, as he's coming back into the backyard, where ...

and I'm gonna have you draw a little basic diagram here, but where are you and where is Liam and where is the indiv-, i-, well, let me ask you this. Who's in the backyard at this

moment?

Ayoub: Myself, Officer McMahon, and the individual.

Donahue: And what happens next?

Ayoub: The individual begins to walk towards Officer McMahon. I

begin to kinda keep a ... keep pace with him from where I was against the fence, and he just continued advancing towards Officer McMahon who was at ... now at the backyard, like, at

the back of the backyard.

Donahue: And can you describe the pace, and can you describe where the

weapon was? Is it up, down, where is the weapon?

Ayoub: I believe he had it ...

walking fr-, briskly, I would say, or if not faster.

Donahue: And are you looking at ... is your vantage point a, a profile of

this? Are you off to the ... a side view, or however ...

Ayoub: Side ...

Donahue: ... how would you describe it?

Ayoub: I was off to the side, so I saw his left body.

Donahue: Okay. And, um, he's walking briskly, your words. Um, what

happens next?

Ayoub: Um, Officer McMahon was continuing to move backwards

towards the back fence, and we were both screaming at him, "Drop the knife." Officer McMahon was, was yelling, "Don't, don't make me ... don't make me do this. Don't make me do this. Just drop the knife." And he just continued, continued

forward.

Donahue: And, um, did Officer McMahon have his weapon drawn?

Ayoub: He did.

Donahue: And what position was that in?

Ayoub: I believe he was pointing it at him.

Donahue: And, um, what was the distance between the individual and

Officer McMahon, uh, as they're closing in, um, as that distance

closed, um, let me ask you this. What happened?

Ayoub: Um, Officer McMahon ... I heard him ... I heard gunshots, um,

and, um, yeah.

Ayoub: I thought I heard five.

would you estimate the distance between Officer McMahon

and the individual was?

Ayoub: Say within 5, uh, sorry, within 10 feet.

Donahue: Within 10 feet. And what was the position of the knife, if you

recall ... I should say the knife or machete or however we're describing it ... in the individual's hand at that moment or

through the course?

Ayoub: I believe at this time, he was holding it out in his right hand.

Donahue: Okay. And, um, after those shots were fired, what happened?

Ayoub: Um, I saw the individual go to the ground. Um, I remember

looking at Officer McMahon, who was stationary, frozen, and I ... Officer Pugliares and I began kind of triangulating on the, on

the suspect.

Donahue: Um, and as you triangulated, you moved in?

Ayoub: Correct.

Donahue: And what did you see?

Ayoub: Um, he was laying down. I ... the knife was under his shoulder,

I believe, and I remember we moved him so that Officer

Pugliares could, could grab ... get it away from him. And, uh ...

Donahue: Get the knife away?

Ayoub: Get the knife away from him. And we started medical aid.

Donahue: Um, did that individual make any statements?

Ayoub: Not at that time. Um.

Donahue: Did he make any movements?

Ayoub: He was moving.

Donahue: Um, how would you categorize those movements?

just seeing where he was hit and where we needed to, uh, we were just assessing his injuries. Um, and then we began kinda applying pressure to where he was injured, and then at one point, he began kinda fighting back with us, and I, I grabbed

both of his hands and put them behind his head.

Donahue: Uh, was he handcuffed?

Ayoub: He wasn't at that time, and, and then we, we did handcuff him

in, in the front.

Donahue: In the front. Um, and was the knife moved, do you recall?

Ayoub: Yes. I believe, I believe Officer Pugliares put the knife off to

the side of, of the yard.

Donahue: Are you familiar with the ... have ... the 40-millimeter round ...

Ayoub: YES.

Donahue: ... the less-lethal round? Have you seen it deployed in the

field?

Ayoub: Um, no.

Donahue: A-, uh, during t-, you ... are you certified in that?

Ayoub: Yes.

Donahue: And have you, um, you've gone to the training. Um, when you

were in that backyard and that millimeter ... the 40-millimeter less lethal was, um, deployed with no effect, what w-, did that have an effect on how you were gonna handle the situation and

what your thoughts were at the time?

Ayoub: I ... from, from when we got there, I, I was hoping that the

40-millimeter was gonna make him drop the knife and get on the ground. When he laughed a-, after I assumed he was hit with it, uh, I knew, I knew it was ... he wasn't gonna stop.

Officer McMahon, do you, uh, before ... I g-, my next question,

but that backyard ... with M-, hi-, McMahon's pim-, positioning, do you recall a fence being behind him?
