Donoghue:	The date is, uh, January 6 <sup>th</sup> , 20, uh, 23. The time is approximately 2:50 p.m. Uh, my name is Detective Lieutenant William Donoghue, D-O-N-O-G-H-U-E. Um, I'm a Detective Lieutenant with the Massachusetts State Police assigned to the Middlesex District Attorney's Office. Uh, we're currently, uh, conducting an interview of Cambridge Police Officer, uh, Brian Pugliares, uh, relative to the facts and circumstances surrounding a fatal officer-involved shooting, which occurred on Wednesday, January 4 <sup>th</sup> , 2023 in the City of Cambridge. Uh, for the benefit of the tape, uh, WHY DON'T we identify ourselves.
Brown:	Uh, Lieutenant David Brown, B-R-O-W-N, uh, assigned to the Criminal Investigation Section.
Anderson:	Uh, Attorney Kenneth Anderson for Officer Brian Pugliares.
Pugliares:	Uh, Officer Brian Pugliares, Cambridge Police.
Donoghue:	Could you spell your last name, OFFICER?
Pugliares:	It's P-U-G-L-I-A-R-E-S.
Donoghue:	Okay. Thank you. Um, so you've had an opportunity to consult with your attorney?
Pugliares:	Yes, I have.
Donoghue:	And you're here voluntarily today?
Pugliares:	Yes, I am.
Donoghue:	Okay. Attorney Anderson?
Anderson:	Yeah. Just for the record, uh, we've consulted. He's here voluntarily. He has not been com-, compelled. He's not under any duress. And he's freely and willingly cooperating with the INVOS-, with the investigation.

Pugliares:	Um, different varieties from, uh, mental health issues to, uh, de-escalation issues, to updates in criminal law.
Donoghue:	And when you say mental health and de-escalation, can you expand on that?
Pugliares:	Um, to understand, uh, what people would kind of express when they are going through a mental health situation and how to see that and diagnose that on, on scene. And then how to properly handle that and give them the best opportunity to fix themselves as possible.
Donoghue:	And what type of techniques would you EMPLOY for that?
Pugliares:	A lot of, um, verbal talking, you know, uh, talking kindly to the person, offering them help. Letting them know that we're there to help them, um, not hurt them. Um, things like that.
Donoghue:	How often does the Cambridge Police Department, um, do type that type of training?
Pugliares:	Um, it's usually every in-service. We, we get updates on me-, mental health. Um, sometimes uh, a few, a few years back, they, uh, gave us a CIT training, which was, like, an elevated level of de-escalation.
Donoghue:	What is do you know what CIT stands for?
Anderson:	I think NOT
Pugliares:	NOT CIT. ICAT. I'm sorry.
Donoghue:	ICAT? Okay.
Pugliares:	Yes. I'm not quite sure what it stands for.
Donoghue:	Yeah, sure.
Pugliares:	But I
Donoghue:	What is, what is it in, in substance? What's the training about?
Pugliares:	So if you're dealing with someone that has mental illness where, um, they want to hurt themselves and they have some sort of instrument, knife or whatever it is, all it is is calming

	down the situation, uh, understanding that you're gonna be there for a long period of time and just try to work this person through that situation. 'Cause they will be armed more than likely and it's just one of those sit back, wait and, and try to help that person as, as much as possible.
Donoghue:	And, um, do you have any other positions within the, the Cambridge Police Department?
Pugliares:	Um, I'm a me-, member of the SWAT team here in for Cambridge. I'm also a, uh, firearms instructor and a less-lethal instructor.
Donoghue:	And in that capacity, do you, um, do you respond to calls, do you have ALL the training? What is what does that specifically entail?
Pugliares:	So, um, that is when I, when I am in those capacities as far as a, um, SWAT team/SRT is for trainings. And then, if there's any type of, um, CRIMINALIST AND that happens out on the street, um, they'll call us in and then we'll handle that as far as, you know, searching buildings, barricade a suspect, things like that.
Donoghue:	And, um, in your in that capacity, um, you're familiar with force continuum
Pugliares:	Yes.
Donoghue:	USING force.
Pugliares:	Mm hmm.
Donoghue:	As well as
Pugliares:	Yes.
Donoghue:	and then the combination of de-escalation techniques with that
Pugliares:	Yes.
Donoghue:	in those incidents?
Pugliares:	Yes.

Donoghue:	Um, so you um, did you I'll ask you that, uh, in a little bit. So, uh, as a THE OTHER SIDE OF YOUR specialities, what are your rules and responsibilities, uh, within the Cambridge Police right now?
Anderson:	IT'S the microphone UNDER THERE.
Donoghue:	Oh, sorry. Thank you.
Pugliares:	Um, right now, I work day patrol so, um, four, four days of patrol on working, two days off. And all four days, currently, I work, uh, a two-man car, which is Car 1 in East Cambridge.
Donoghue:	And, um, what is your PRA-, patrol duties specifically?
Pugliares:	Uh, just answer any calls that are in my area of, of responsibility. Anything ranging from 9-1-1 hang ups to B&E's, larcenies, things like that
Donoghue:	Okay.
Pugliares:	INAUDIBLE INTERACTIONS.
Donoghue:	And directing your attention to this past Wednesday, January 4 <sup>th</sup> of 2023, were you working?
Pugliares:	Yes, I was.
Donoghue:	And what was your assignment that day?
Pugliares:	I was out working in Car 1 in East Cambridge.
Donoghue:	Car 1. Um, were you, uh, single-man car, two-man car?
Pugliares:	A two-man car.

Donoghue:	And on this day, um, on Wednesday, did you, um do you recall receiving a call? Did you respond to, uh, an incident?
Pugliares:	Yes. Um, a, a call came over the radio, um, for, um, another sector car, Car 3 and I think in OUR CAR A SERGEANT to respond to Sidney Street for, uh, an individual with a knife.
Donoghue:	And, um, where were you, uh, in Car 1, and Officer Colbert at that time, do you recall?
Pugliares:	Um, we were somewhere around Galileo Way OR, OR that area I believe.
Donoghue:	How far would that be from the scene?
Pugliares:	Um
Donoghue:	Or the call I should say.
Pugliares:	Yeah. Um, I, I a few, a few blocks. So I can't really say. So, like, where Broadway so it's, like, it'd be Broadway, then it would be Harvard Street, then Mass Ave. and then Sidney's Sidney Street's off Mass Ave. but it was at the farther end of Sidney Street.
Donoghue:	Okay. How, how long do you think it took you guys, uh, to respond?
Pugliares:	Uh, five minutes.
Donoghue:	Okay. And in the time that you were responding, do you recall any radio transmissions? Did you learn anything more about the nature of the call while in route?
Pugliares:	Um, just that the individual supposedly jumped out of window and was out in front of the building, um, had a THEY state

Donoghue:	Okay. Um, you were able to make it to the area?
Pugliares:	Yes.
Donoghue:	What happened next?
Pugliares:	Um, so when we I, I was driving so when, when we get to the area, um, at first, we didn't really see anybody so we drove by the place. We didn't see anybody. We asked control I believe we asked control if there was an RP on scene and they said they'll get back to us.
Donoghue:	What's RP?
Pugliares:	Uh, reporting person.
Donoghue:	Okay.
Pugliares:	So then, I backed up and then when I backed up, I think it was Colbert noticed the individual in question sitting in, like, an alleyway on the side, like, of the building.
Donoghue:	Were you when he noticed it, were you, were you able to see it as well? Did he direct your attention to it?
Pugliares:	Ye-, yes. Yeah. So I, I parked the cruiser right in the middle of the street, um, both of us get out of the cruiser. Um, we saw him sitting on the ground.
Donoghue:	Did you have your lights on at that time?
Pugliares:	Yes.
Donoghue:	Okay. And you said you described him as sitting on the ground. Could you describe what you saw?
Pugliares:	Yeah. It was just a, uh, white male, shirtless, sitting on the ground, had something in his hand. I really couldn't see, but he was sitting there, looking down, doing something with his hands. I, I couldn't really PICK it out.
Donoghue:	Okay. And was his back to you at that time?

Pugliares:	I MEAN, he was it was if you were looking at it from the street, it was his side.
Donoghue:	His side.
Pugliares:	Mm hmm.
Donoghue:	Um, did you recognize him?
Pugliares:	Um, I I've never seen this person before.
Donoghue:	Okay. Um, what do you do with that INFOR-, so you see him sitting. What happens next?
Pugliares:	So once we saw him sitting, once we clo-, closed, YOU KNOW, the cruiser doors, that might have, might have alerted him because he popped right up and just ran to the back of the yard.
Donoghue:	And just to back up a little bit, do you remember what he was wearing when he was seated?
Pugliares:	Uh, no, no shirt, um, and he had some pants on at the time.
Donoghue:	Did you notice any injuries?
Pugliares:	Um, not, not really. I just know that he had things in his hands.
Donoghue:	Okay. And at that time, did you have an opportunity to communicate with him and did he say anything to you?
Pugliares:	No, nothing.
Donoghue:	Okay. So you shut the doors, he starts to move, what do you do next?
Pugliares:	Uh, I end up going to the back of the yard, Colbert leads and I follow him. We go back to the yard 'cause that's where he ran towards.
Donoghue:	Okay. Um, what happens next?

Pugliares:	Um, he ends up fitting through a fence somewhere to, to the left of the yard. Um, Colbert and I followed him. Colbert's in the lead and he goes across, um, Putnam Ave.
Donoghue:	So in the time that you first saw him and then he crossed Putnam Ave
Pugliares:	Mm hmm.
Donoghue:	did you make any, uh, further observations about him?
Pugliares:	Yeah. So at that at, at that time, I saw that he was, you know, had brown hair. He had no shirt. He, he had the weapon, a knife in his hand or something and gray sweatpants so I broadcasted that on the radio.
Donoghue:	Did you notice, um, any injuries to him at that time?
Pugliares:	Um, not, not at the time 'cause he was running.
Donoghue:	Okay. Did he have anything else in his hand?
Pugliares:	I, I didn't notice anything.
Donoghue:	Okay. Any verbal communications either way?
Pugliares:	Not from me. I, I didn't 'cause he was a little bit of a distance so I, I didn't make any communication with him.
Donoghue:	And then you made, um, radio transmissions?
Pugliares:	Yeah, saying white male, no shirt, gray sweatpants, with, with a running across, uh, Putnam Ave.
Donoghue:	And, um, how long would you say that initial interaction was prior to Putnam Ave.?
Pugliares:	Oh, it was with him? It wa-, it was we shut the door, we see him, he runs, we just follow.
Donoghue:	Okay. So, uh, you cross Putnam Ave
Pugliares:	Mm hmm.
Donoghue:	what happens next? Where do you go?

Pugliares:	So I saw him cross Putnam Ave., um, up towards, like, Central Square area, went down a little side street and there's, like, a pharmaceutical at the end of the side street. I'm not sure of the name of the street or the pharmaceutical company, but he went down that side street, towards Central Square and then, he turned right. Um, when he turned right, I stayed on Putnam Ave. and I saw him kind of pop out of that area and head towards the Waverly Street and the Waverly Street parking lot.
Donoghue:	And in that time, just to be clear for me, did, um, did an-, did you or Colbert issue verbal commands for him to stop?
Pugliares:	Um, I, I didn't. I'm not sure if Colbert did or not.
Donoghue:	Okay.
Pugliares:	He was ahead of me.
Donoghue:	And what was your distance going back to the initial call across from Putnam Ave., what was your distance between you and the individual?
Pugliares:	Uh, geez, uh, 'cause I, I was basically cutting through side yards when I saw him go across the street so, uh, a, a couple street widths, I guess. I don't
Donoghue:	Okay.
Pugliares:	know what distance that would be.
Donoghue:	And you didn't essentially, you wouldn't have occasion, you weren't close enough to make a, a, a statement, like, LET YOU give any commands?
Pugliares:	No, no.
Donoghue:	That's what I'm trying
Pugliares:	Yes.
Donoghue:	to get at.
Pugliares:	No.

Donoghue:	Okay. Um, so now you have you continue with this. Um, have you you and Colbert together or have you separated?
Pugliares:	He's, he's ahead of me.
Donoghue:	Okay.
Pugliares:	So what, uh I he's a distance ahead of me, close enough where I can hear him trying to communicate on the radio.
Donoghue:	Okay. Uh, continue, what happened next?
Pugliares:	So, once he came out of that area, he ran across Waverly Street, then, uh, went to Waverly Street parking lot, um, ran towards the fence. Um, I started getting closer to Colbert. I hear Colbert making some sort of demands, you know, like, stop, whatever it was. Um, the guy turns right down the parking lot, like, towards the river and there's, like, a construction site there, uh, with white with blue tarps so he runs to where those two fences meet and there was a little space and so he goes in there. So Colbert I kind of catch up to Colbert. I see him kind of fan out, check that area before he goes in. He goes in and, and then I follow. Um, this guy continues on running down the tracks, um, towards the river, just slows down and starts walking. Me and Colbert follow behind him and at this time, that's when the other sector car and the um, I think it was the other OUR car kind of show up on the tracks and so we kind of have him in the middle of us.
Donoghue:	And with this vantage point, um, do you make any other observations, you know, are you, are you has the distance closed for yourself?
Pugliares:	Yeah. So the distance closed. It was, you know, it, it a few yards away.
Donoghue:	Okay.
Pugliares:	But he stopped running at this point and I could see that there was blood on his hands, on his chest.
Donoghue:	And now that you're closer, could you more, in greater detail, describe the knife? What did you see?
Pugliares:	It wa-, it was just a big knife, silver.

Donoghue:	And, um, I think the call came in as a machete?
Pugliares:	Right.
Donoghue:	Is it fair to say it's a machete?
Pugliares:	IT yes. Mm hmm.
Donoghue:	Um, and was there blood on the knife, do you recall?
Pugliares:	I, I don't remember seeing the blood on the knife at this point.
Donoghue:	And, um, any conversation from the individual? Did he do you recall him making any statements?
Pugliares:	No.
Donoghue:	And any, um, any observations about his demeanor or his condition?
Pugliares:	Um, smiling and then straight face and then smiling.
Donoghue:	And based upon your training experience and given the setting of

Donoghue:	what's going on with the machete and the blood and the smiling, what is what did, what did you what was going through your mind at that point? What kind of a call did you have?
Pugliares:	I, I knew that this guy had some serious mental issues.
Donoghue:	Did that concern you?

Donoghue:	Um, do you remember who else was in that the other officers that arrived by any chance?
Pugliares:	Um, Officer McMahon was there and Ayoub.

Pugliares:	Yes. So he stopped in the middle of the tracks and he saw that me and Colbert were coming from behind him and the two officers kind of had in on the other side and that's when he decides to run across the tracks, back towards Waverly Street.
Donoghue:	Okay. And do you guys follow?
Pugliares:	Yes.

Donoghue:	Gonna ask you a quick question regarding the neighborhood. What's the setting? Can you describe Chestnut Street? You talked about train tracks
Pugliares:	Mm hmm.
Donoghue:	now you're on Ches-, what how would you describe that neighborhood?
Pugliares:	Right. So where the train tracks are is wide open. Um, Waverly Street's, um, YOU KNOW, PARTS a neighborhood and right next IN THE right next to Waverly Street, from there is Chestnut Street and Sidney and whatnot, but once you get onto Waverly Street, um, it gets, like, thickly set up neighborhood.

Pugliares:	I saw some peop-, in that CARP-, apartment complex to the left. I saw some people on, like, the walkway. There was, like, two, two or three guys. I'm not sure what they were doing but as we're, as we're I was walking up, I was looking around everywhere and that that's where I noticed people, in that ACOMP-, apartment complex.
Donoghue:	And when you got onto Chestnut Street, um, what would be the positioning at to the best of your memory, of, uh, the individual with the knife and then the order of officers behind?
Pugliares:	So he was in the middle of the street, um, I remember seeing Of-, 'cause I, I my whole purpose of trying to get past him on the left side of the street I wanted to get past him so we can kind of corral him, you know, and that's to prevent him from going deeper into the neighborhood.
Donoghue:	Well, what's the as a police officer, with your training, what's the what is the what's the benefit of getting ahead, in further detail?
Pugliares:	So you can stop him pursuing forward or getting into the neighborhood and getting innocent people going into a house, things like that. You want to try to prevent him you want to contain the contain him as much as possible so he doesn't cause injury to other people.
Donoghue:	Okay. Was that a concern for you at the time?
Pugliares:	Mm hmm. Yes, it was.

Pugliares:	A lot. I can't say how many times, but it was repetitive. Ma-, many times.
Donoghue:	And, um, when, um you've talked to a lot of people, what type of when you're trying to en-, when you're trying to engage somebody like that, what understanding it's an intense situation, what type of um, how do you balance the delivery of that? How would how did you deliver that message?
Pugliares:	Um, I was, I was loud when I said it.
Donoghue:	Yup.
Pugliares:	Um, I was hoping for some sort of reaction 'cause in calls before where you talk to people, they would at least acknowledge you and say swear at you or I'm not doing some sort of communication back.

Pugliares:	No, just a smile and a run.

Pugliares:	Um, that just means that you're looking for some sort of device to stop this individual from harming himself or others but the device is meant to, uh, temporarily stun or knock that person down temporarily SO
Donoghue:	And, uh, what do, what do the Cambridge Police have for less-lethal options?
Pugliares:	Um, so on, on a duty belt, we have OC, which is, like, pepper spray. We have our PR-24 baton. Um, the baton's up close, you're not gonna use that for someone with a knife.

Pugliares:	Uh, because if they have a knife and you have your baton, they can easily slash at you or cut you.
Donoghue:	So if you used the baton in this instance with someone that has a machete
