**NARRATIVE**

On January 4, 2023, I, Detective Sergeant Ashley Kmiec, assigned to the DV/SA Unit of the Cambridge Police, responded to the area of 59 Chestnut Street for a report of shots fired and a man down, Officer involved shooting.

On scene I assisted with taping off the area believed to be part of the crime scene on Sidney Street and Chestnut Street, I asked Detective Lieutenant D. Brown if he knew the route the police and subject took to properly mark the scene and he was unsure. I obtained approval from Det. Lt. Brown and Super. Cabral to call an officer from the incident to learn the route they took.

I called Officer Brian Pugliares and asked if he could recount the path they took during the encounter with the subject. Off Pugliares described the route starting with his initial encounter at the left of 259 Green Street and ending behind 59 Chestnut Street. I walked this route multiple times and later was directed to do so with the Massachusetts State Police (MSP), Special Emergency Response Team (SERT) while they mapped the route with GPS. Please refer to MSP report and map.
