Brown:	All right. We are now recording.
Donoghue:	Okay. Just let me get the right time here. It's 3:32. The, uh, date is January 5 th , 2023. The time is approximately 3:32 p.m. in the afternoon. My name is Detective Lieutenant William Donoghue, D-O-N-O-G-H-U-E, um, a Massachusetts State Police officer assigned to the Middlesex district attorney's office. We are currently conducting an interview of Cambridge Police Sergeant STEVE Sennott relative to the facts and circumstances surrounding a fatal officer-involved shooting which occurred yesterday, January 4 th , 2023, in the city of Cambridge. Uh, for the benefit of the record and the tape, if we could go around the room and identify ourselves.
Brown:	Lieutenant David Brown, B-R-O-W-N, um, in, uh, with the criminal investigation section here at the Cambridge PD.
Anderson:	Uh, Attorney Kenneth Anderson, uh, for Sergeant Sennott.
Sennott:	Sergeant Stephen Sennott, S-E-N-N-O-T-T.
Donoghue:	Thank you. Um, Sergeant Sennott, you, um, you're here voluntarily?
Sennott:	Yes.
Donoghue:	Yeah. And you've had an opportunity to consult with your attorney?
Sennott:	Yes.
Anderson:	INAUDIBLE and I just
Donoghue:	INAUDIBLE.
Anderson:	put on the record that I've discussed his rights, and we're here voluntarily, willing to give, uh, a statement. There's no coercion. He's here not under any duress.
Donoghue:	Okay. Thank you. I appreciate that. Um, just by way of background, um, what's your current occupation?
Sennott:	Patrol sergeant
Donoghue:	And

Sennott:	day shift.
Donoghue:	day shift? How long have you been a police officer?
Sennott:	Twenty-five years.
Donoghue:	And, uh, what year did you start?
Sennott:	1998.
Donoghue:	And did you go through a training process for that?
Sennott:	Yes.
Donoghue:	And could you describe that?
Sennott:	Uh, I think it was about 12 weeks of a training process, and it went from anything from defensive tactics to criminal law to providing, uh, medical, medical care.
Donoghue:	Have you always been a Cambridge police officer?
Sennott:	Um, i-, i-, i-, yes. I started a bit later in life, but yes.
Donoghue:	And, um, throughout that, you're you were promoted to a sergeant. When did you become a sergeant?
Sennott:	I think it was 2009.
Donoghue:	So, um, over 10 years as a sergeant?
Sennott:	Yes.
Donoghue:	And what have your duties been throughout your career as a Cambridge police officer and a Cambridge police sergeant?
Sennott:	Okay. Um, in patrol, just patrolling the area. Um, res-, responding to calls, pulling cars over for traffic stops. As a sergeant, supervising personnel doing those functions.
Donoghue:	And as a sergeant, does that involve any increased training?
Sennott:	They did send us away to training, yes, in Rhode Island.

Donoghue:	Okay. And throughout your normal course of, of training within the Cambridge Police Department, do you have inservice training?
Sennott:	Yes.
Donoghue:	Um, firearms training?
Sennott:	Yes.
Donoghue:	When's the last time you had firearms training?
Sennott:	Uh, I think it was
Donoghue:	INAUDIBLE.
Sennott:	September.
Donoghue:	Okay. And with tho-, that training, have you had, uh, the opportunity to have any training in, um, mental health issues with the citizens of, uh, of Cambridge
Sennott:	INAUDIBLE.
Donoghue:	and any de-escalation tactics? Have you had
Sennott:	We had
Donoghue:	that training?
Sennott:	Yes, I have had that training.
Donoghue:	Would you describe that training for us?
Sennott:	I've had training in, um, de-escalation, um, in the department, and they also brought us over to Harvard University and we had de-escalation training over there as well for a couple of days.

Sennott:	It was both classroom and practical. And then they critiqued us.

Sennott:	Yes.

Sennott:	I was car 17, which handles the lower end of the city. There were only two sergeants, so I actually had that half-end of the city.

Sennott:	Um, from, from Central Square to East Cambridge.
Donoghue:	Are you, uh, a one-person car, two-person car?
Sennott:	One-person.
Donoghue:	And do you recall who else was, uh, in your so you had the lower end is that, is that a sector, multiple sectors?
Sennott:	Um, it depends how many supervisors they have, but, um, it's usually based on a car number, 17, 18, 19

Sennott:	Y-, yeah, it's about, it's about 20 people.
Donoghue:	Okay. And at some point in time, did you, uh, were you called or did you respond to, um, a disturbance?
Sennott:	Yes, at about 1:15, there was a call.
Donoghue:	Okay. Could you describe that?
Sennott:	Okay. The call come in. There was a man with a machete, uh, threatening to kill himself, and, uh, they dispatched some units, including myself, and then a couple of more calls come in that he had jumped out of the window, and I believe that he was cutting himself with glass.
Donoghue:	And how did you learn that?
Sennott:	On the radio through dispatch.
Donoghue:	And when you were dispatched, was this call, do you recall the address?
Sennott:	Um, the I believe it was down by Waverly Street. I don't believe it was a s-, specific address.
Donoghue:	Okay. Um, do you remember who responded?
Sennott:	Uh, yes. I res-, ra-, I responded, car 1, car 2, car I mean, car 3. Uh, Officer ILIENSKI was 5. Uh, he responded.
Donoghue:	And when you were on scene as a patrol sergeant or a supervisor, did you assume command of that scene, or were you w-, was that duty and responsibility for somebody else when you arrived INAUDIBLE?
Sennott:	That was your role that would've been my responsibility. When I arrived after the officers, they were already in their driveway, and I was probably only there seconds, and then, um, Officer COLBERT shot the less-than-lethal.
Donoghue:	Okay. So let's back up a little bit. So when you got that call, where were you?

Sennott:	I was at the s-, I was b-, at the station
Donoghue:	At the station?
Sennott:	which is in which is in my area.
Donoghue:	Okay.
Sennott:	So I was getting ready to be relieved. I get relieved around that time between that time and 1:30.
Donoghue:	Okay. So you heard the call. What was your response time from the station to the scene?
Sennott:	Um, I'd say, you know, three to four minutes.
Donoghue:	In the scene, um, if you as you're we now know through radio transmissions, there was a foot chase?
Sennott:	Yes.
Donoghue:	And as you're approaching, do you recall any of the radio transmissions or updates that were going on when you were on your way to that scene?
Sennott:	Yeah. They just kept saying that he was on Waverly Street, he's on Sydney Street, he's on Putnam Avenue. He was, he was clearly on the move.
Donoghue:	And did they descr-, further describe his, uh, any other observations, demeanor, um, weapons, injuries?
Sennott:	Uh
Donoghue:	Any, any
Sennott:	I do recall, you know, that he had, he had a machete, and I that i-, that's about all I recall.
Donoghue:	Okay. And when you first got to the
Sennott:	And he didn't have a shirt on.
Donoghue:	Okay. Anything else? Any statements?

Sennott:	No.
Donoghue:	Okay. And when you first got to the area, specifically, what do you recall where you
Sennott:	Sure.
Donoghue:	what road you came in on?
Sennott:	Sure. I come d-, I come up Waverly Street up the wrong, the wrong way up Waverly because I had to, because I couldn't get around. Some of the cruisers were, were parked a couple streets over, blocking my access, and I stopped the cruiser approximately in betw-, Waverly and Chestnut Street.

Sennott:	And when I stopped the car there, he was there. That's where the last transmission came in, that he was right there in that area. I swung over there, stopped the car. I get out of the car, saw him, and then he started to move away from us and run away.
Donoghue:	Okay. So when you w-, when you s-, stopped the car, what was he where were you specifically, do you recall?
Sennott:	On Waverly Street, just before Chestnut.
Donoghue:	Okay. And when you got out of the car or you first saw the car, do you recall any of the officers that were present right there?
Sennott:	Yeah, I believe, uh, Officer Colbert was there. I believe Officer Pugliares was there.
Donoghue:	Um, did you see the decedent?
Sennott:	I did.
Donoghue:	And what were the observations that you made then?
Sennott:	I just I the only thing I could say is I what I saw was I saw him. I didn't s-, recall his clothing or a weapon or anything. I just saw him. It was very brief, and then he ran away.

Donoghue:	Did you recognize him?
Sennott:	No.
Donoghue:	Um, he's subsequently been identified as Sayed Faisal. Do you, do you recognize that name? Are you
Sennott:	No.
Donoghue:	do you now know any other any contact you can remember?
Sennott:	Never.
Donoghue:	Okay. So you saw him in that brief time, and we may have said do you remember the officers that were in the area at that moment? Was he on th-, I should say this. Was he on the move or was he stationary the decedent?
Sennott:	He c-, at, at, at that time, he was at the corner of Waverly and Chestnut, and the officers were in dialog with him, telling him to drop the weapon and stop. And he looked at them, and then he turned and he ran away.

Sennott:	He ran up Chestnut Street.
Donoghue:	Okay. And do you remember the officers that were having that dialog?
Sennott:	I believe it was Pugliares.
Donoghue:	Okay. And do you remember m-, the language that they were using?
Sennott:	I don't. I don't remember the language.
Donoghue:	Okay. And how far were you from those guys?
Sennott:	I was probably 50 to 60 feet.
Donoghue:	Okay. And the decedent ran. In what direction did he run?

Sennott:	Uh, patrol supervisors have that.

Sennott:	Yes.
Donoghue:	Okay. Um, is Officer Colbert trained in that?
Sennott:	I believe so, yes.
Donoghue:	Okay. So at some point, you handed him the less-lethal?
Sennott:	Yes. Anyone should be trained in it, so he was trained in it, yeah.

Sennott:	After that, um, because the individual ran from us up Chestnut Street, all the officers INAUDIBLE continued to pursue him, chasing after him, and I could hear officers yelling out to stop, to drop the machete and to stop

Sennott:	Uh, they, they s-, s-, s-, they were fairly calm, but they were, they were high-pitched so they could he could hear tell him to stop.
Donoghue:	Okay.
Sennott:	Commands so giving commands.
Donoghue:	So at some point, you were on Chestnut Street. Did you drive or walk there?
Sennott:	I walked and half ra-, half ran and half walked, yeah.
Donoghue:	Okay. AND
Sennott:	Kind of ran.
Donoghue:	and at some point, when you first go down to Chestnut Street, you're looking down, um, the street. Did you were you able to see, um, the decedent at all?
Sennott:	I was.
Donoghue:	And where did you see him travel or run or walk or what did
Sennott:	I saw
Donoghue:	what did you observe?
Sennott:	I saw him, um, running down Chestnut Street, and then I heard that he ducked into a yard, and right when I heard that, I saw him, and I saw him go into the driveway.

Donoghue:	So when you saw so to be clear, you saw m-, who we now know is the decedent when he when you say "ducked into

	a dr-, the driveway," or the do you which address would that be?
Sennott:	Um, I believe that was 59 Chestnut Street.
Donoghue:	59 Chestnut Street. And, um, do you recall who was pursuing him at that time?
Sennott:	Um, Officer Pugliares was pursuing him. Officer Colbert was pursuing him.
Donoghue:	Okay. And then what happened?
Sennott:	Okay. Then I showed up to that address, and at the driveway and i-, i-, the entrance of the driveway, um, we had, um, there was a car obstructing in the driveway, and the individual was, uh, on the left side of the car towards the front of the car, and I had Officer Colbert right next to me with the less-than-lethal. Officer Pugliares was there, I recall. Um, Deputy Boyle was next to me. And, um, it all happened within a couple of seconds. He, um, they were giving him commands to drop, drop the machete, to drop the machete, to just, just to cease and desist. And he turned his body as if to get away, and, um, he let the, uh, less-than-lethal round go at that point.

Sennott:	And it looked like it hit his I, I thought it hit maybe his upper body in the torso. I think it hit him. It bounced off of him. Didn't faze him one bit. He kinda moved to the front of the car at that point. Then I saw him put the machete to his throat. And after that not shortly after that, he started to make his way into the backyard, which was, which was literally only 5 feet away the grass

Donoghue:	Okay. And were you at to the right side at the back of the car or actually moving up along the INAUDIBLE?
Sennott:	Right side to the back of the car.

Sennott:	He was going directly at Officer McMahon, and he was c-, walking, walking.

Donoghue:	So he's walking, and while he was walking, um, what was the initial distance that when he had that m-, the knife or the machete, we should say the knife up he has his, essentially, his back to you. He's walking towards Officer McMahon. What's that initial distance, if you rec-, could estimate?
Sennott:	Maybe 20 feet.
Donoghue:	Okay. And McMahon's issuing commands. Is anyone else issuing commands, that you recall?
Sennott:	Not that I recall at that point.
Donoghue:	It do you observe anyone else in the backyard beyond Officer McMahon?
Sennott:	Uh, Officer Ayoub, Ayoub was in the backyard.
Donoghue:	And what was his positioning?
Sennott:	I believe he was on the right side, in front of me.
Donoghue:	So was O-, was Officer Ayoub do you if you know, did he come through the driveway as well?
Sennott:	I don't know, because when I showed up, they were all in place.

Sennott:	From my vantage point, it looked like it was about 4, f-, 4 feet, maybe 5 feet away.
Donoghue:	And was he walking, I guess, um, directly at him?
Sennott:	Yes.
Donoghue:	Um, do you know how many rounds were fired? Do you recall?
Sennott:	I thought it was three rounds.
Donoghue:	And
Sennott:	But they were very fast.
Donoghue:	Okay. And those rounds were fired. What did you observe next?
Sennott:	I observed the individual go down on the ground at that point.
Donoghue:	And what happens next?
Sennott:	Then we all rush towards him, and he was on the ground, and he, um, had the machete in his hands still, and he was still moving it with his hand, and we were able to the officers were able to get the machete away from him. And we assessed him, and then we provided medical care and ran out to the front to get a medical bag. I called for the ambulance. Soon as he got shot, I called for the ambulance.

Sennott:	No.
Donoghue:	Do you recall him holding anything else in his hands when he was, um, at any point when he was in the driveway or ?
Sennott:	No.

Donoghue:	Okay. Um, when you you've had training in mental health issues and de-escalation, whatnot. Are there any observations that you made when you first were, you know, you were out front with Officer Colbert and making and
Sennott:	Yeah.
Donoghue:	when he deployed the less-lethal?
Sennott:	Yeah.
Donoghue:	Is there anything you can add or anything that you observed regarding his demeanor? Was he responsive, not responsive?
Sennott:	No, he looked like he was literally out of his mind, on drugs or something wasn't responding.
Donoghue:	And how
Sennott:	He looked very he looked erratic-looking, just moving shaking his body back. It looked erratic. His I can't give you the exact explanation, but his face looked didn't look normal.
Donoghue:	And getting back to at that point, and that's really when you f-, first were able to see him, do you recall, um, what his condition was? When prior to the less-lethal round being fired, when you first observed him with Officer Colbert, what, what else did you observe about his body?
Sennott:	I believe he had INAUDIBLE he had a machete in his hand, and, um, I he just looked erratic-looking. He didn't have a shirt on. I also observed that he had blood all over him at that point. He had blood on him.
Donoghue:	Okay. And then with that, with that being close with Officer Colbert and he's m-, let that round go, did you have any concerns when he that round didn't was not effective

Donoghue:	and then he was in the back? What were your concerns at that point?

Donoghue:	And then when he moved to the backyard and you were in a position to observe Of-, Officer McMahon give verbal commands, and then let me back up one second. D-, could you describe the backyard? Do you recall?
Sennott:	Yeah. It was, it was grass. There was a f-, I believe there was a it was a chain-link fence, at least in the back, if not all around. It was a relatively small yard.
Donoghue:	Okay. And then if you had very specifically, you had a line of sight for Officer McMahon, could you do you recall, what was behind him?
Sennott:	Chain-link fence.
Donoghue:	How close was the chain-link fence?
Sennott:	It might have been 5 to 7 feet from behind him at that point, after he backed up.
Donoghue:	So for a route of escape for him, what was
Sennott:	Not, not much. Not no route of escape.
Donoghue:	And then did you have
Sennott:	No, no, no room to maneuver.
Donoghue:	Okay. And that was because of
Sennott:	The size of the yard. It was very small.
Donoghue:	Okay. And then any did you have concerns or what was going through your mind when the decedent had the machete and was approaching Officer McMahon?
