Dad left for work @ Noon, breakfast together

call for psych w/ weapon, don't know what kind, put man  
and <sup>Sidney</sup> ~~press~~ standing by, behind PD blocking the  
block, told stand by police in foot chase, update to  
relocate and some notification of shots fire, patient  
officer?, Hick/Kevlar, cruiser in front moves  
<sup>Sidney</sup> ~~press~~ → chestnut, arrive @ scene, get gear, high  
stress, assume patient shot but unknown, PD starts  
taking stuff, get to backyard, in confusion of PD  
gripping stuff, have to look for gear, put on T.O. on  
both arms (shoulders), right leg, 9mm, ask who shot  
right thigh GSW, looked like broken, someone mentioned  
jumping out window but don't know, GSW to right chest  
cops asking for chest seal, but gear still unknown, seal  
was already on lower left flank GSW? exit wound,  
covered in blood difficult to see completely  
smiled at her, can breathe - when tried to move or talk  
he would smile and flail what he could, left leg  
could move out arms, wouldn't call extreme low held  
down

cop holding pressure on right chest, stroke her on Amb.  
Param. Meghan May gets in, <sup>long fellow</sup>  
transport... going over SNP Bridge when stopped moving  
TA so no BP, IO in left leg, fluids + oxygen,  
decline in, get to MGH, Acute Rm 7 move to  
needle decompress on left side before stretchy  
Squad 2 followed, Squad 2, took patient through ER  
her, Meghan  
intubate w/ no meds because declined so much, no IO  
on him, gave report to Hospital, didn't know about  
self harm til told in Amb. by cop, ~~right wrist~~ cuts  
across, deep enough to see tissue but no bleed due to TA  
also told superficial across neck, cleared

PD screaming when arrive, cop was given blankets  
breathing moving smiling, looking for trauma kit in backyard  
pull in front of blue house,  
handcuffed laying down in underwear, others  
keeping down on back, moving head facing right corner  
legs to house, left leg + arms moving, see how cop sons  
from her experience... come look, taking meds or not taking  
enough  
heard, <sup>clearly</sup> screaming, intuitively fight off when transport  
pull off restraints w/ bag until decompressed  
initially told ~~her~~ shot 3... MGH was 5 times  
back, Meghan, her, Darren. Drive: Gianni

Meghan May leaves w/ chest seeds, supervisor  
explains McMahon needs transport, clear he is upset  
transport to Mr Auburn, he was dehydrated, physical inj.  
took vitals, appeared stressed.

hospital... McMahon, him, sup. go in, seated on bed  
in hallway, registered

back: him, McMahon, McMahon supervisor

no real conversation, asking what's going on not knowing  
what happened, "I just shot someone."  
super. telling him what's going on

TAs, off sitting on bench holding pressure, Fire guy  
Darren, wounds sealed up

maintained pulse as drove, decompress chest, got to MCH,  
pulse + respiratory when brought there  
go from truck to truck

<sup>Deventham</sup>  
that truck: gianna driver, Elise, Megan, officer back there

2-3 inch cuts to neck, bilateral cuts to wrists

<sup>when already in back of truck</sup>  
patient behavior... Elise secured pretty out of it until  
IO, "Omg my leg" screamed, lidocaine, screamed  
a few more times, moving arms trying to fight

IO on left, right arm upper, and upper right leg

No shirt no shoes, maybe underwear, legs exposed
